Renewal of Type Approval Certificate for Ionising Radiation Gauging Device (IRGD) Model QG-2000 manufactured by M/s Endress + Hauser GmbH+Co. KG, Germany.

- M/s Endress + Hauser (India) Pvt. Ltd., Mumbai is hereby informed that the Atomic Energy Regulatory Board (AERB) renews the Type Approval of the Ionizing Radiation Gauging Device (IRGD) model QG-2000 for Level/Density measurement, manufactured by M/s Endress + Hauser GmbH+Co. KG, Germany for import, sale, installation and use in India.
- 2. The strength of the Co-60 radioactive source in the above IRGD model shall not exceed 37GBq (1Ci).
- 3. This type approval becomes invalid if any change is made in the above approved model of IRGD.
- 4. This device shall be supplied only to persons authorized by Radiological Safety Division, AERB, Mumbai and installed only at authorized premises.
- 5. M/s Endress + Hauser (India) Pvt. Ltd., Mumbai shall be responsible for import, supply, installation, commissioning, servicing, maintenance and decommissioning/dismantling of IRGD. M/s Endress + Hauser (India) Pvt. Ltd., Mumbai shall assist the authorized user for safe disposal of disused radioactive source in the above IRGD model by returning such sources to the original supplier or at authorized radioactive waste management facility with prior approval of AERB.
- 6. M/s Endress + Hauser (India) Pvt. Ltd., Mumbai shall keep AERB informed about the import, supply, servicing, maintenance and performance status of the above IRGD model. Such information shall be in the form of reports to AERB in the months of January and July every year.
- 7. The import and marketing of the above IRGD model after the expiry of the type approval is conditional upon the re-validation of this approval. A copy of this certificate shall be provided to the user when supplying the device.
