(15) Description of equipment:

The Solitrend sensor series is designed for humidity measurements in dust hazardous areas. They each consist of an enclosure housing the evaluation unit and the actual sensor body. Evaluation unit and sensor body are connected via a coax cable and are both suitable for zone 21 dust atmospheres.

Electrical data:

12 V - 24 V dc, max. 250 mA @ 12 V, max. 125 mA @ 24 V, max. 3 W
