The DUSTHUNTER SB30 measuring system only serves continuous measurement of dust concentrations in exhaust gas and exhaust air plants.

Measuring system DUSTHUNTER SB comprises the components:

- Sender/receiver unit DHSB30 consisting of:
 - Enclosure with electronics
 - Plug connector for connection of analog output and status signal
 - Plug connector for connection of service adapter or digital inputs
 - Plug connector for connection of external voltage supply 24V DC
 - Signalling of device state
- Purge air connection
- Flange with tube

Periodical assessment is to be performed after 2 years and after 3.5 years. A renewal assessment will be performed at renewal of the certificate.
