
#### Safety instructions: General

- Comply with the installation and safety instructions in the Operating Instructions.
- Staff must meet the following conditions for mounting, electrical installation, commissioning and maintenance of the device:
  - Be suitably qualified for their role and the tasks they perform
  - Be trained in explosion protection
  - Be familiar with national regulations
- For installation, use and maintenance of the device, users must also observe the requirements stated in the Operating Instructions and the standards:
  - GB 50257-2014: "Code for construction and acceptance of electric device for explosion atmospheres and fire hazard electrical equipment installation engineering".
  - GB/T 3836.13-2021: "Explosive atmospheres, Part 13: Equipment repair, overhaul, reclamation and modification".
  - GB/T 3836.15-2017: "Explosive atmospheres, Part 15: Electrical installations design, selection and erection".
  - GB/T 3836.16-2022: "Explosive atmospheres, Part 16: Electrical installations inspection and maintenance".
  - GB/T 3836.18-2017: "Explosive atmospheres, Part 18: Intrinsically safe electrical systems".
- Install the device according to the manufacturer's instructions and national regulations.
- Only use the device in media to which the wetted materials have sufficient durability.
- Avoid electrostatic charging:
  - Of plastic surfaces (e.g. enclosure, sensor element, special varnishing, attached additional plates, ...)
  - Of isolated capacities (e.g. isolated metallic plates)

## Safety instructions: Specific conditions of use

- In the case of process connections made of polymeric material or with polymeric coatings, avoid electrostatic charging of the plastic surfaces.
- For light metal flanges or flange faces (e.g. titanium, zirconium), avoid sparks caused by impact and friction.
- To avoid electrostatic charging: Do not rub surfaces with a dry cloth.
- In the event of additional or alternative special varnishing on the enclosure or other metal parts or for adhesive plates:
  - Observe the danger of electrostatic charging and discharge.
  - Do not install in the vicinity of processes (≤ 0.5 m) generating strong electrostatic charges.

After aligning (rotating) the enclosure, retighten the fixing screw.

#### Intrinsic safety

- $\bullet$  The intrinsically safe input power circuit of the device is isolated from ground. The dielectric strength is at least 500  $V_{\rm rms}.$
- When the device is connected to certified intrinsically safe circuits of Category Ex ib for Equipment Groups IIC and IIB, the type of protection changes to Ex ib IIC and Ex ib IIB. Do not operate the sensor in Zone 0 if connecting to an intrinsically safe circuit of Category Ex ib.

#### Overvoltage protection

Device type PMC71, Basic specification, Position 10 + 11 and Device type PMP71, PMP75, Basic specification, Position 11 + 12 = M The intrinsically safe input power circuit of the device is isolated from ground. The dielectric strength is at least 290  $V_{rms}$ .

### Safety instructions: Zone 0

- In the event of potentially explosive vapor/air mixtures, only operate the device under atmospheric conditions.
  - Temperature: -20 to +60 °C
  - Pressure: 80 to 110 kPa (0.8 to 1.1 bar)
  - Air with normal oxygen content, usually 21 % (V/V)
- If no potentially explosive mixtures are present, or if additional protective measures have been taken, the device may also be operated under non-atmospheric conditions in accordance with the manufacturer's specifications.
- Associated devices with galvanic isolation between the intrinsically safe and non-intrinsically safe circuits are preferred.

For Device type PMC71, the following also applies:

For installations which require overvoltage protection to comply with national regulations or standards, install the device using overvoltage protection (e.q. HAW56x from Endress+Hauser).
