Basic specifications

The features that are absolutely essential for the device (mandatory features) are specified in the basic specifications. The number of positions depends on the number of features available.

The selected option of a feature can consist of several positions.

Optional specifications

The optional specifications describe additional features for the device (optional features). The number of positions depends on the number of features available. The features have a 2-digit structure to aid identification (e.g. JA). The first digit (ID) stands for the feature group and consists of a number or a letter (e.g. J = Test, Certificate). The second digit constitutes the value that stands for the feature within the group (e.g. A = 3.1 material (wetted parts), inspection certificate).

More detailed information about the device is provided in the following tables. These tables describe the individual positions and IDs in the extended order code which are relevant to hazardous locations.



Safety instructions: General

 Devices suitable for zone separation (marked Ga/Gb or Da/Db) are always suitable for installation in the less critical zone (Gb or Db).
 Due to space limitations the corresponding marking maybe not indicated on the nameplate.

- Staff must meet the following conditions for mounting, electrical installation, commissioning and maintenance of the device:
 - Be suitably qualified for their role and the tasks they perform
 - Be trained in explosion protection
 - Be familiar with national regulations
- Install the device according to the manufacturer's instructions and national regulations.
- Do not operate the device outside the specified electrical, thermal and mechanical parameters.
- Only use the device in media to which the wetted materials have sufficient durability.
- Avoid electrostatic charging:
 - Of plastic surfaces (e.g. enclosure, sensor element, special varnishing, attached additional plates, ..)
 - Of isolated capacities (e.g. isolated metallic plates)
- Refer to the temperature tables for the relationship between the permitted ambient temperature for the sensor and/or transmitter, depending on the range of application and the temperature class.
- Modifications to the device can affect the explosion protection and must be carried out by staff authorized to perform such work by Endress+Hauser.

Safety instructions: Special conditions

Permitted ambient temperature range at the electronics enclosure:

- \rightarrow 10, "Temperature tables".
- To avoid electrostatic charging: Do not rub surfaces with a dry cloth.
- In the event of additional or alternative special varnishing on the enclosure or other metal parts or for adhesive plates:
 - Observe the danger of electrostatic charging and discharge.
 - Do not install in the vicinity of processes (≤ 0.5 m) generating strong electrostatic charges.

Basic specification, Position 6 = A

Avoid electrostatic charging of the enclosure (e.g. friction, cleaning, maintenance, strong medium flow).



Avoid sparks caused by impact and friction.

Avoid electrostatic charging of the weather protection cover (e.g. friction, cleaning, maintenance, strong medium flow).

- When the device is connected to certified intrinsically safe circuits of Category Ex ib for Equipment Groups IIC and IIB, the type of protection changes to Ex ib IIC and Ex ib IIB.
- Continuous service temperature of the connecting cable: $\geq T_a + 20 \text{ K}$.
- Observe the pertinent guidelines when interconnecting intrinsically safe circuits.
- Observe the maximum process conditions according to the manufacturer's Operating Instructions.
- At high medium temperatures, note flange pressure load capacity as a factor of temperature.
- Install the device to exclude any mechanical damage or friction during the application. Pay particular attention to flow conditions and tank fittings.
- Support extension tube of the device if a dynamic load is expected.

Accessory high pressure sliding sleeve

The high pressure sliding sleeve can be used for a continuous setting of the switch point and is suited for zone separation if mounted properly (see Operating Instructions).

Intrinsic safety

- The device is only suitable for connection to certified, intrinsically safe equipment with explosion protection Ex ia / Ex ib.
- \blacksquare The intrinsically safe input power circuit of the device is isolated from ground. The dielectric strength is at least 500 $V_{\rm rms}.$

Potential equalization

Integrate the device into the local potential equalization.

Safety instructions: Zone 0

- In the event of potentially explosive vapor/air mixtures, only operate the device under atmospheric conditions.
 - Temperature: -20 to +60 °C
 - Pressure: 80 to 110 kPa (0.8 to 1.1 bar)
 - Air with normal oxygen content, usually 21 % (V/V)
- If no potentially explosive mixtures are present, or if additional protective measures have been taken, the device may also be operated under non-atmospheric conditions in accordance with the manufacturer's specifications.
- Only use the device in media to which the wetted materials have sufficient durability (e.g. process connection seal).
- When using under non-atmospheric pressures and non-atmospheric temperatures: The sensor part of the device approved for Zone 0 does not cause any ignition hazards.




