Basic specifications

The features that are absolutely essential for the device (mandatory features) are specified in the basic specifications. The number of positions depends on the number of features available. The selected option of a feature can consist of several positions.

Optional specifications

The optional specifications describe additional features for the device (optional features). The number of positions depends on the number of features available. The features have a 2-digit structure to aid identification (e.g. JA). The first digit (ID) stands for the feature group and consists of a number or a letter (e.g. J = Test, Certificate). The second digit constitutes the value that stands for the feature within the group (e.g. A = 3.1 material (wetted parts), inspection certificate).

More detailed information about the device is provided in the following tables. These tables describe the individual positions and IDs in the extended order code which are relevant to hazardous locations.



Staff must meet the following conditions for mounting, electrical installation, commissioning and maintenance of the device: Be suitably qualified for their role and the tasks they perform Be trained in explosion protection Be familiar with national regulations Install the device according to the manufacturer's instructions and national regulations. Only use the device in media to which the wetted materials have sufficient durability. Avoid electrostatic charging: Of plastic surfaces (e.g. enclosure, sensor element, special varnishing, attached additional plates,) Of isolated capacities (e.g. isolated metallic plates)

- After aligning (rotating) the enclosure, retighten the fixing screw.
- In potentially explosive atmospheres: Do not open the connection compartment cover and the electronics compartment cover when energized.
- Before operation:
 - Screw in the cover all the way.
 - Tighten the securing clamp on the cover.
- Connect the device:
 - Using suitable cable and wire entries of protection type "Flameproof Enclosure (Ex db)".
 - Using piping systems of protection type "Flameproof Enclosure (Ex db)".
- When connecting through a conduit entry approved for this purpose, mount the associated sealing unit directly at the enclosure.
- Seal unused entry glands with approved sealing plugs that correspond to the type of protection. The plastic transport sealing plug does not meet this requirement and must therefore be replaced during installation.
- Only use certified cable entries or sealing plugs. The metal sealing plugs supplied meet this requirement.
- Only use genuine spare parts from Endress+Hauser which are specified for the device.

Flameproof equipment with G threaded entry holes is not intended for new installations but only for replacement of equipment in existing

installations. Application of this equipment shall comply with the local installation requirements.
