At this position, an option (number or letter) selected from the specification is displayed instead of the placeholders.

#### Basic specifications

The features that are absolutely essential for the device (mandatory features) are specified in the basic specifications. The number of positions depends on the number of features available. The selected option of a feature can consist of several positions.

#### Optional specifications

The optional specifications describe additional features for the device (optional features). The number of positions depends on the number of features available. The features have a 2-digit structure to aid identification (e.g. JA). The first digit (ID) stands for the feature group and consists of a number or a letter (e.g. J = Test, Certificate). The second digit constitutes the value that stands for the feature within the group (e.g. A = 3.1 material (wetted parts), inspection certificate).

More detailed information about the device is provided in the following tables. These tables describe the individual positions and IDs in the extended order code which are relevant to hazardous locations.

### Safety instructions: General

 Comply with the installation and safety instructions in the Operating Instructions.


- Staff must meet the following conditions for mounting, electrical installation, commissioning and maintenance of the device:
  - Be suitably qualified for their role and the tasks they perform
  - Be trained in explosion protection
  - Be familiar with national regulations
- Install the device according to the manufacturer's instructions and national regulations.
- Avoid electrostatic charging:
  - Of plastic surfaces (e.g. enclosure, sensor element, special varnishing, attached additional plates, ..)
  - Of isolated capacities (e.g. isolated metallic plates)

### Safety instructions: Special conditions

In the event of additional or alternative special varnishing on the enclosure or other metal parts:


- Observe the danger of electrostatic charging and discharge.
- Do not rub surfaces with a dry cloth.
- Do not install in the vicinity of processes generating strong electrostatic charges.

- After aligning (rotating) the enclosure, retighten the fixing screw.
- The safety screws at the pipe enclosure must not be loosened:

- Do not open in a potentially explosive dust atmosphere.
- Seal the cable entry or piping tight (see protection type of enclosure in the "Temperature tables" chapter).
- Connect the device using suitable cable and wire entries of protection type "Equipment dust ignition protection by enclosure (Ext)" (ingress protection of at least IP65). Lay connecting cable and secure.
- Before operation:
  - Screw in the cover all the way.
  - Tighten the securing clamp on the cover.
- Continuous service temperature of the connecting cable:  $\geq T_a + 20 \text{ K}$ .

- The tightening torque refers to cable glands installed by the manufacturer:
  - Recommended torque to connect the cable gland into the enclosure: 3.75 Nm
  - Recommended torque to tighten the cable into the cable gland: 3.5 Nm
  - Maximum torque to tighten the cable into the cable gland: 10 Nm
  - This value may be different depending on the type of cable.
     However, the maximum value must not be exceeded.
- Only suitable for fixed installation. The operator must pay attention to a suitable strain relief of the cable.
- To maintain the ingress protection of the enclosure: Install the enclosure cover, cable glands and blind plugs correctly.

The cable glands are suitable for a low risk of mechanical danger (4 Joule) and must be mounted in a protected position if larger impact energy levels are expected.
