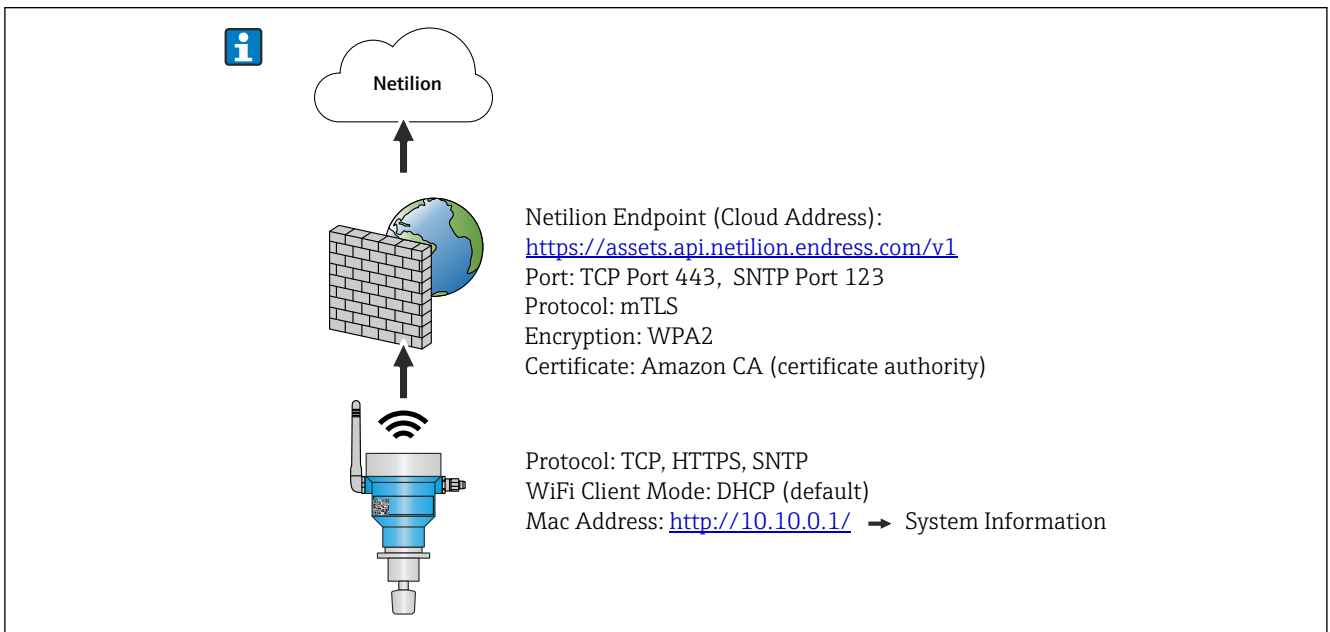

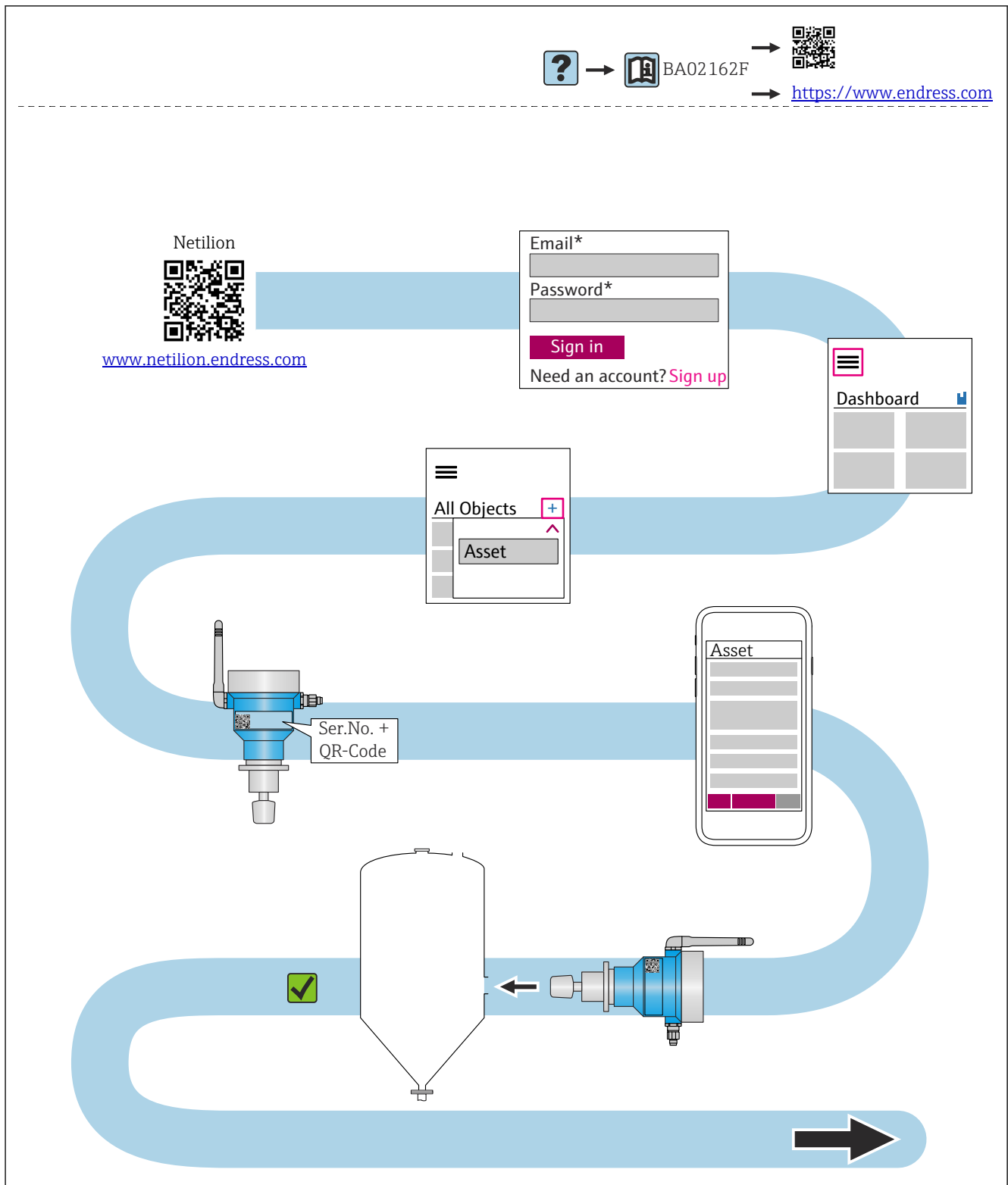

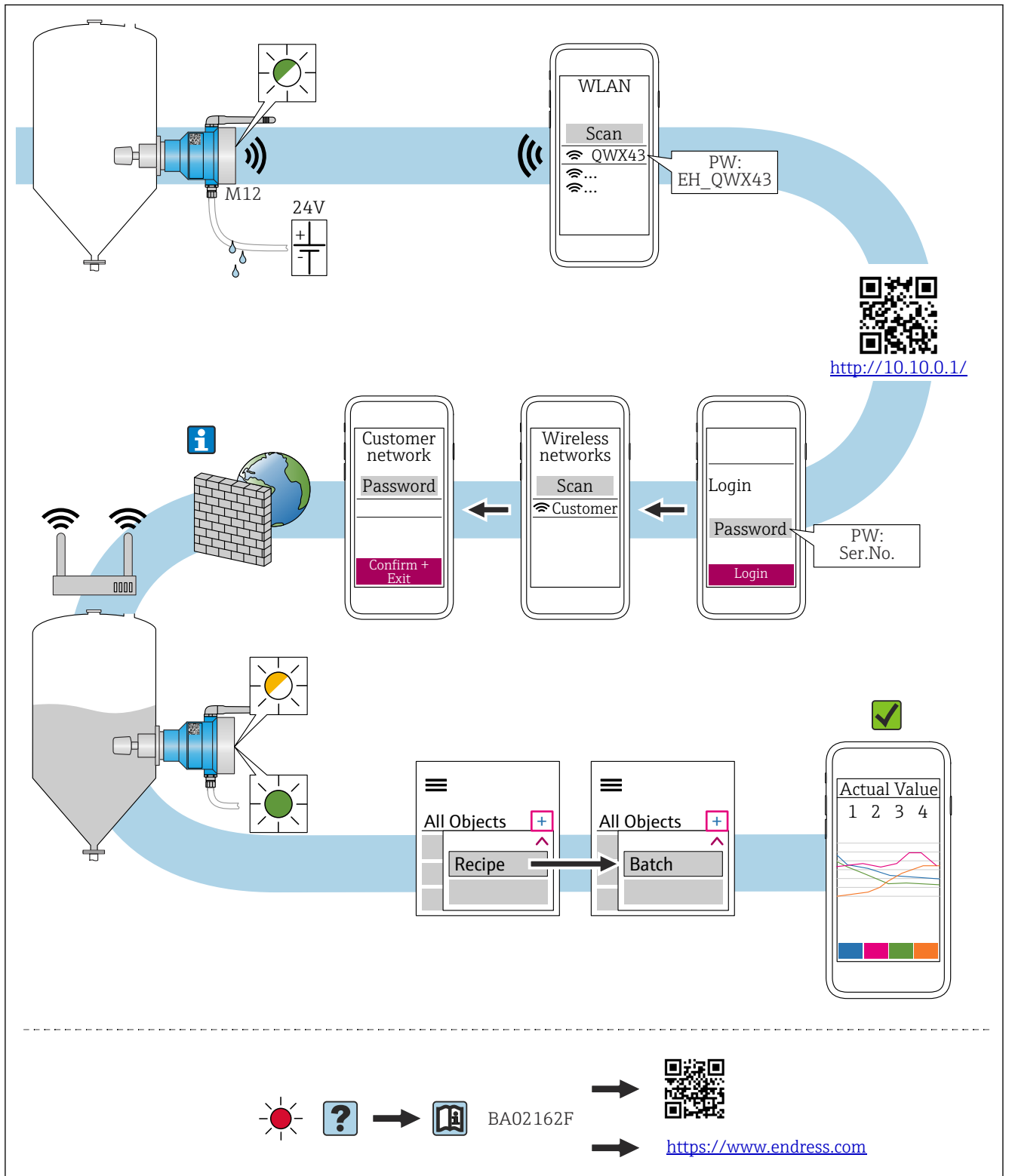
Netzwerk Konfiguration

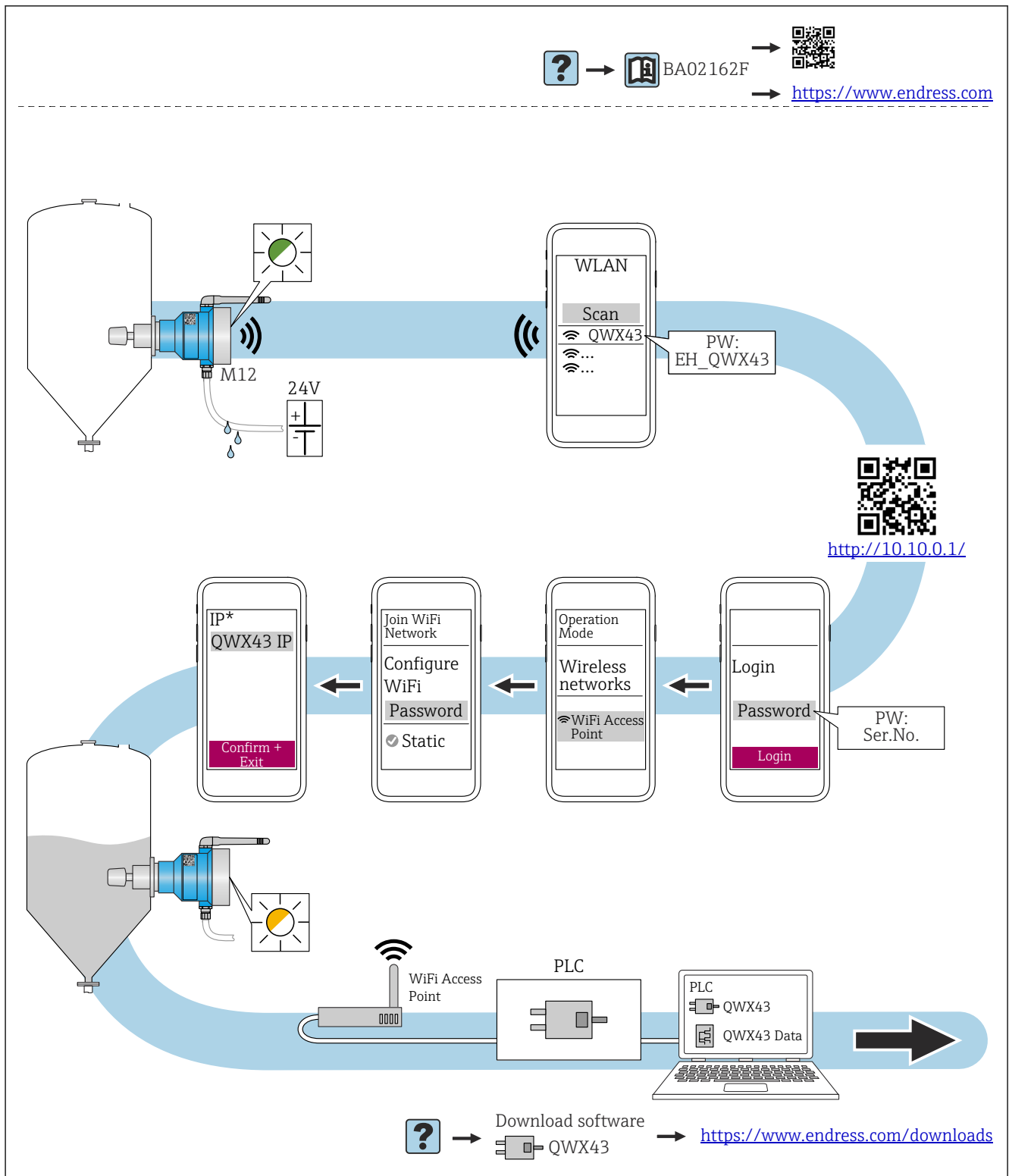
Verbindung Netilion



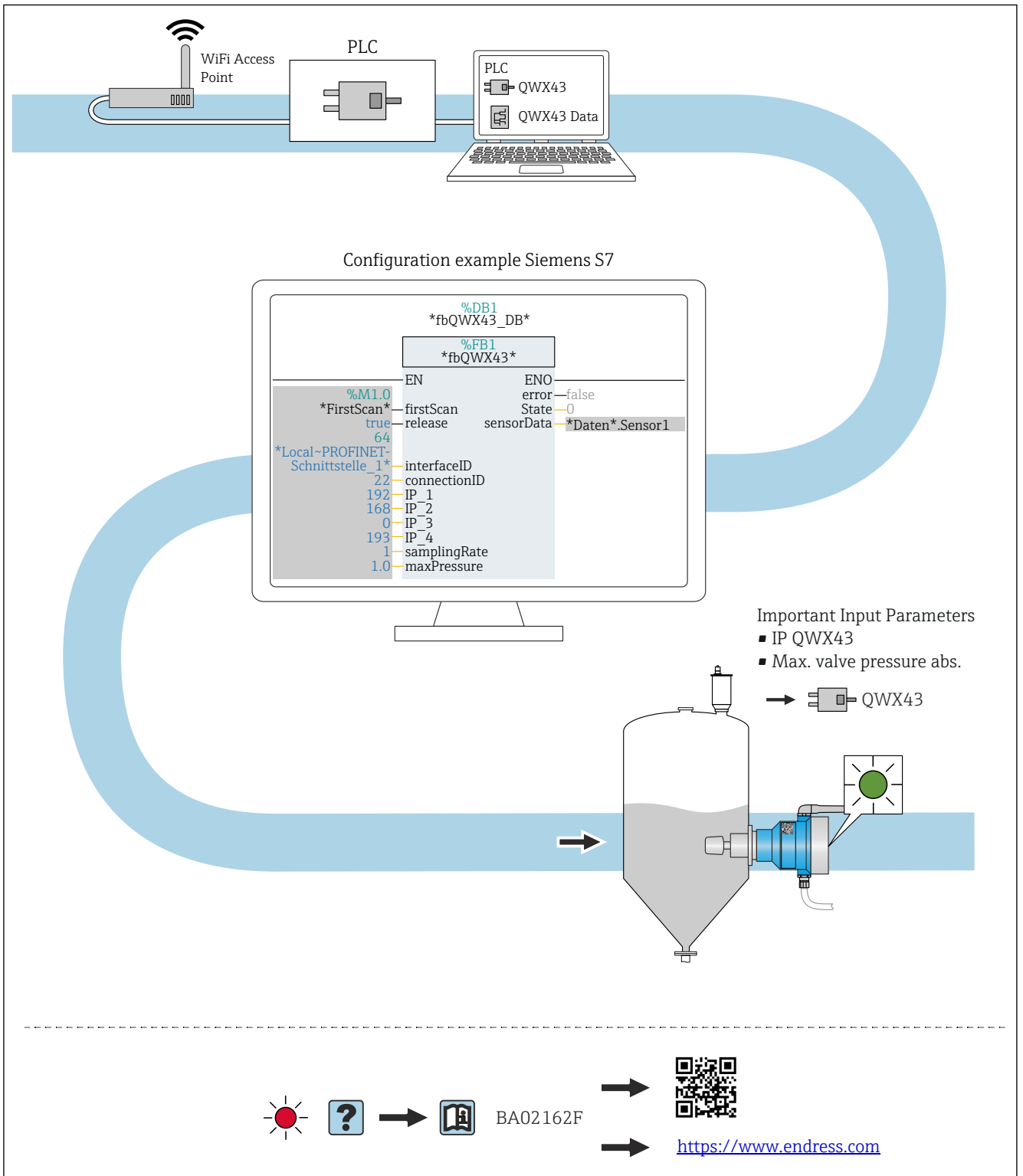
