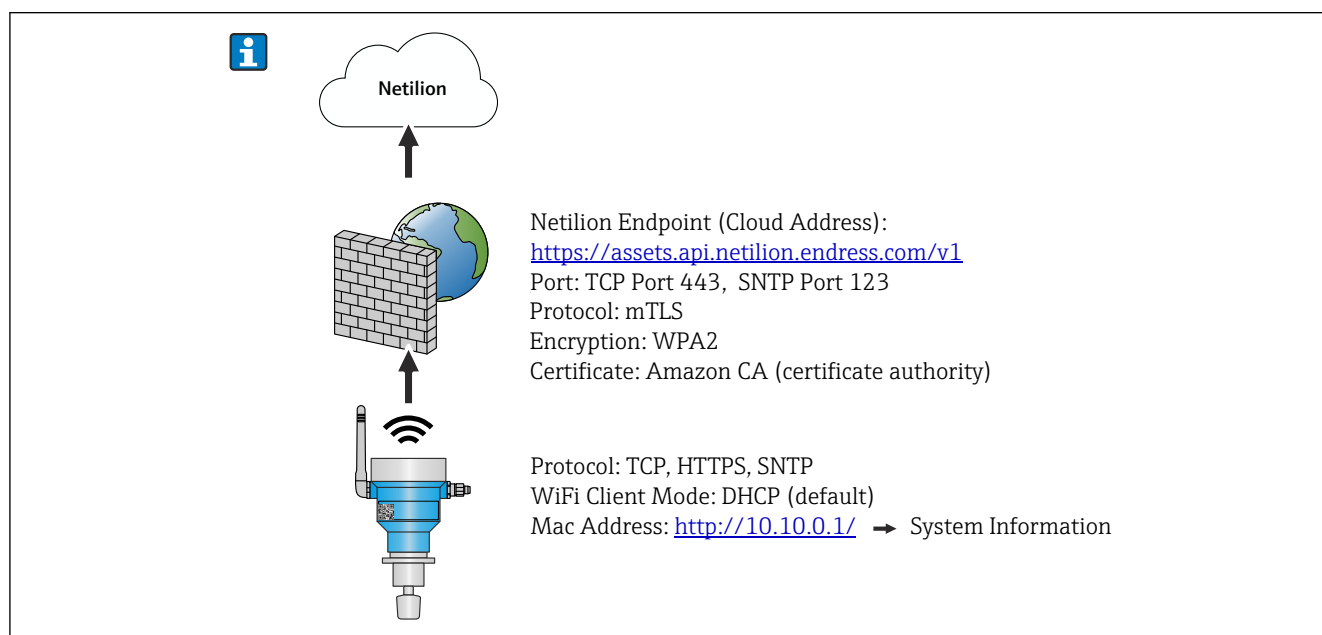

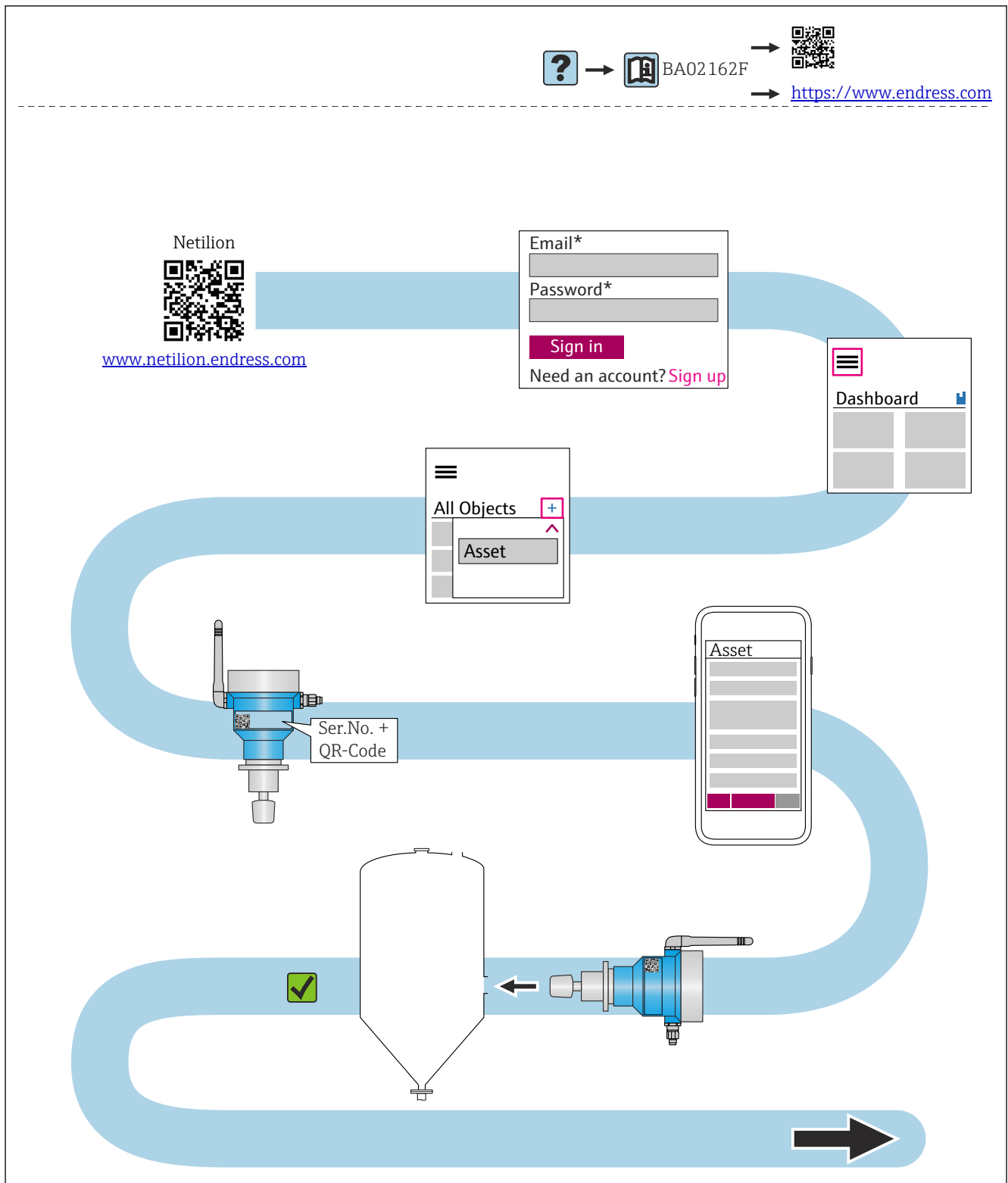

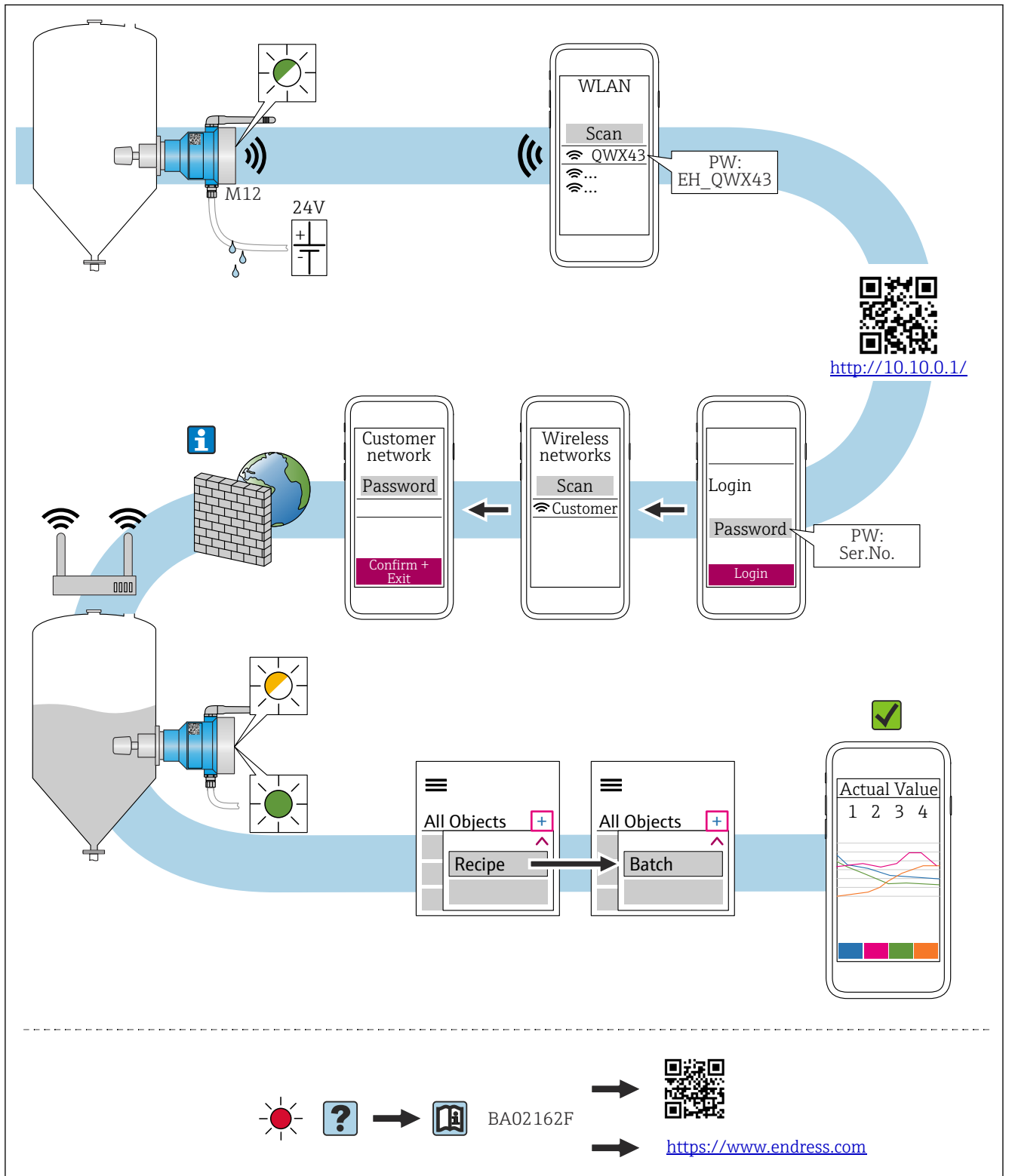
Konfiguracija mreže

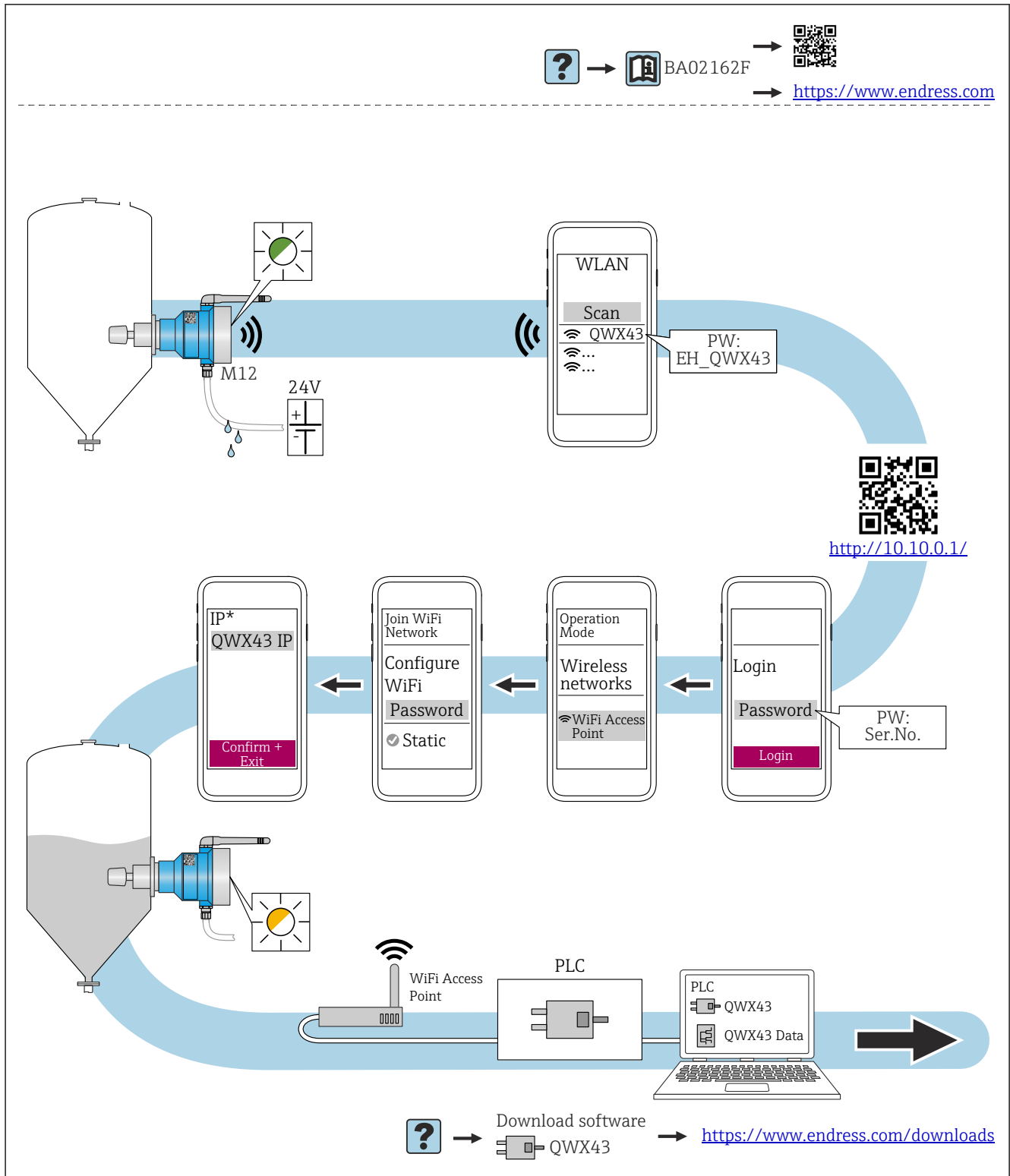

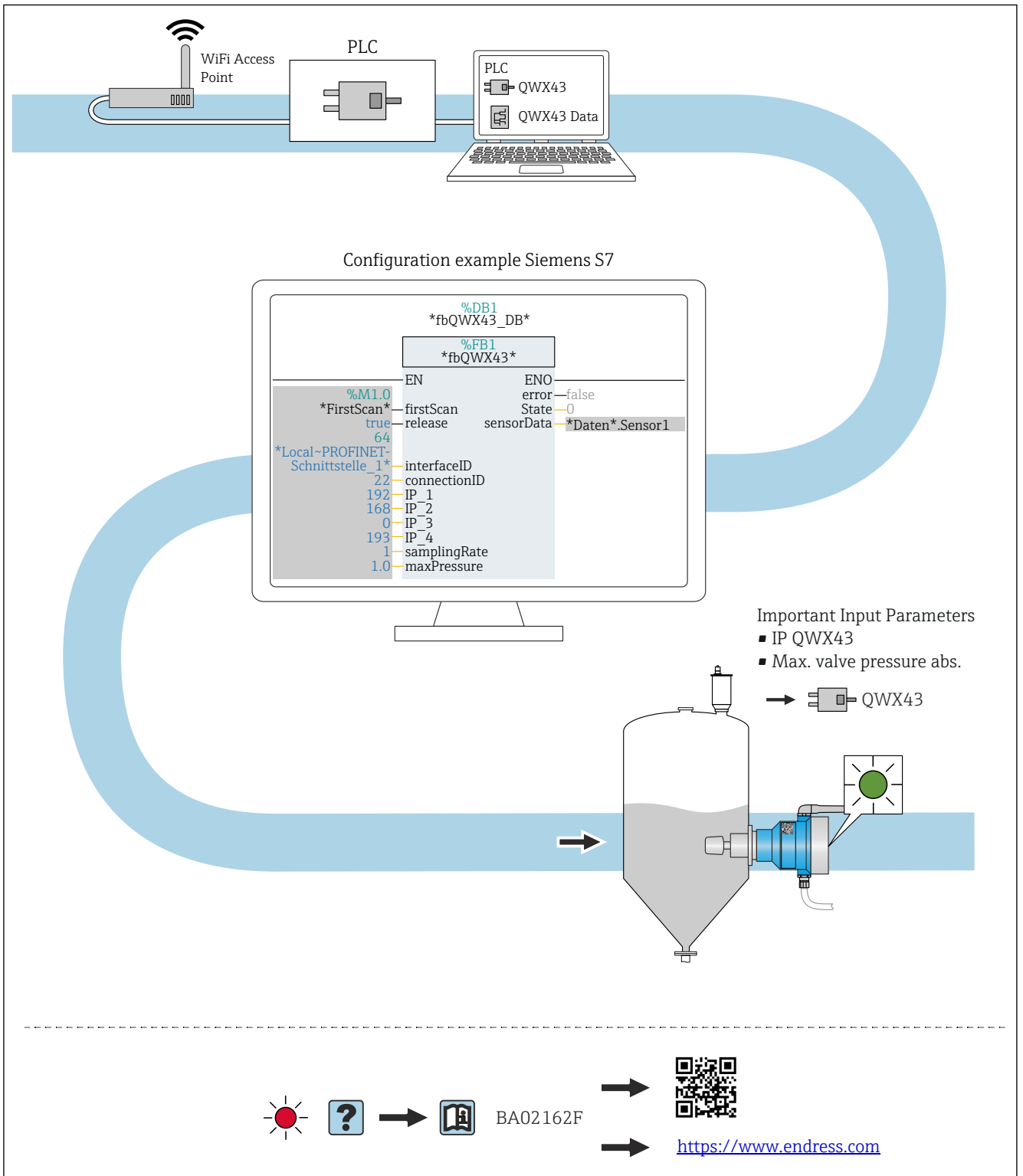
