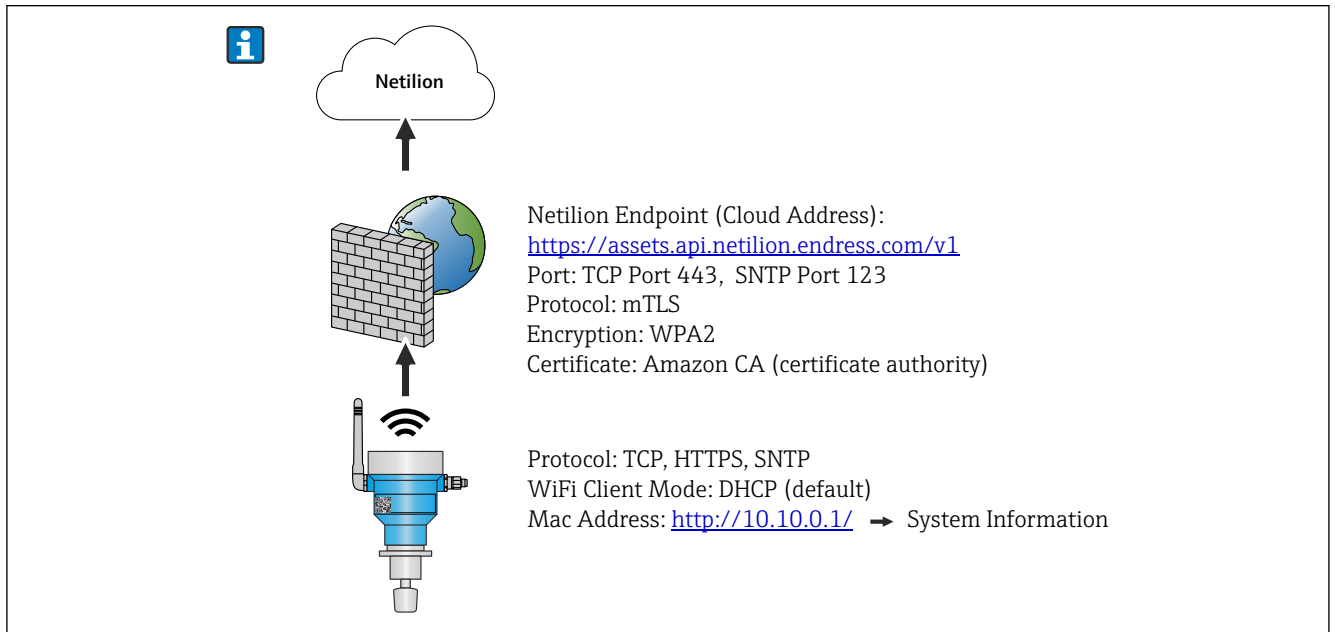

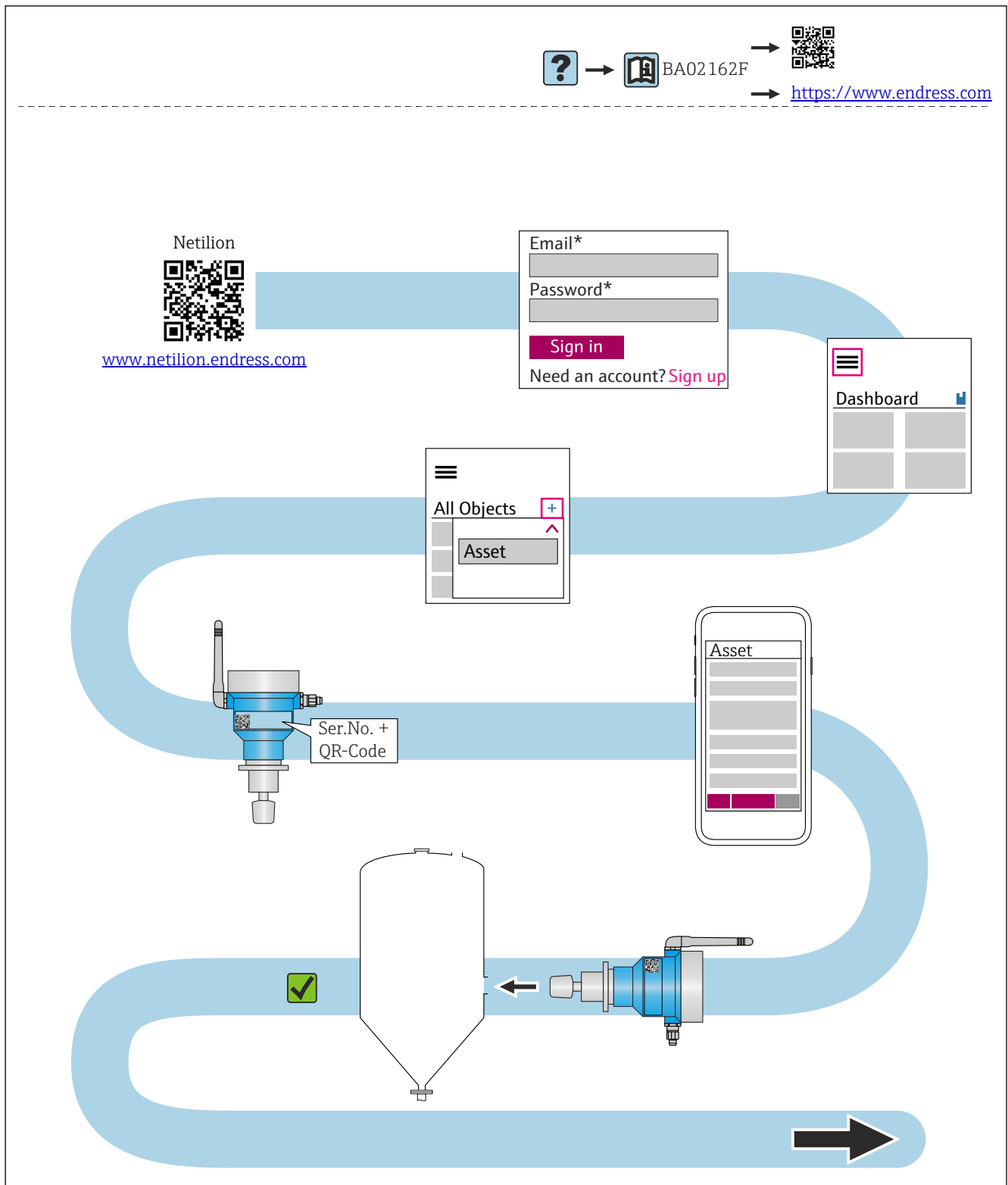

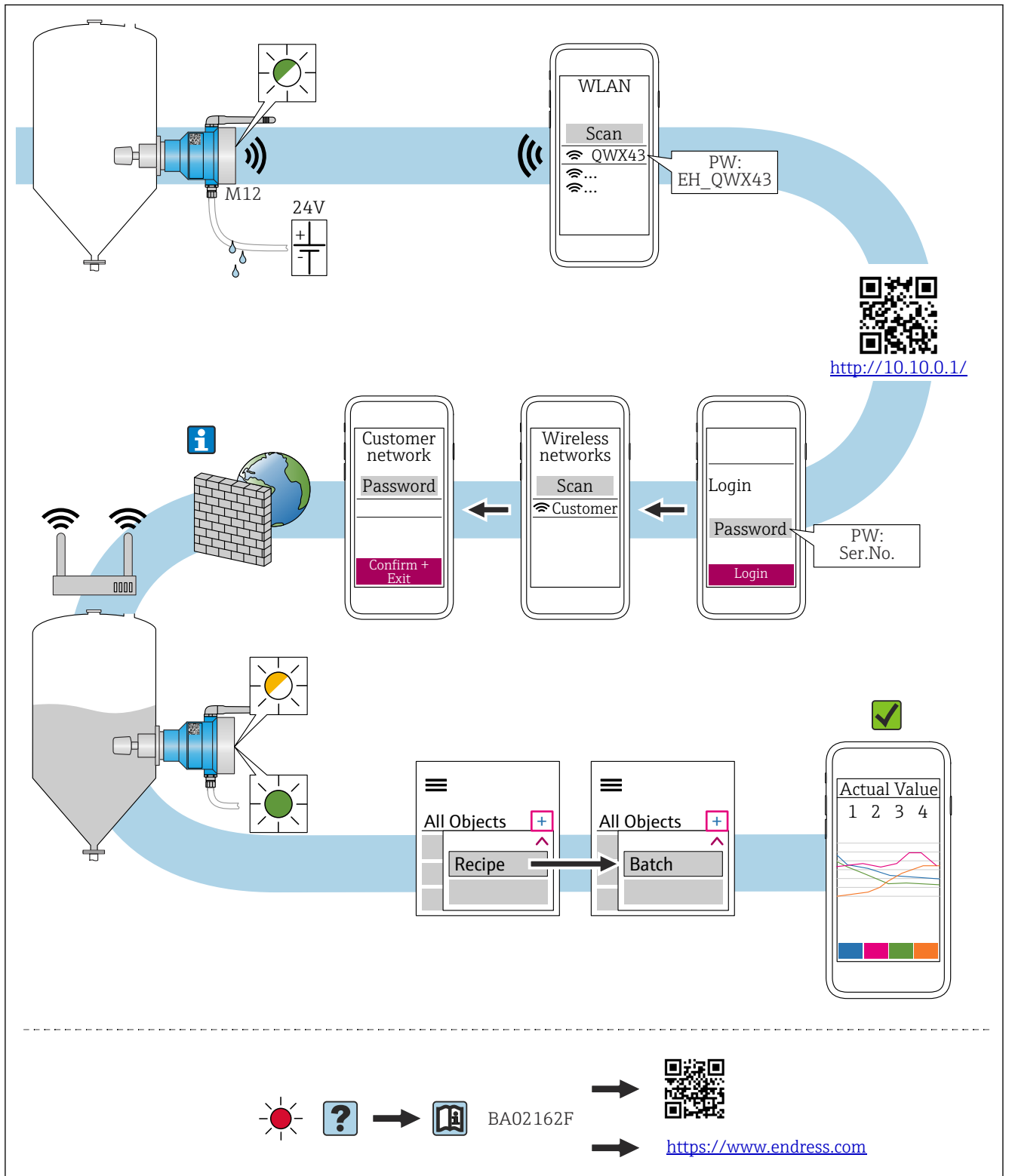
### Ağ konfigürasyonu

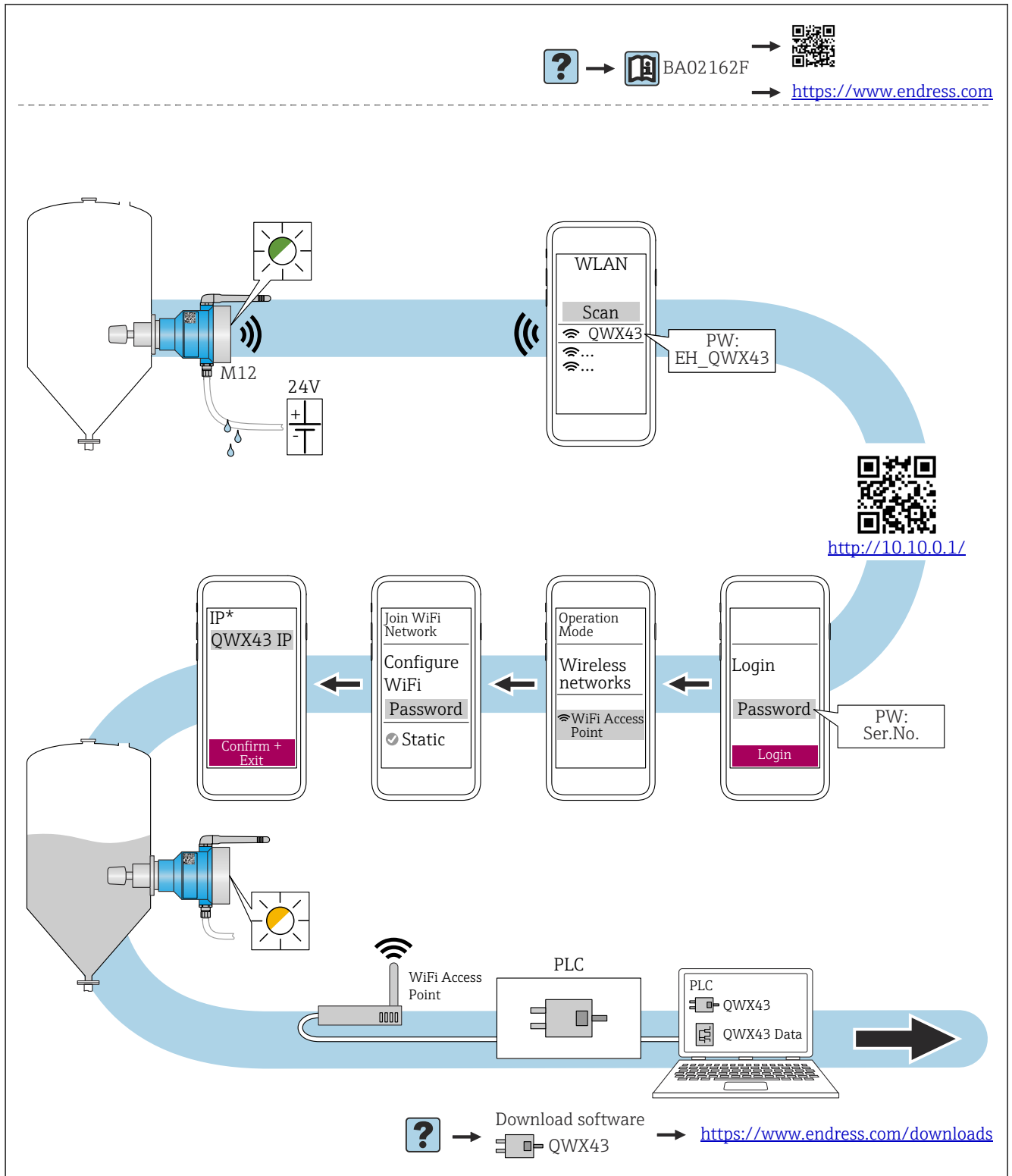

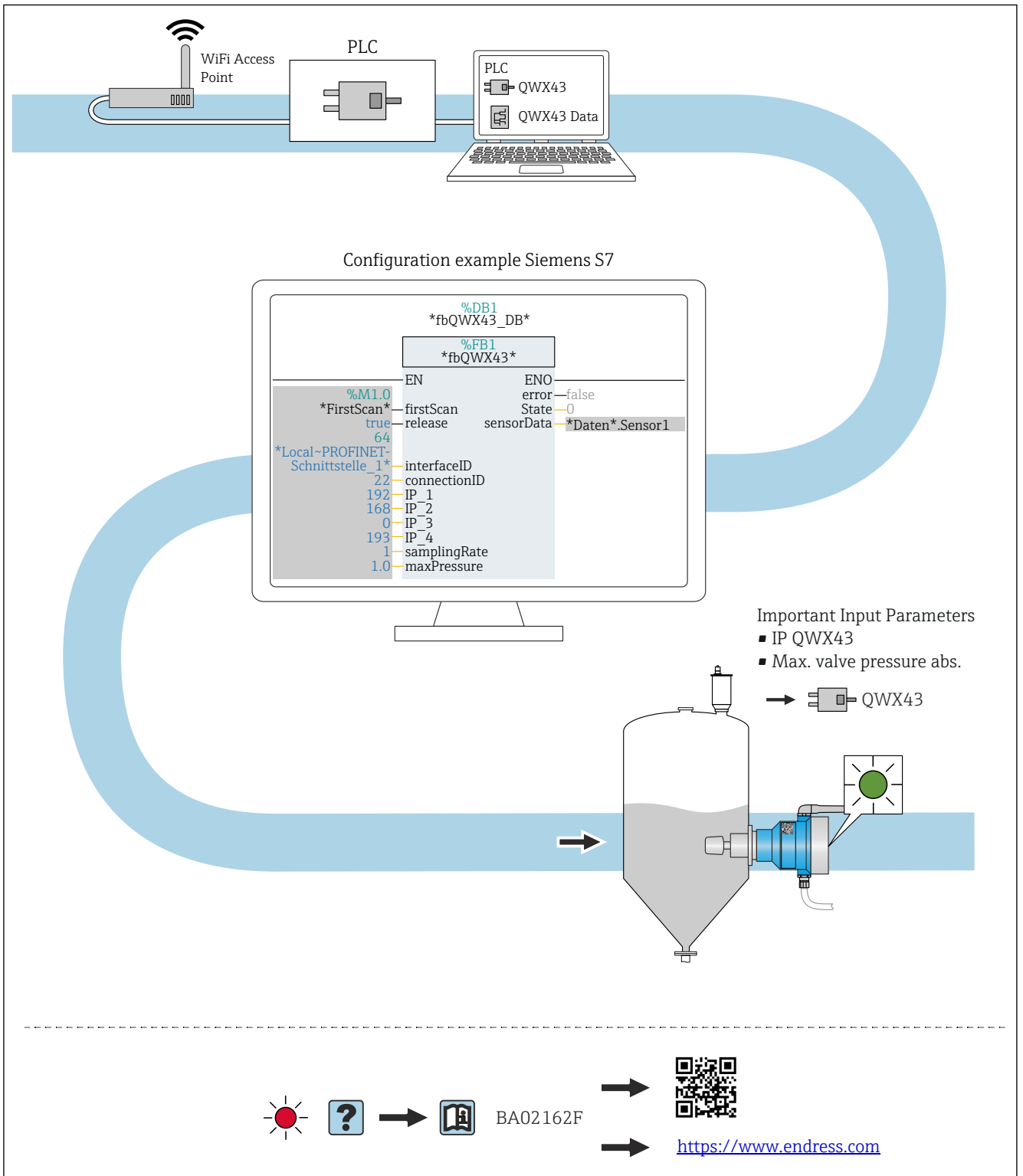
