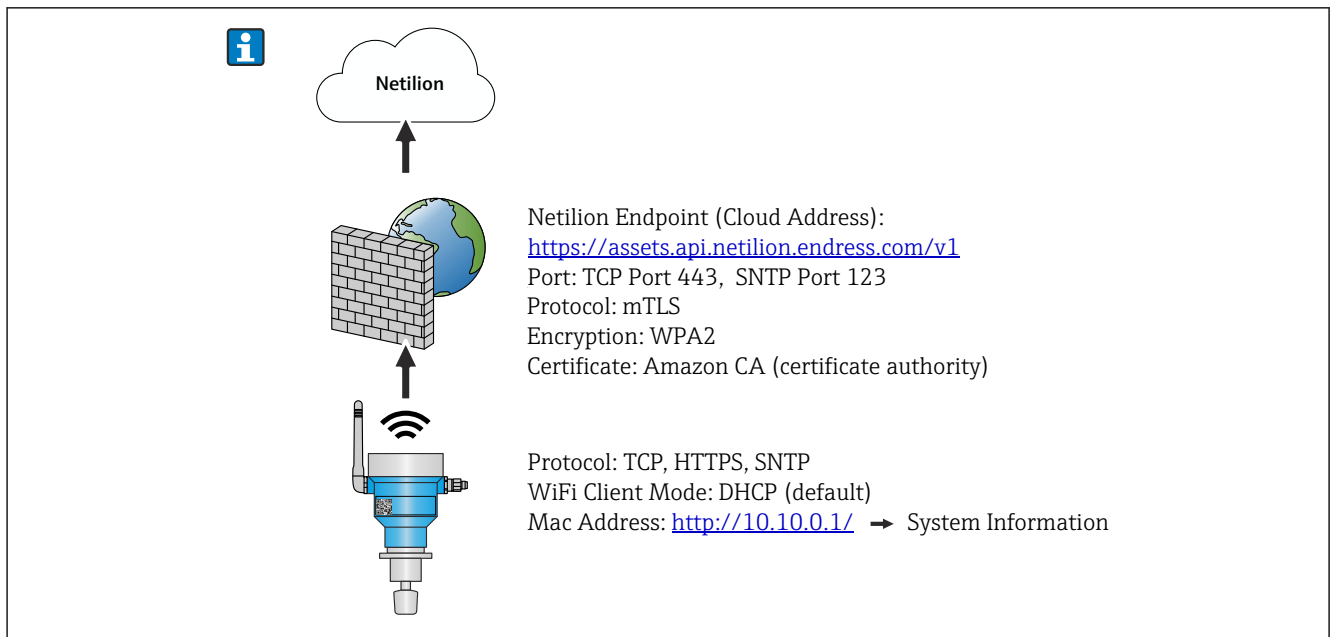

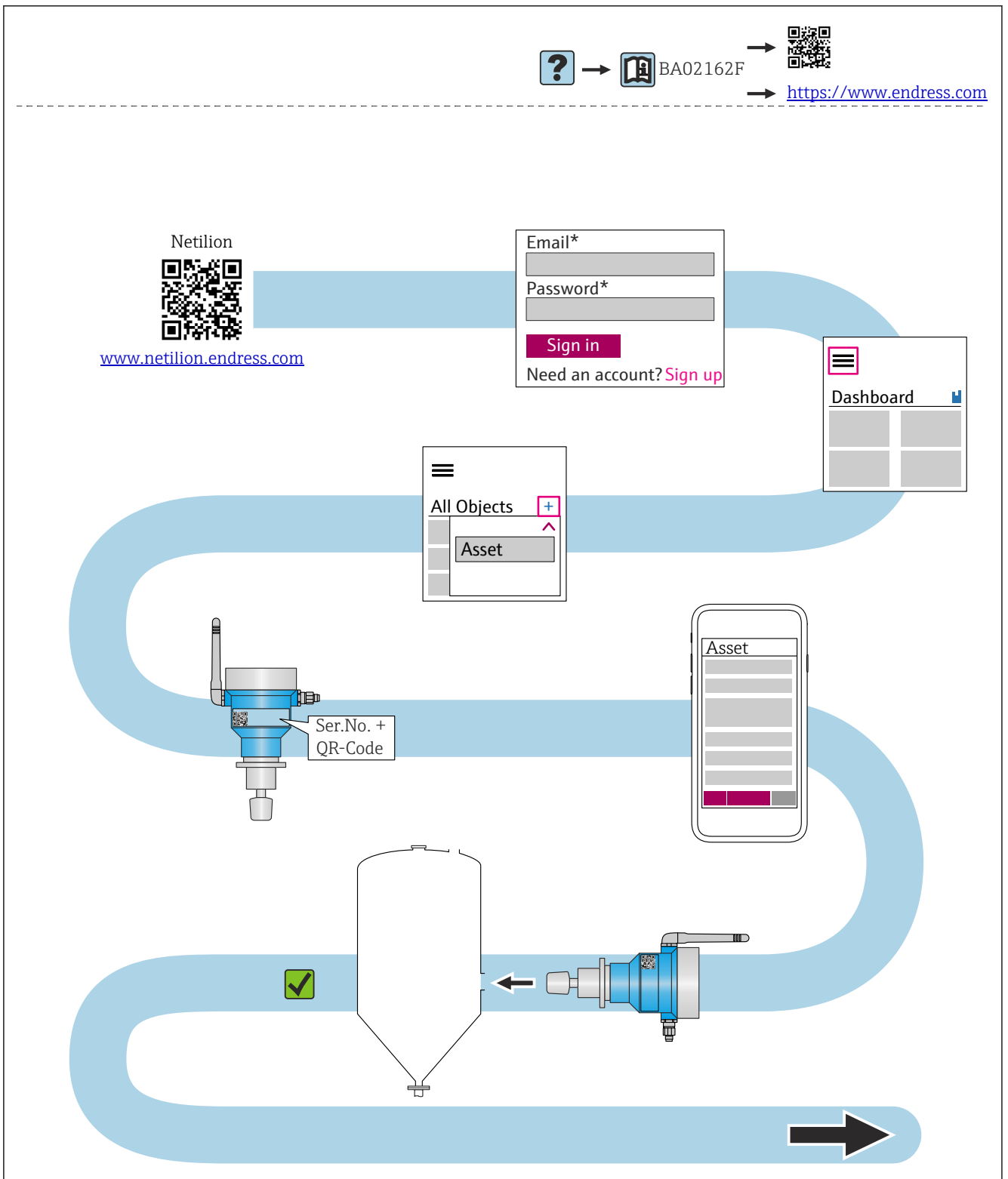

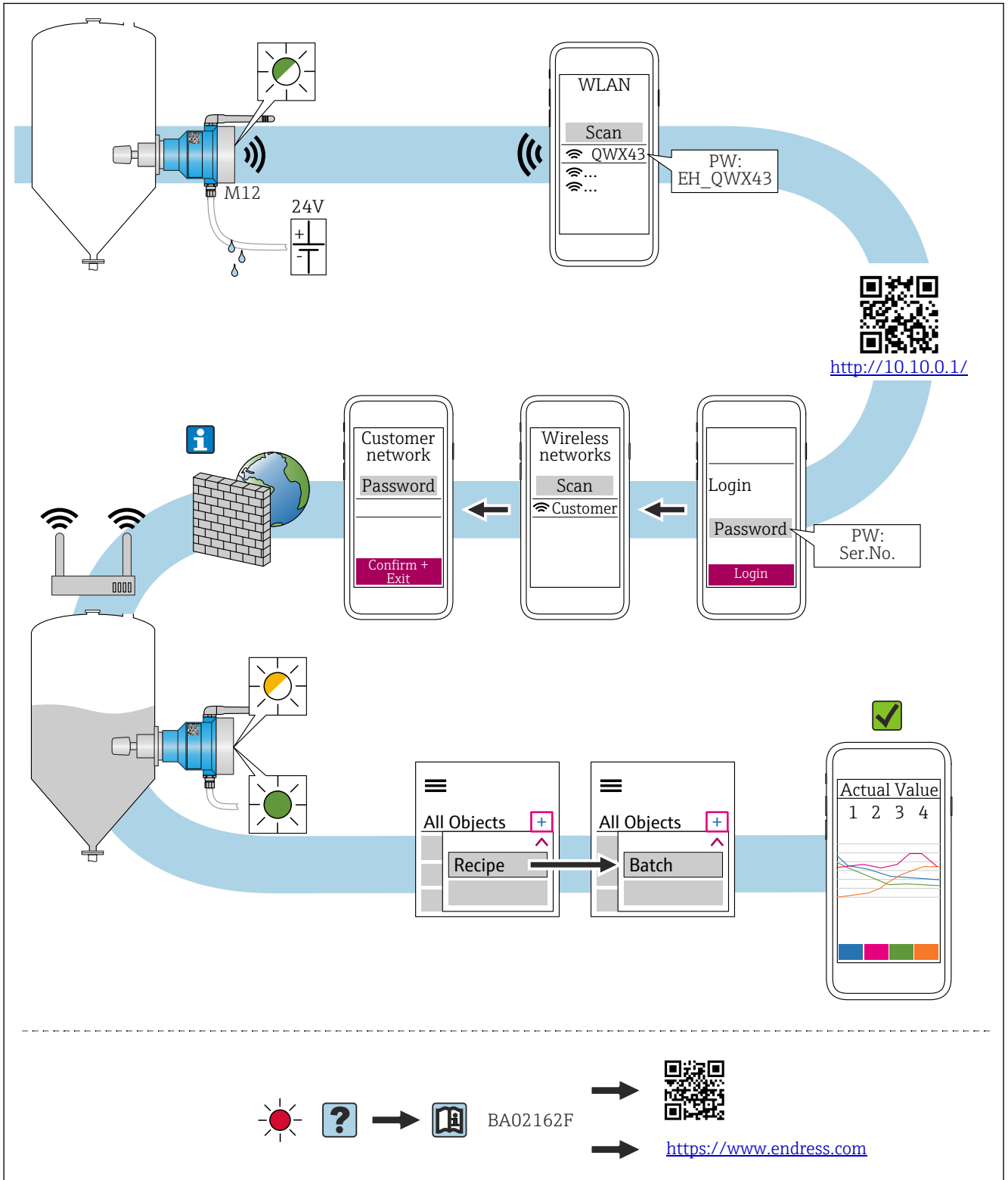
## Configurare rețea



### Conexiune Netilion

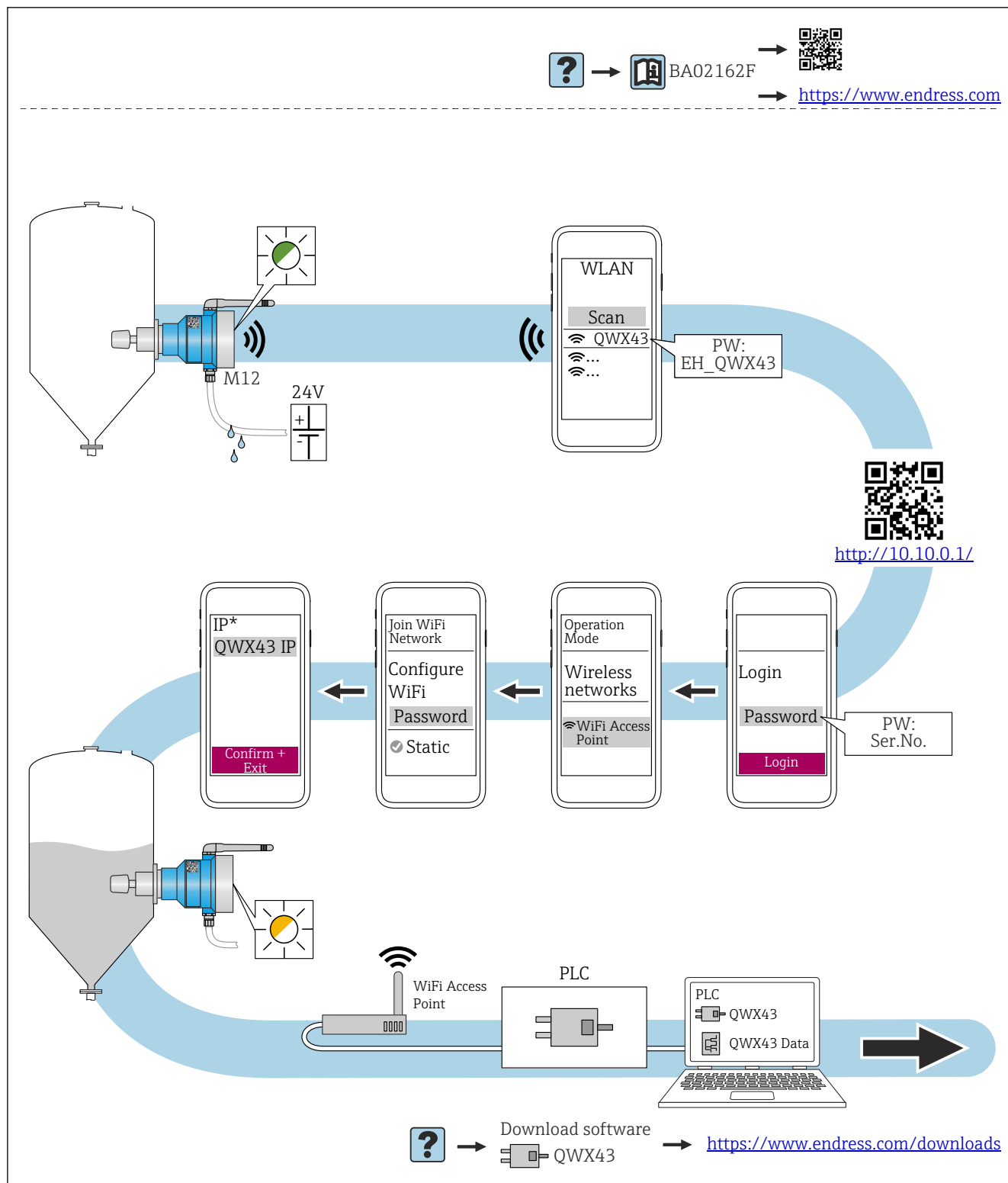

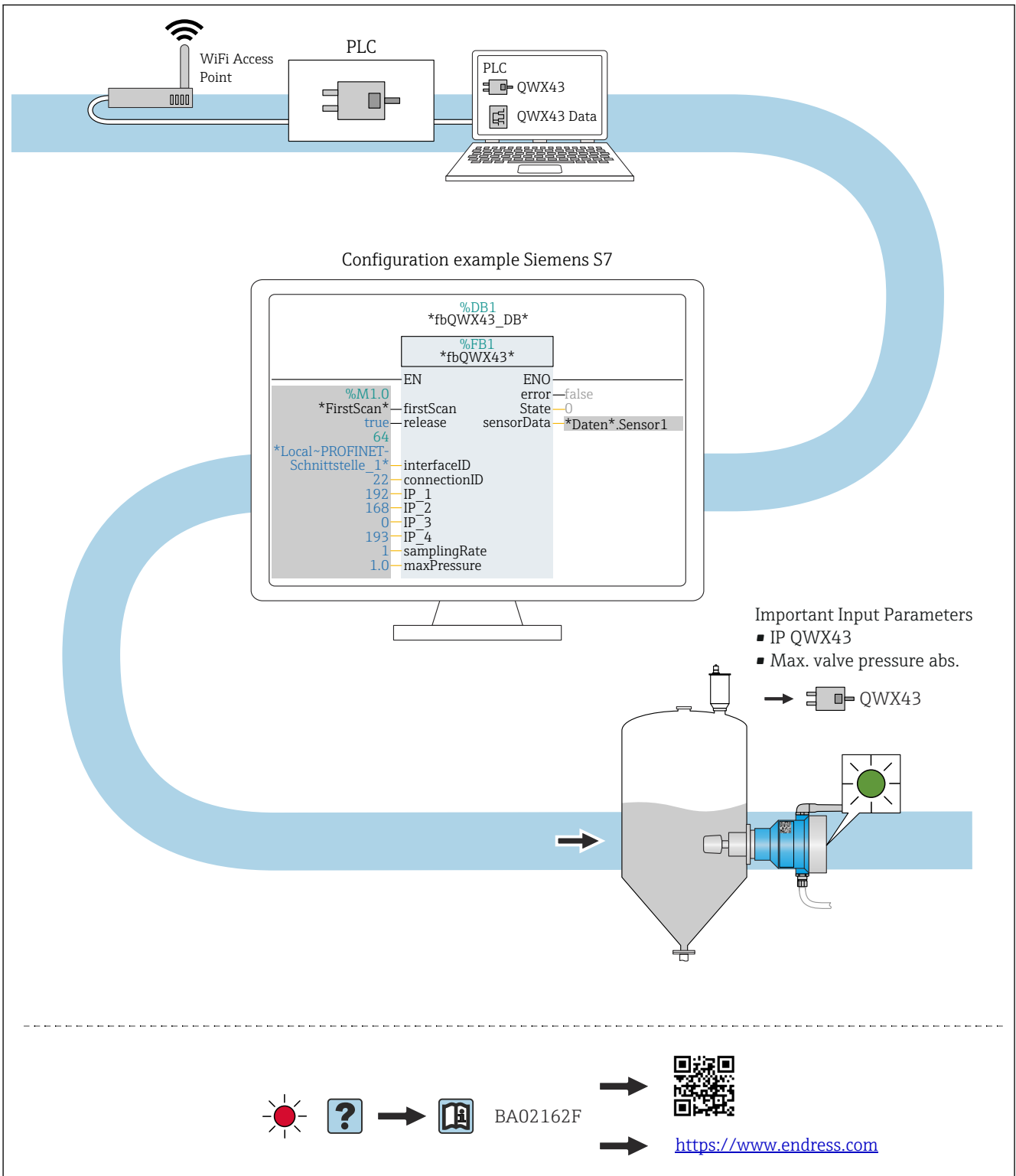

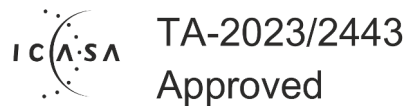
