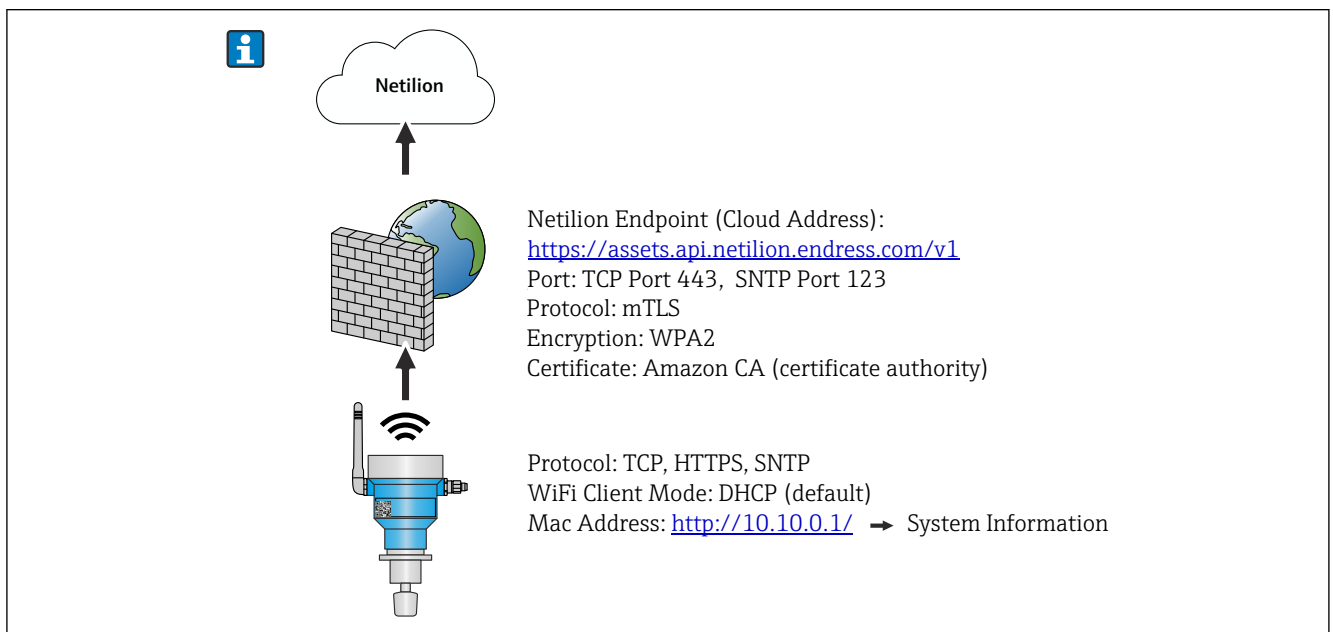

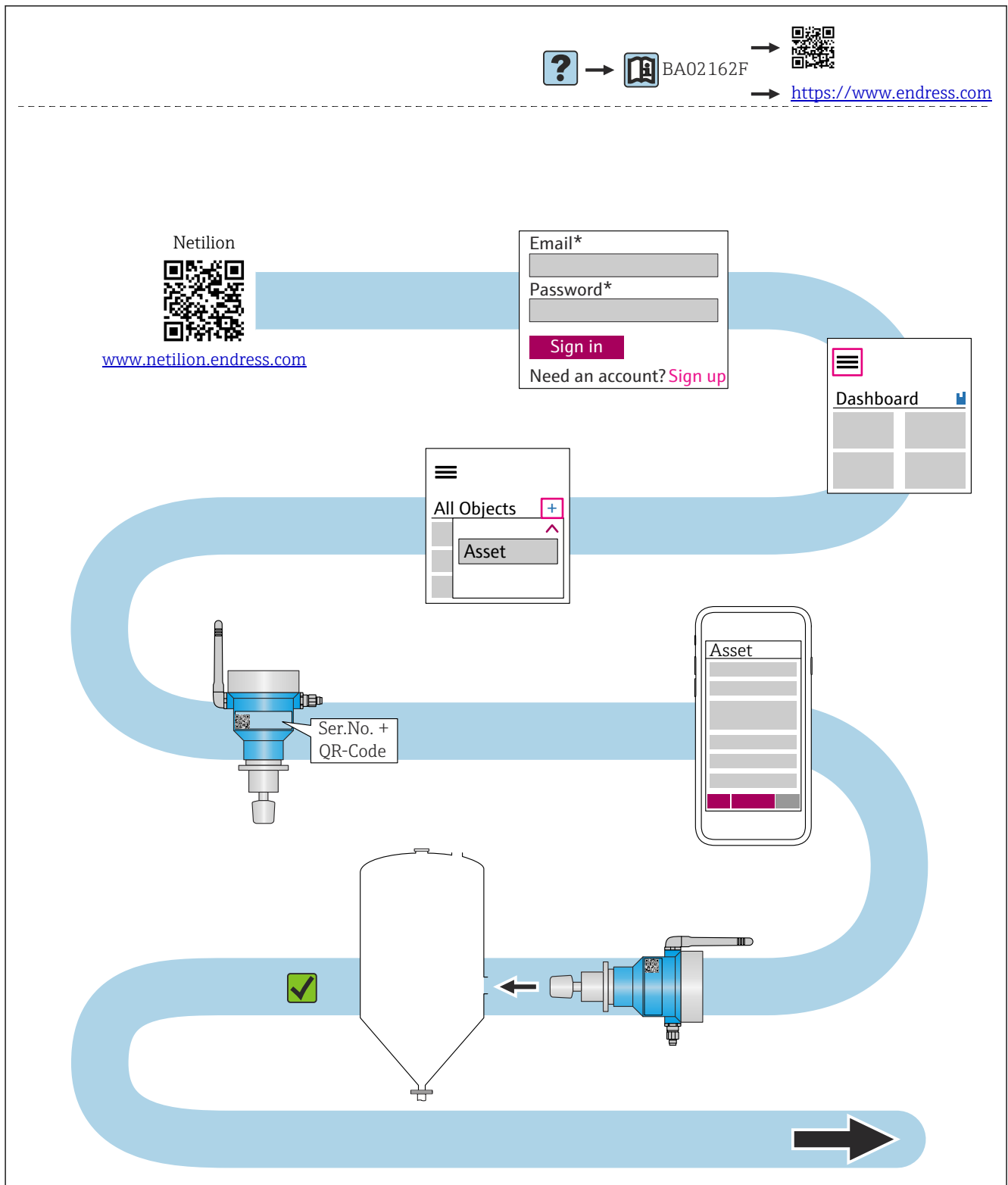

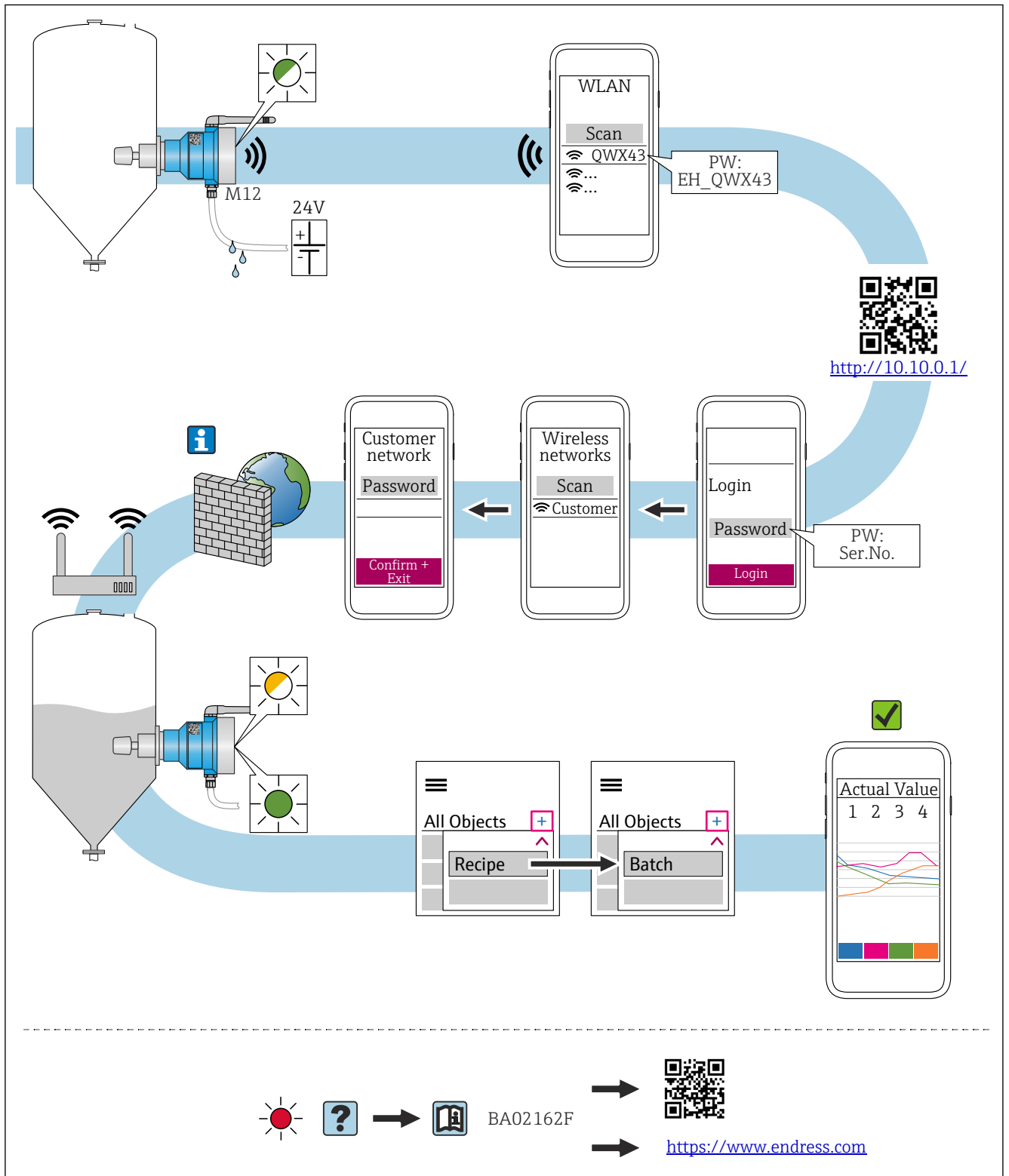
Nätverkskonfiguration

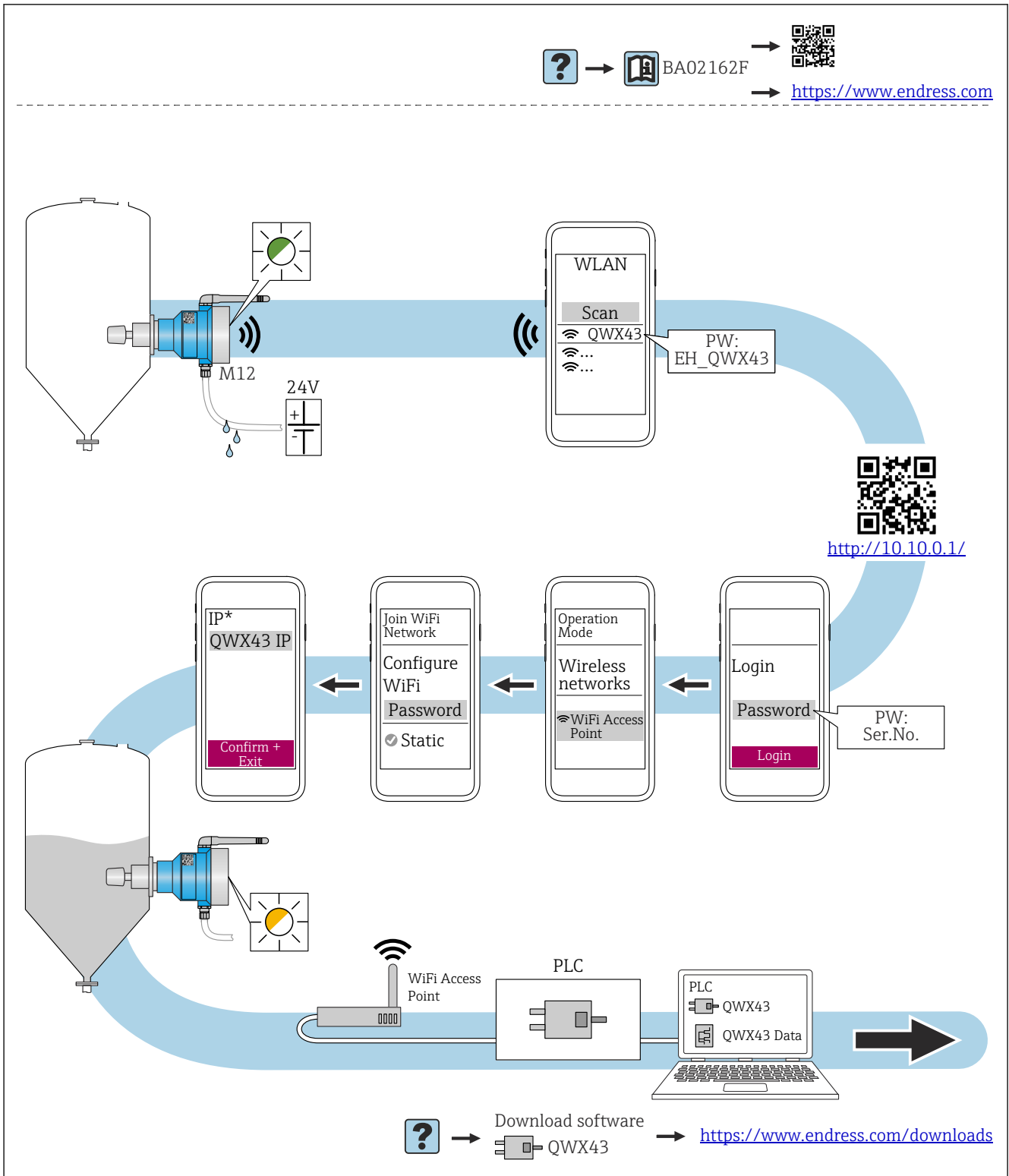
Netilion-anslutning



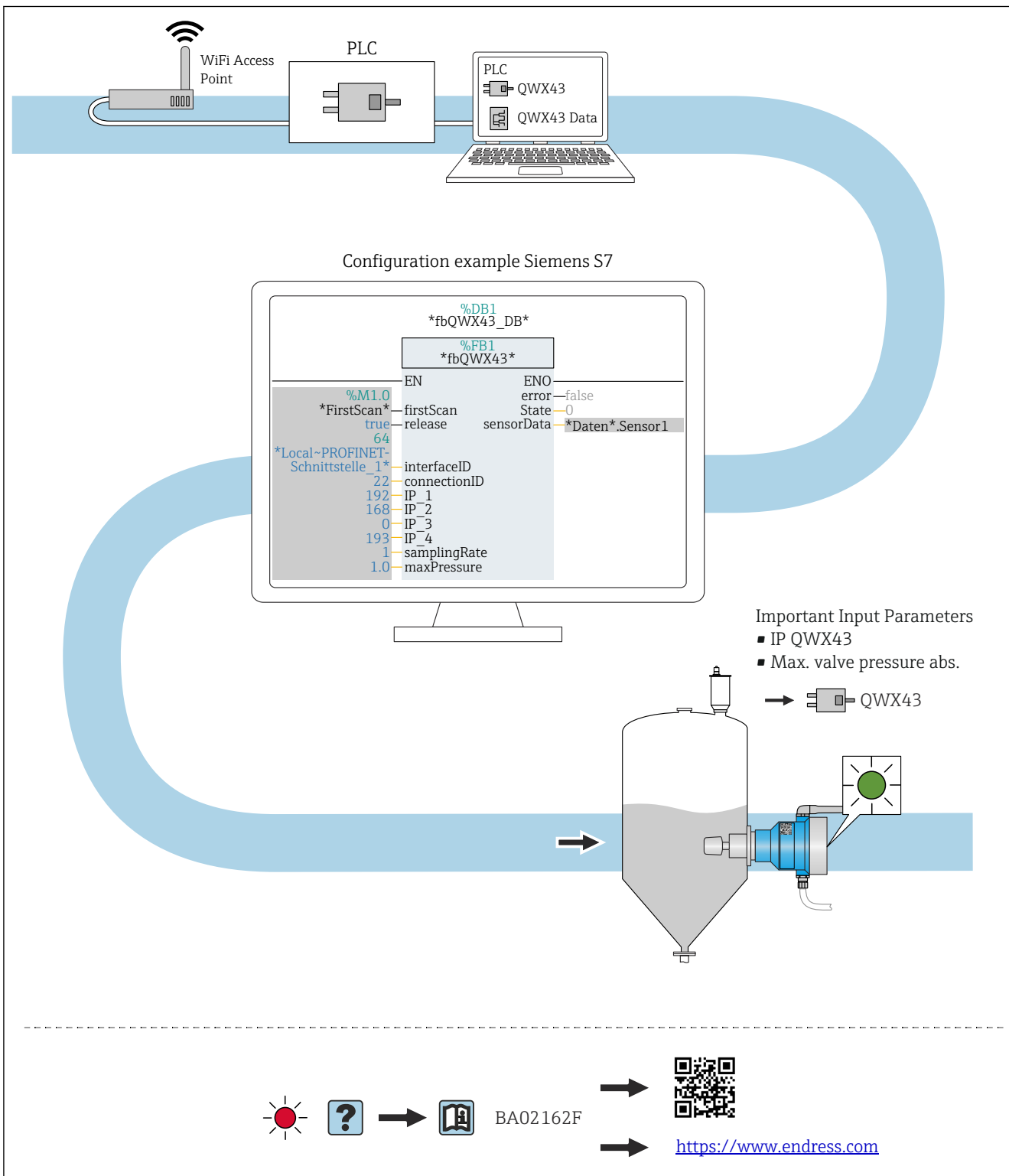
