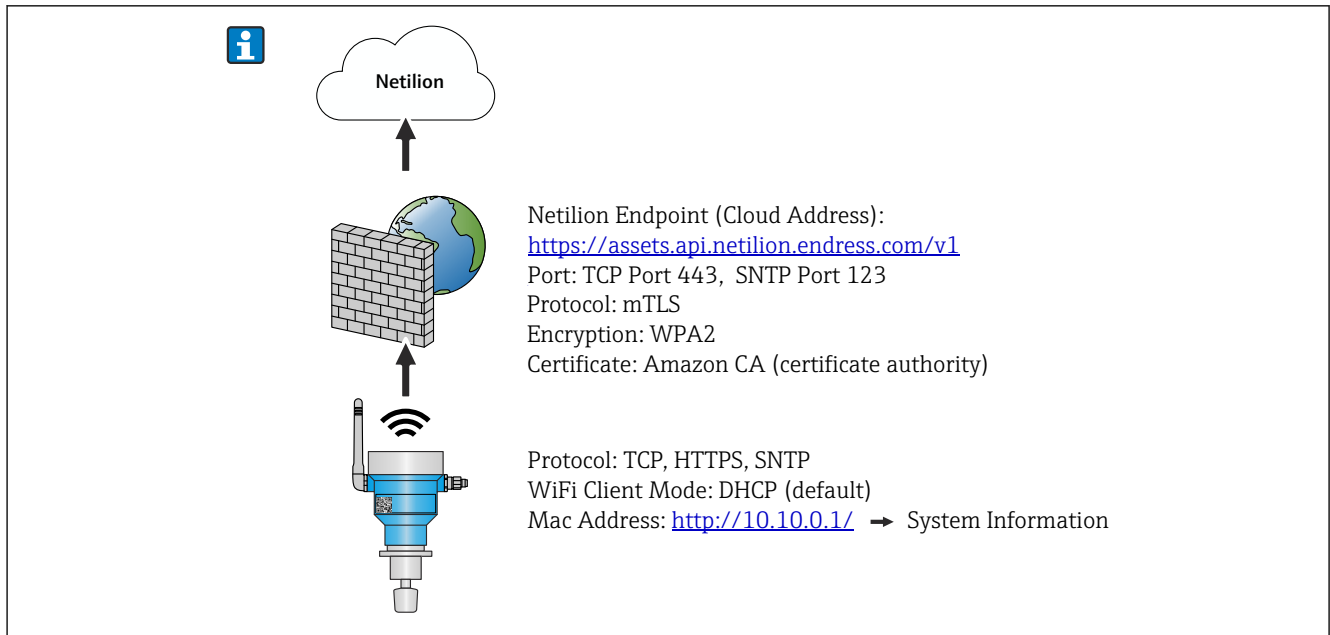

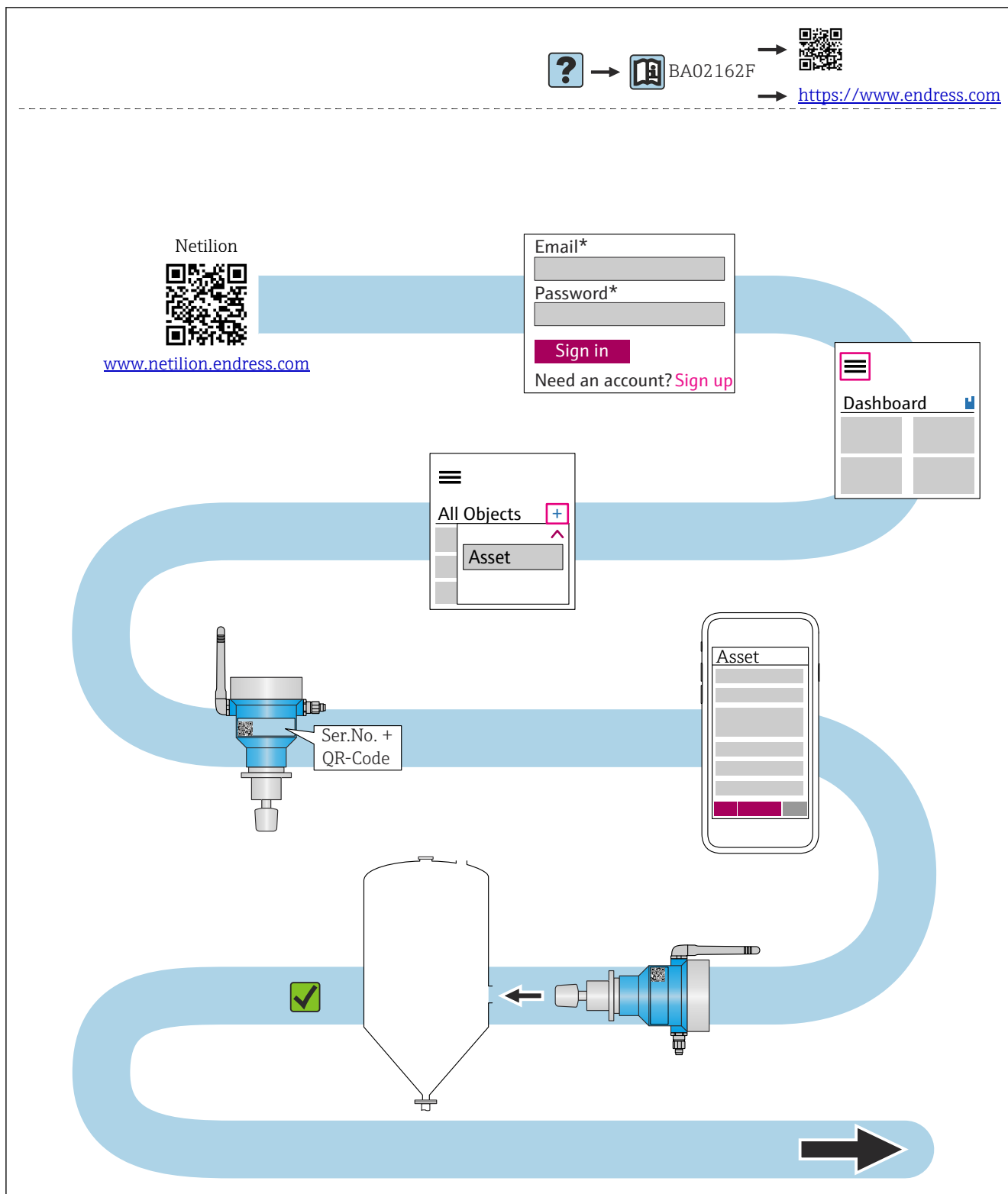

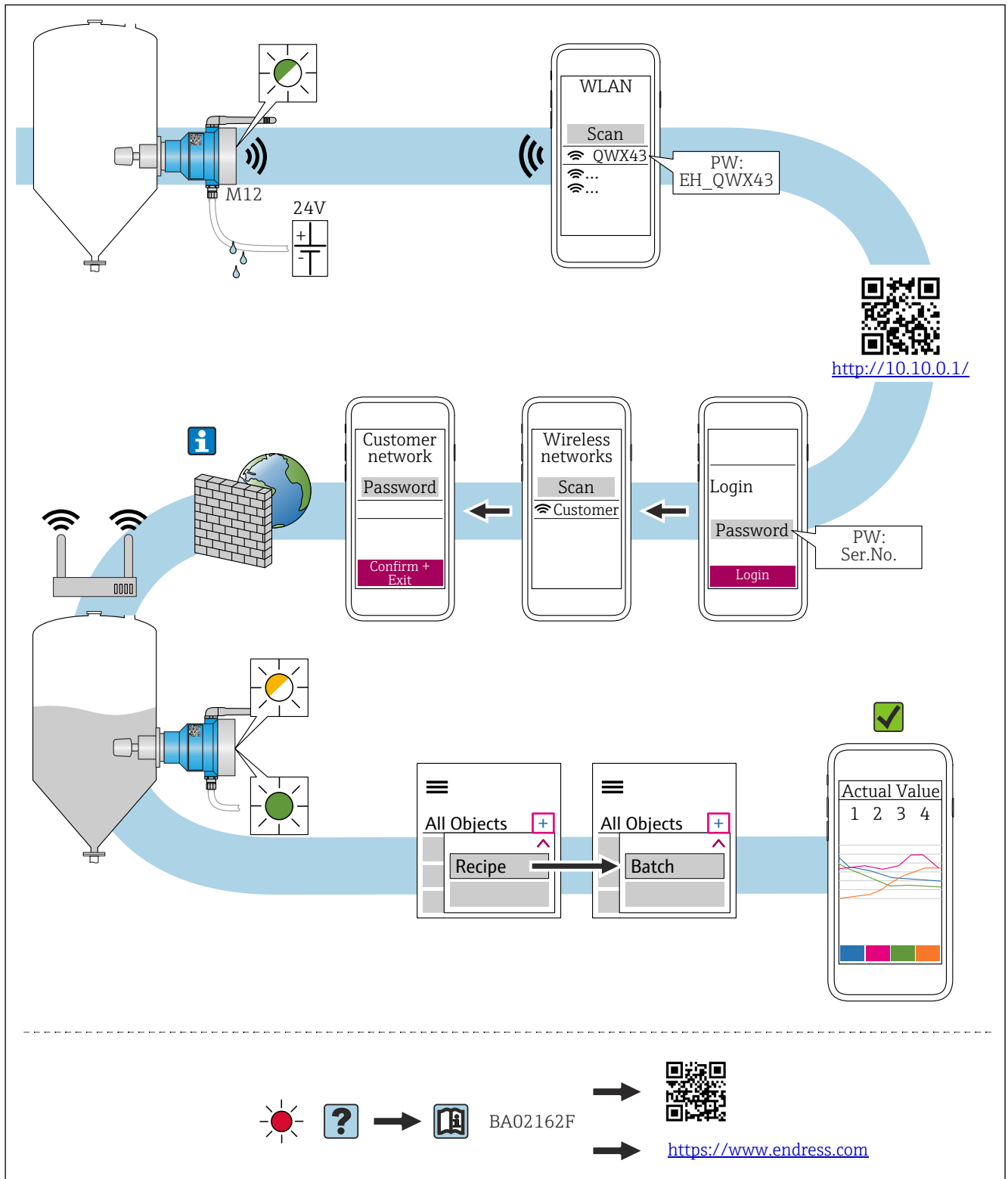
Конфигурация сети



Подключение Netilion

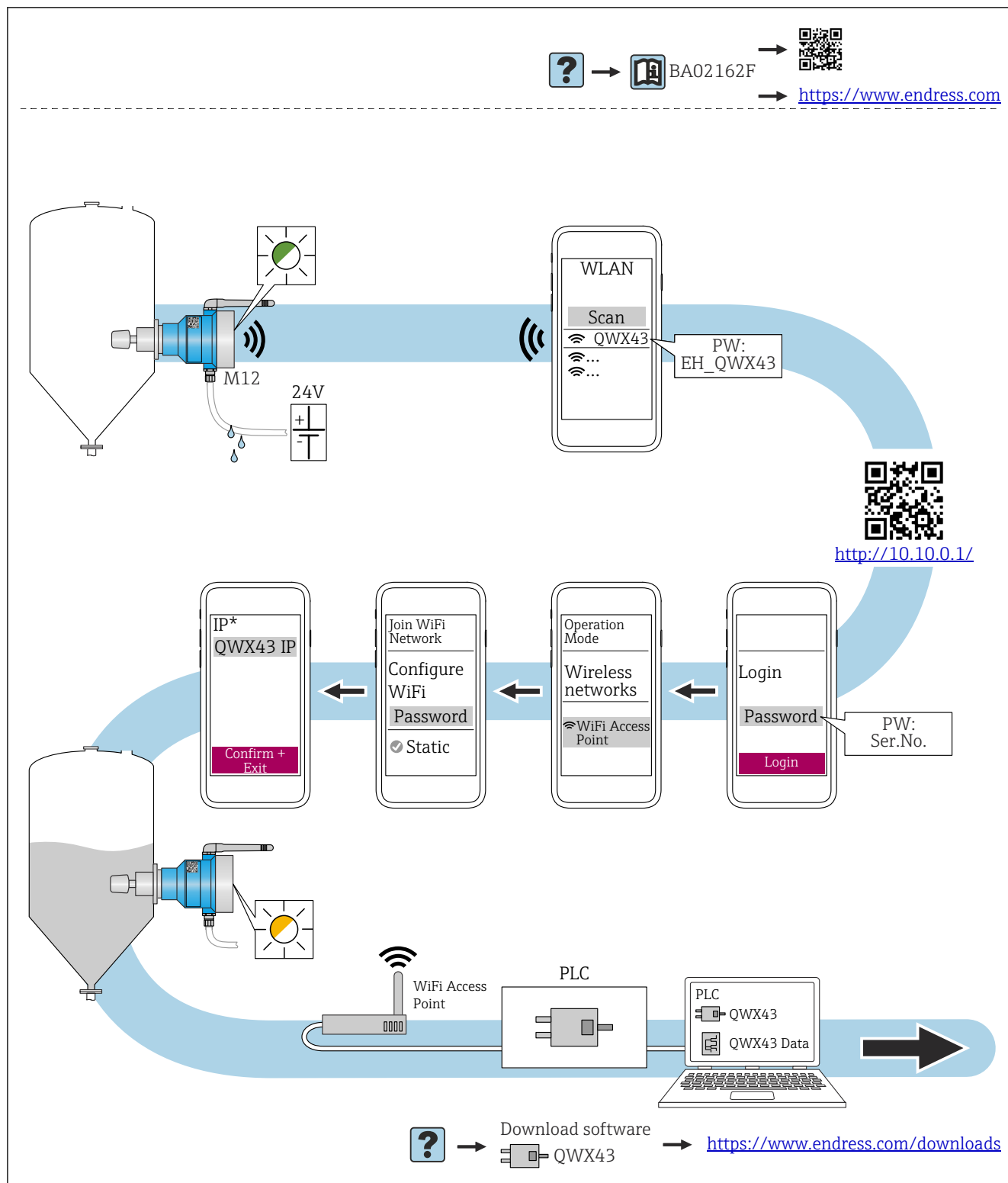

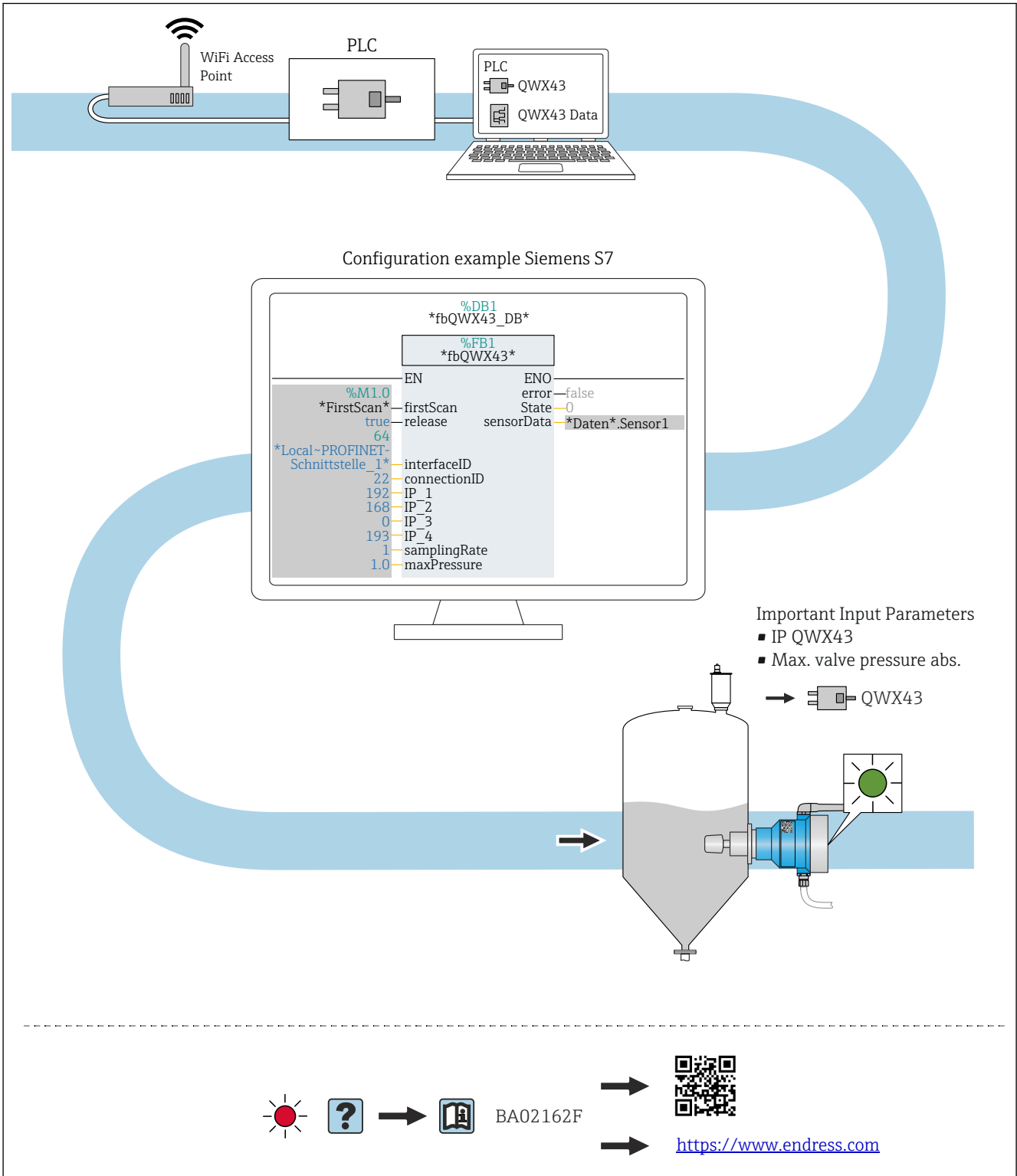
