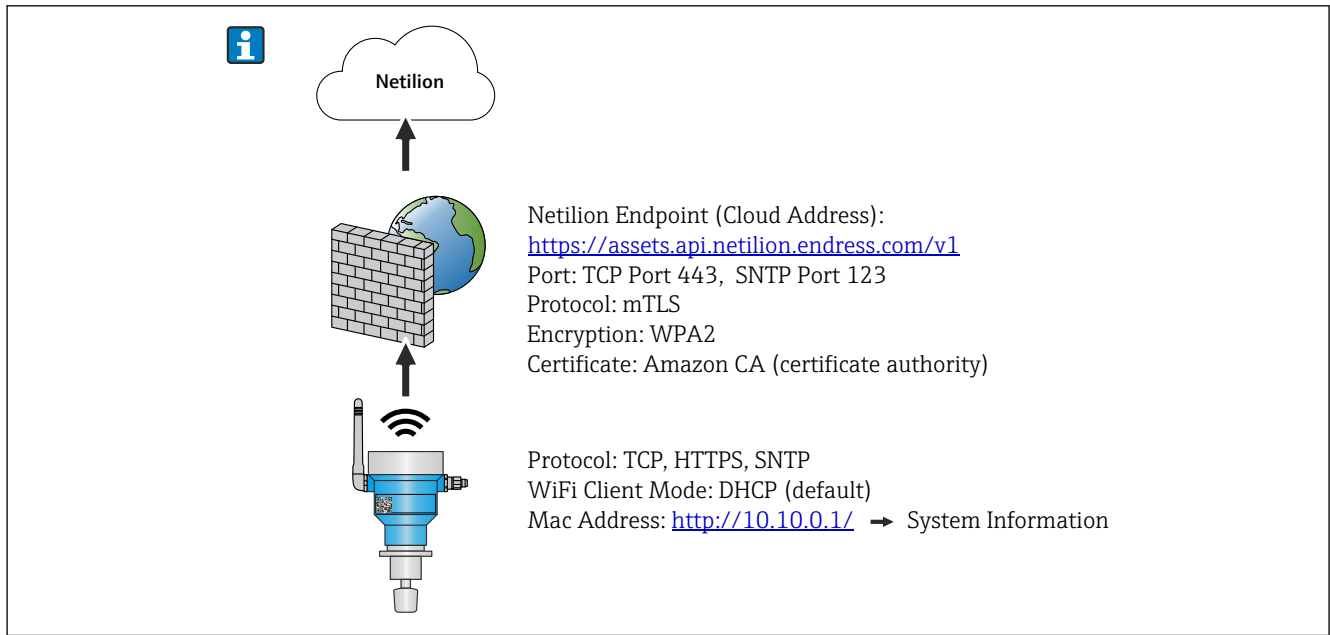

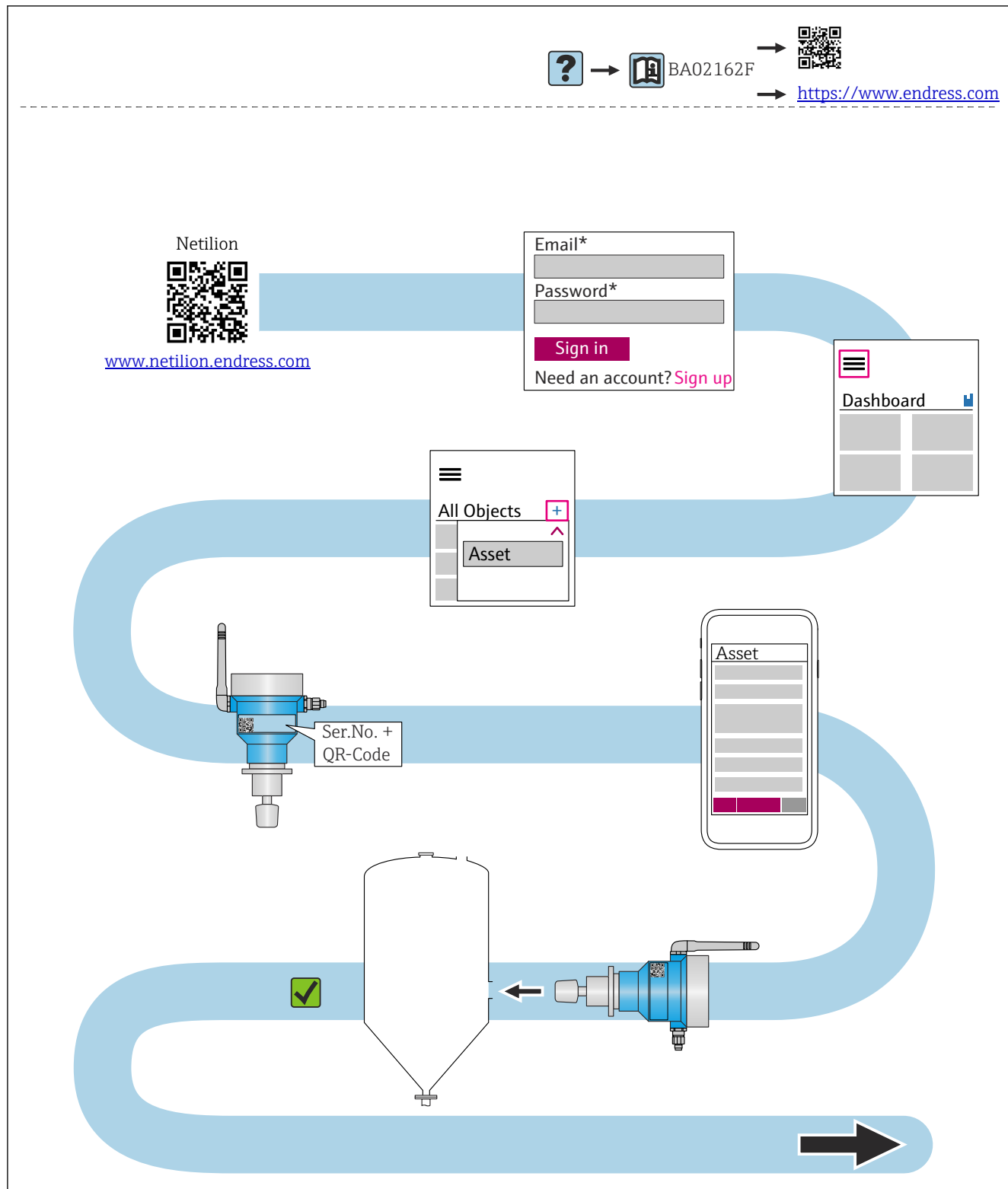


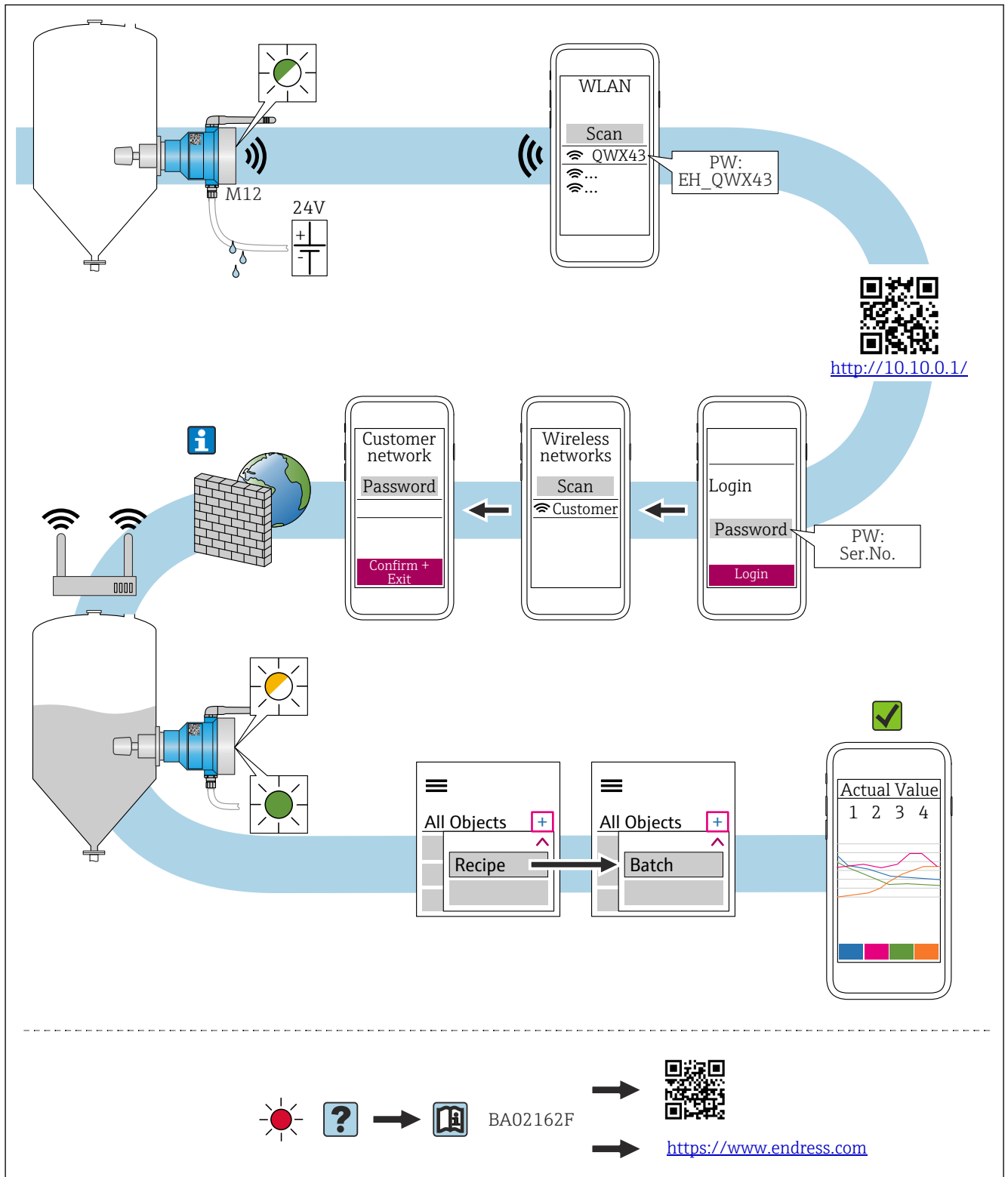

네트워크 구성



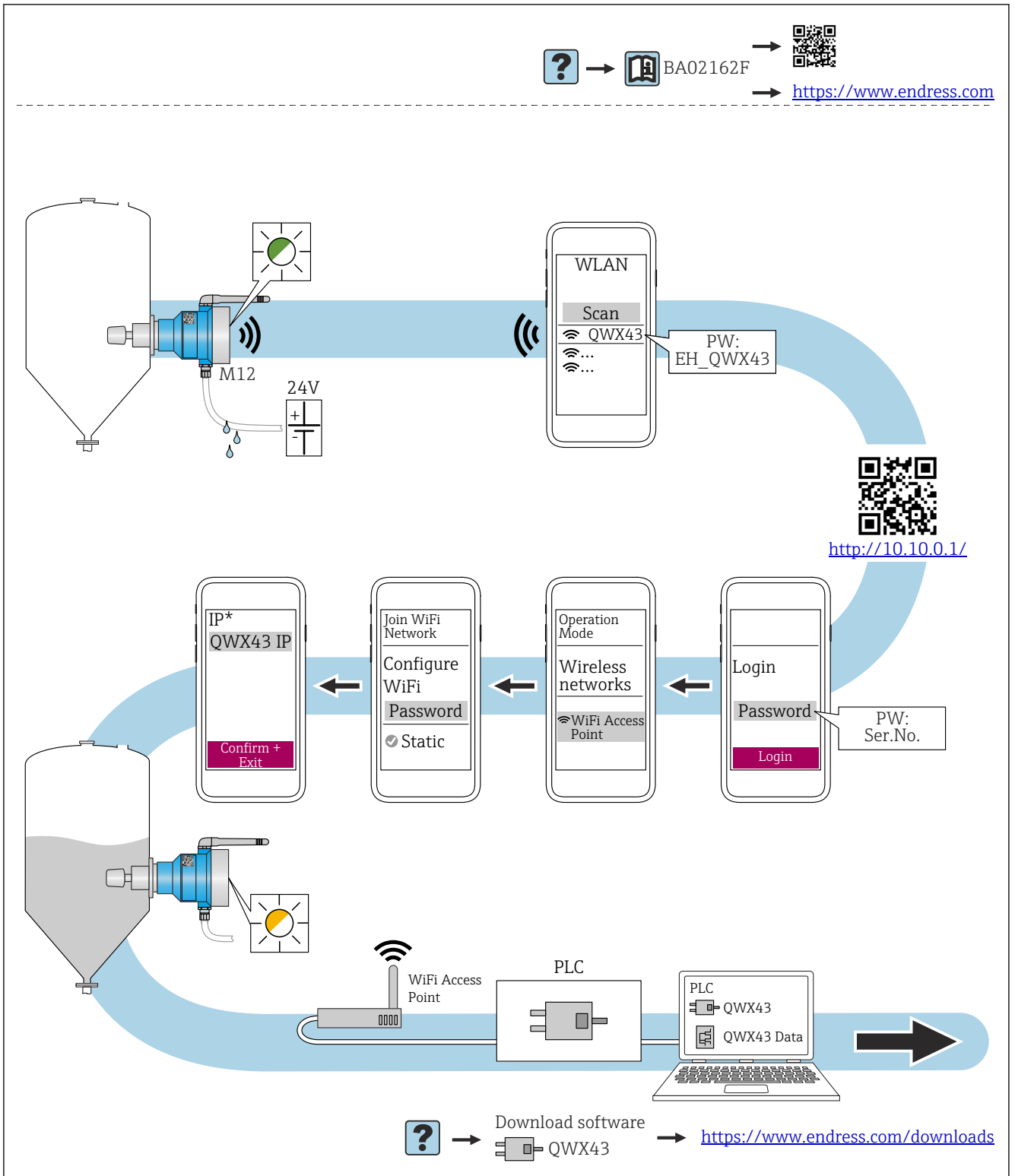
Netilion 연결



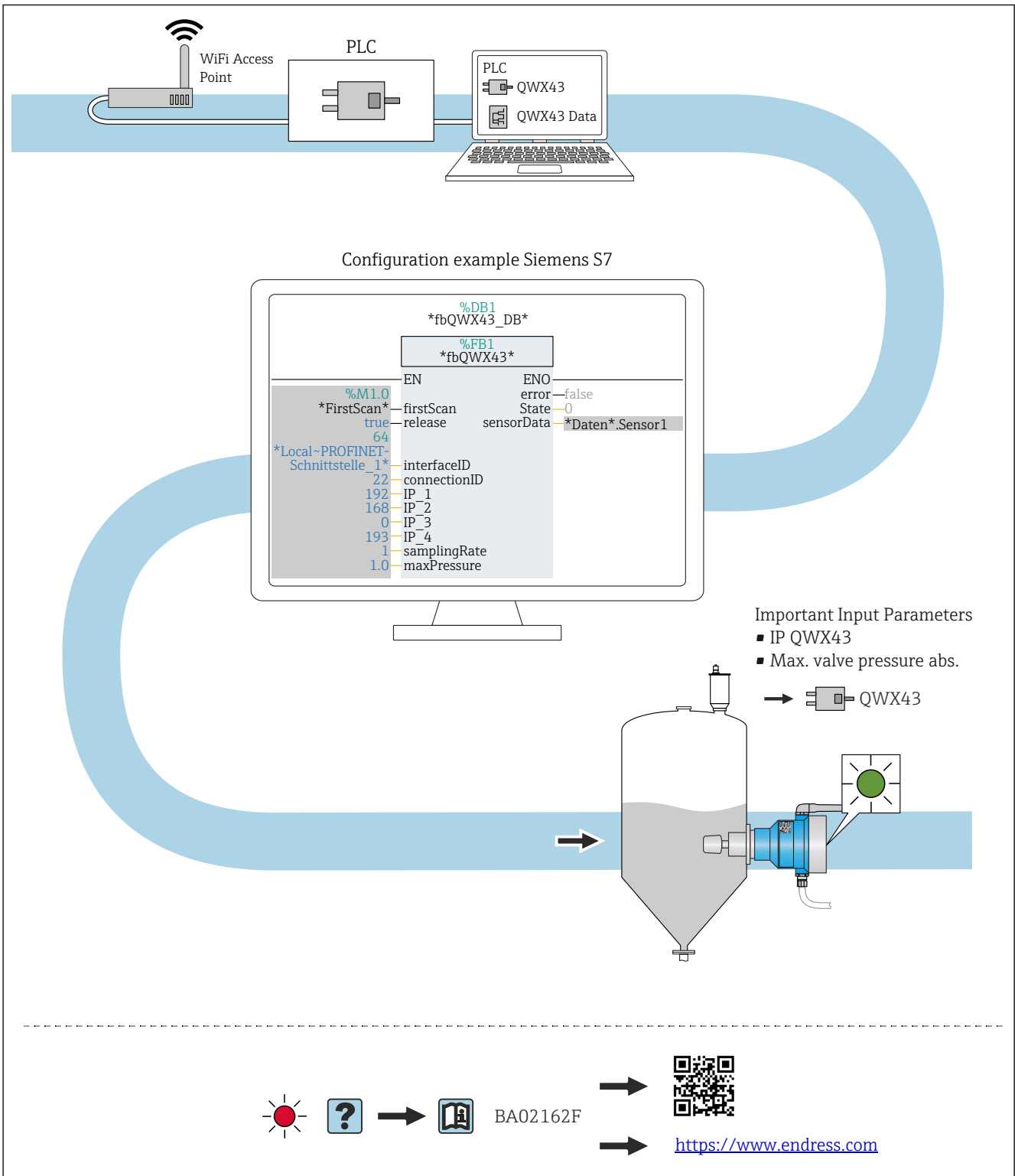

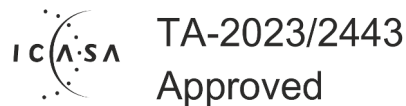
