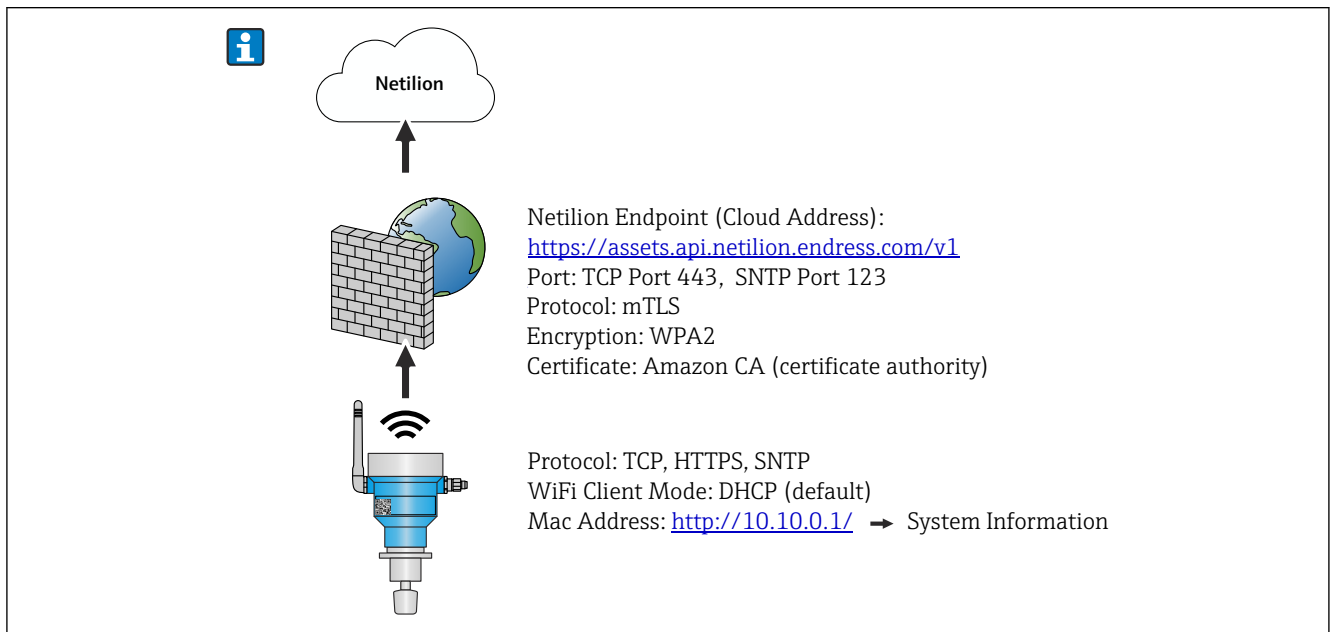

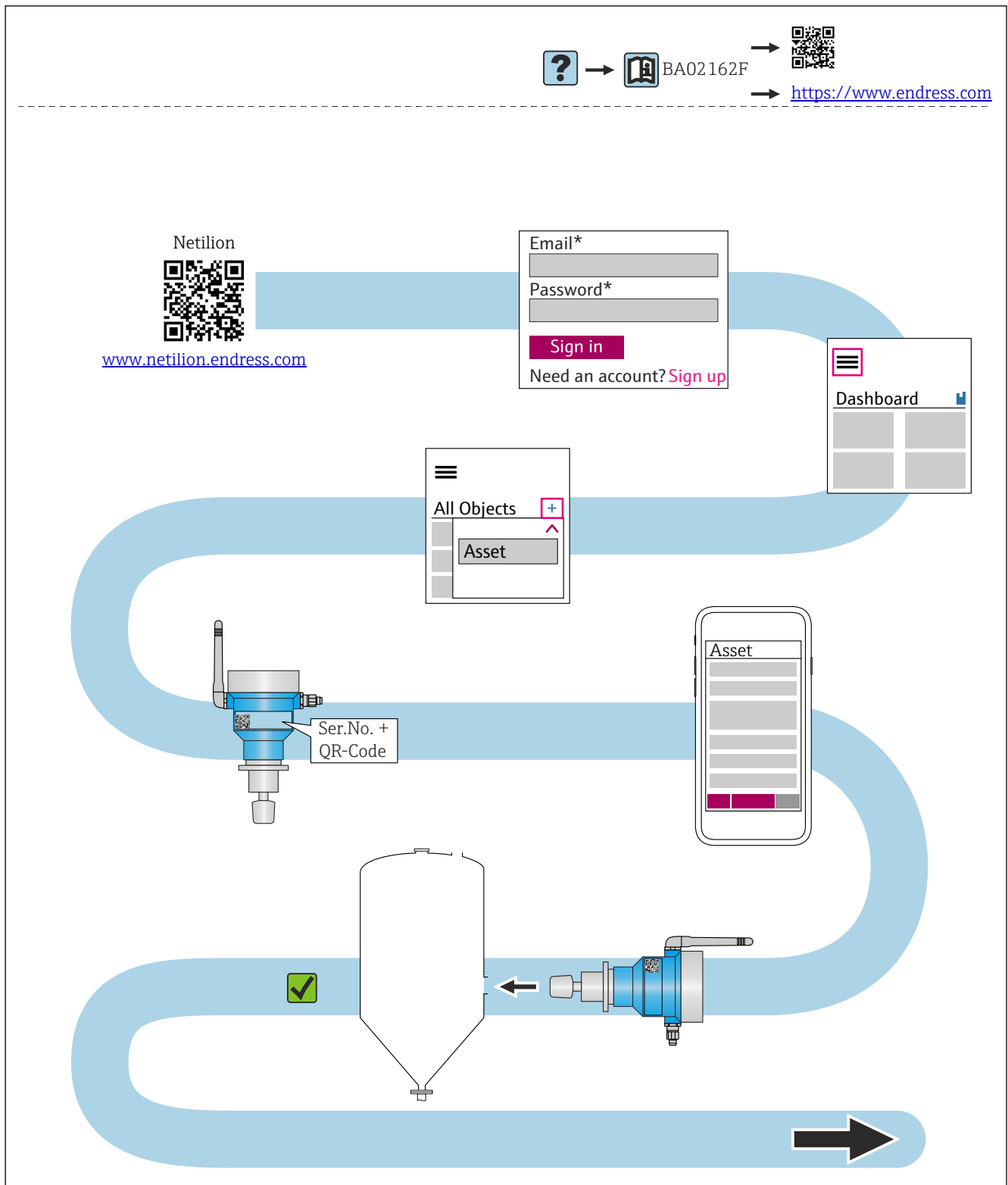

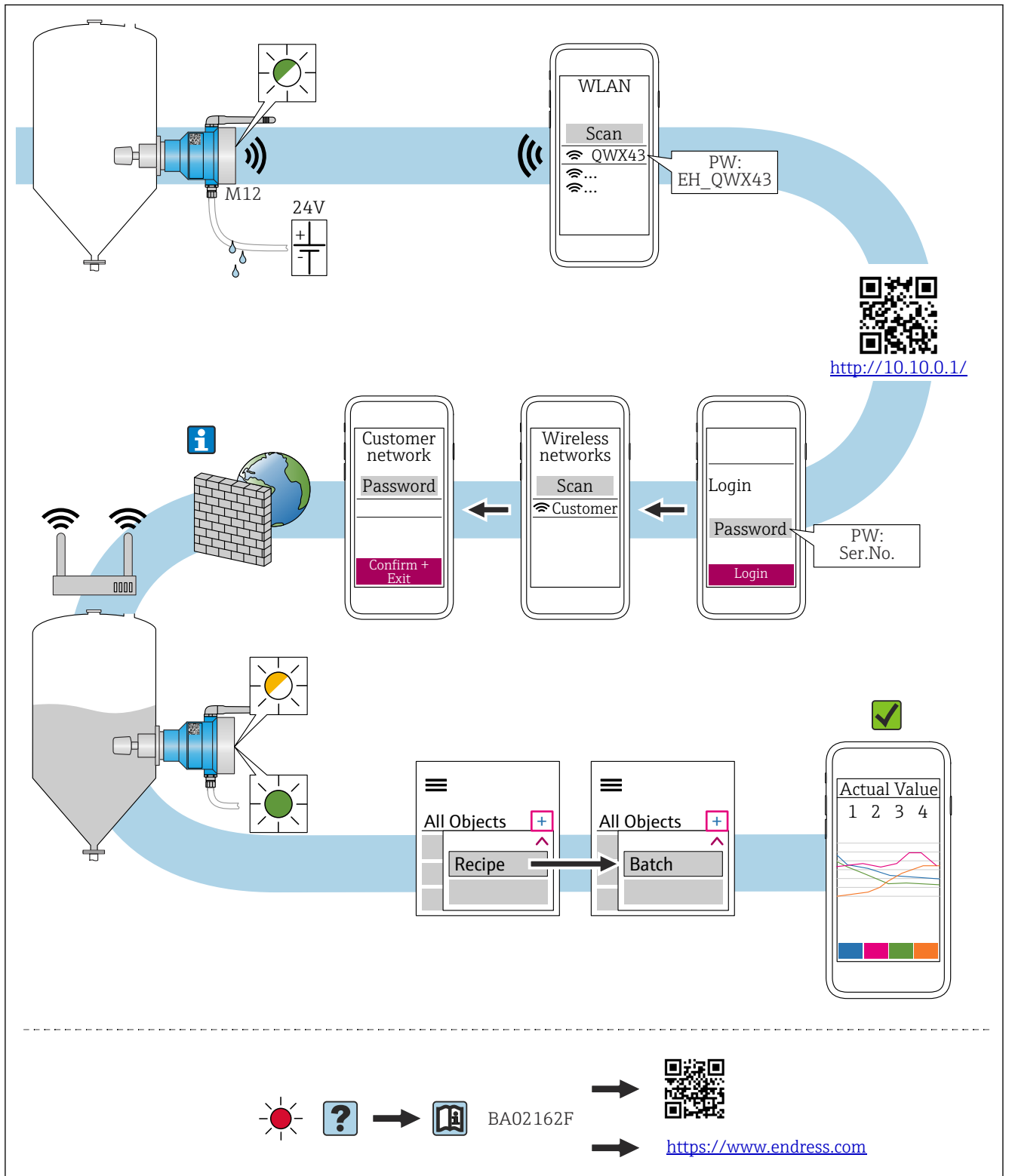
### Netværkskonfiguration

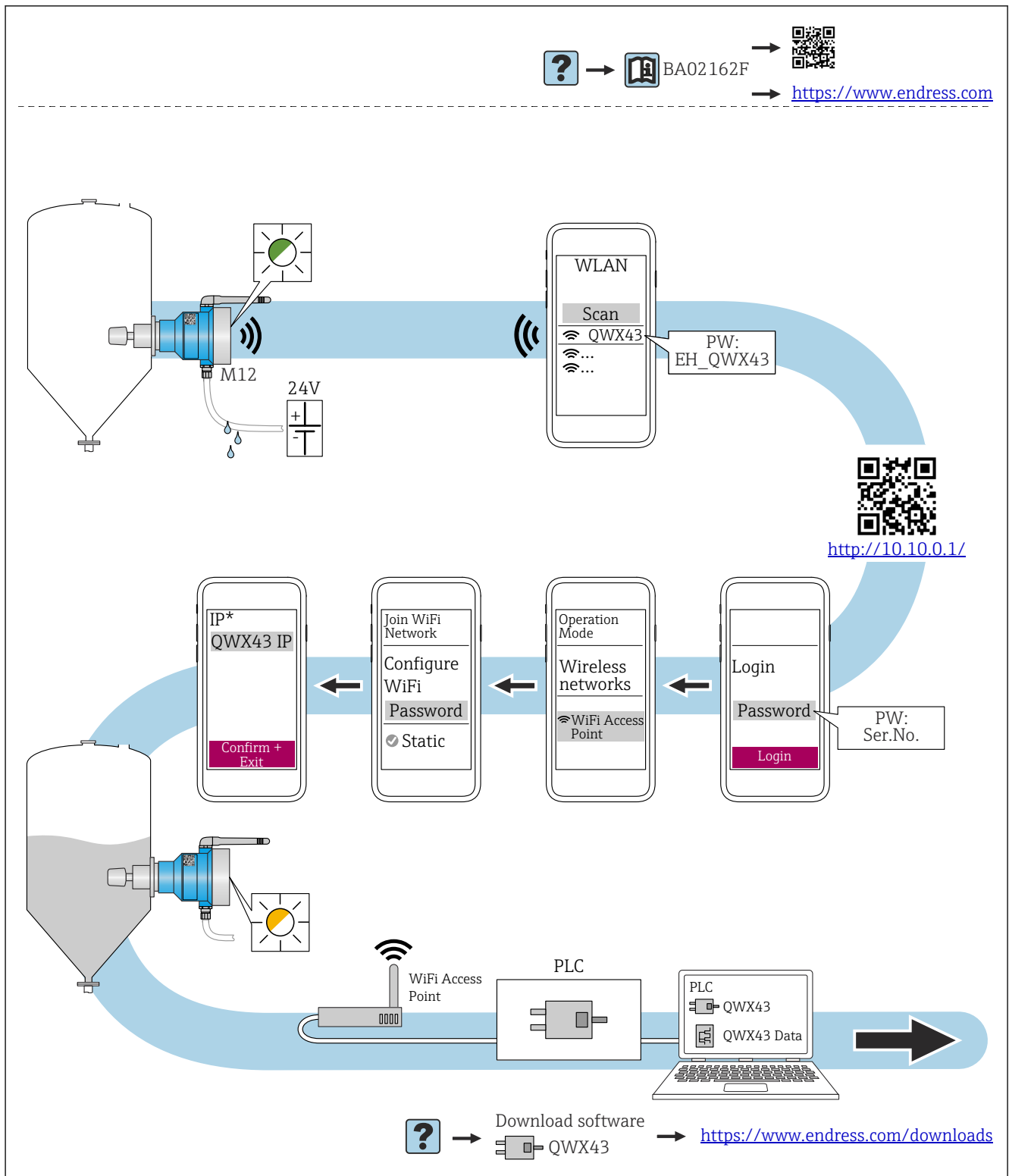

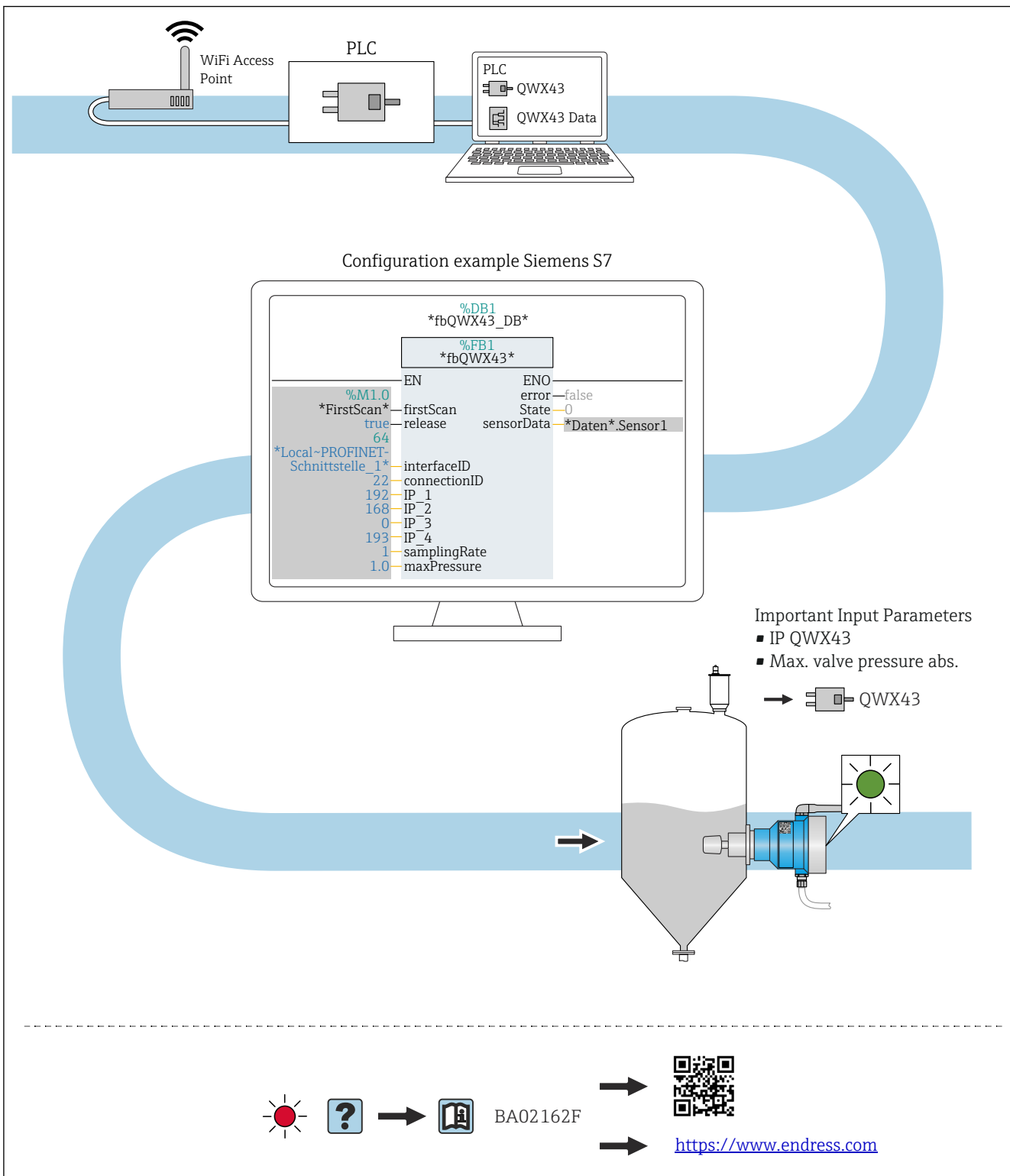
