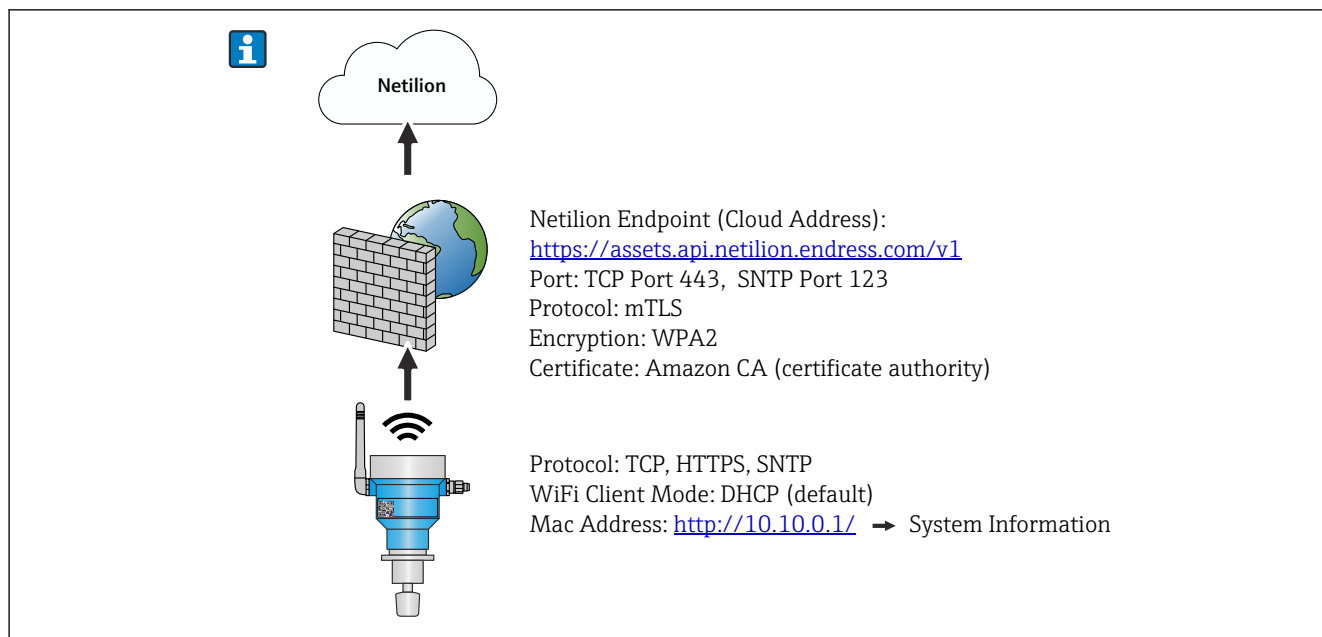

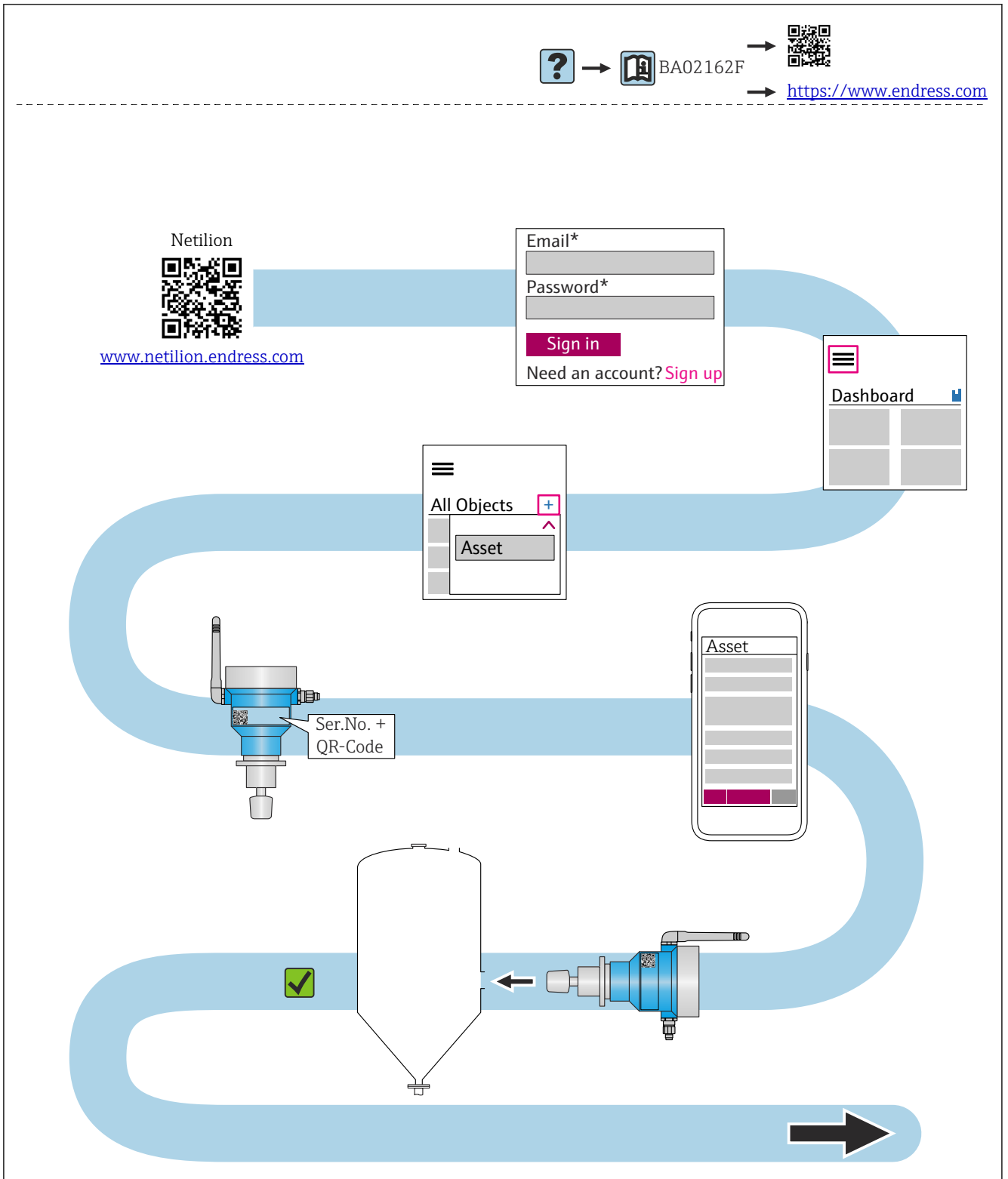

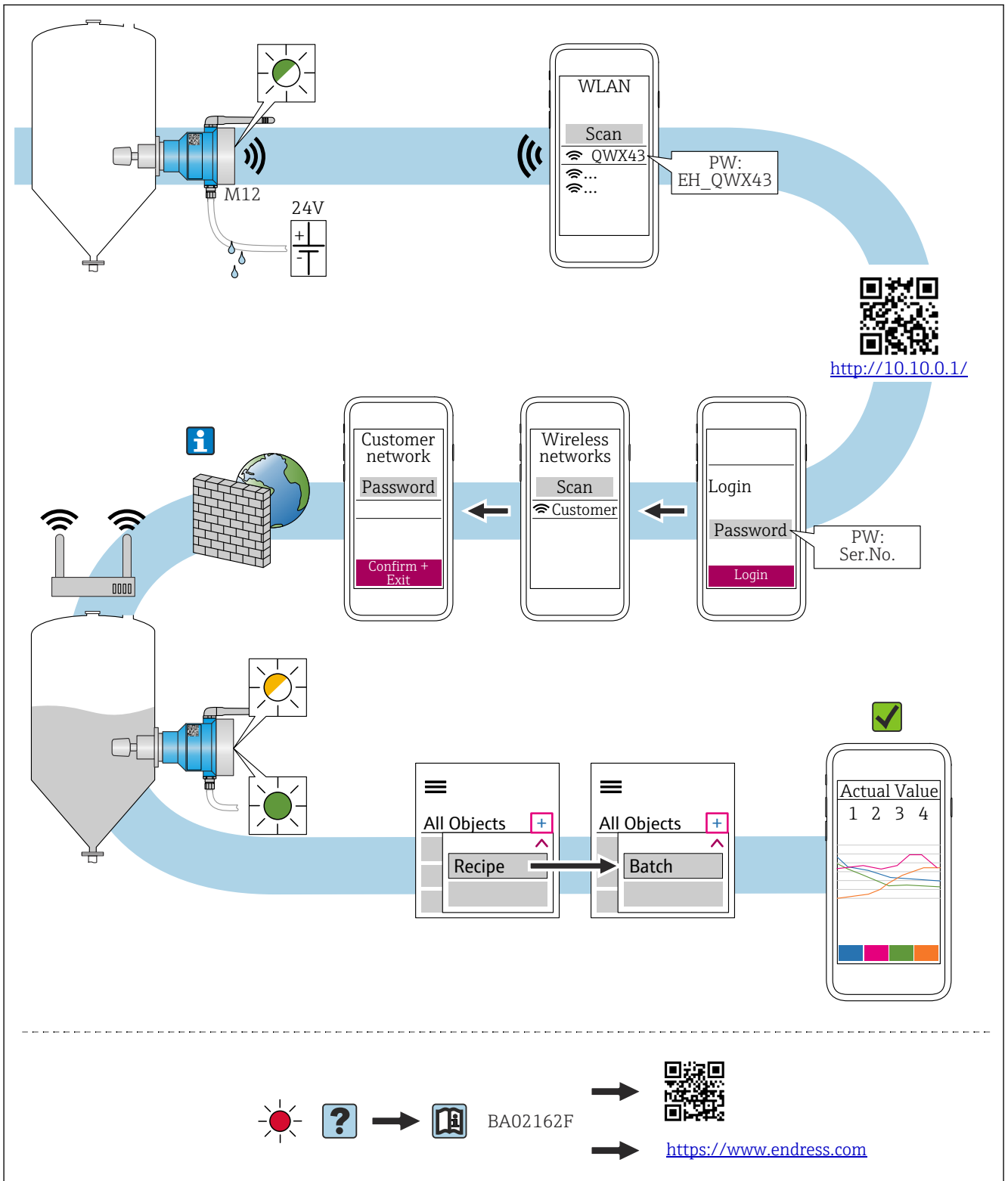
Nastavitev omrežja

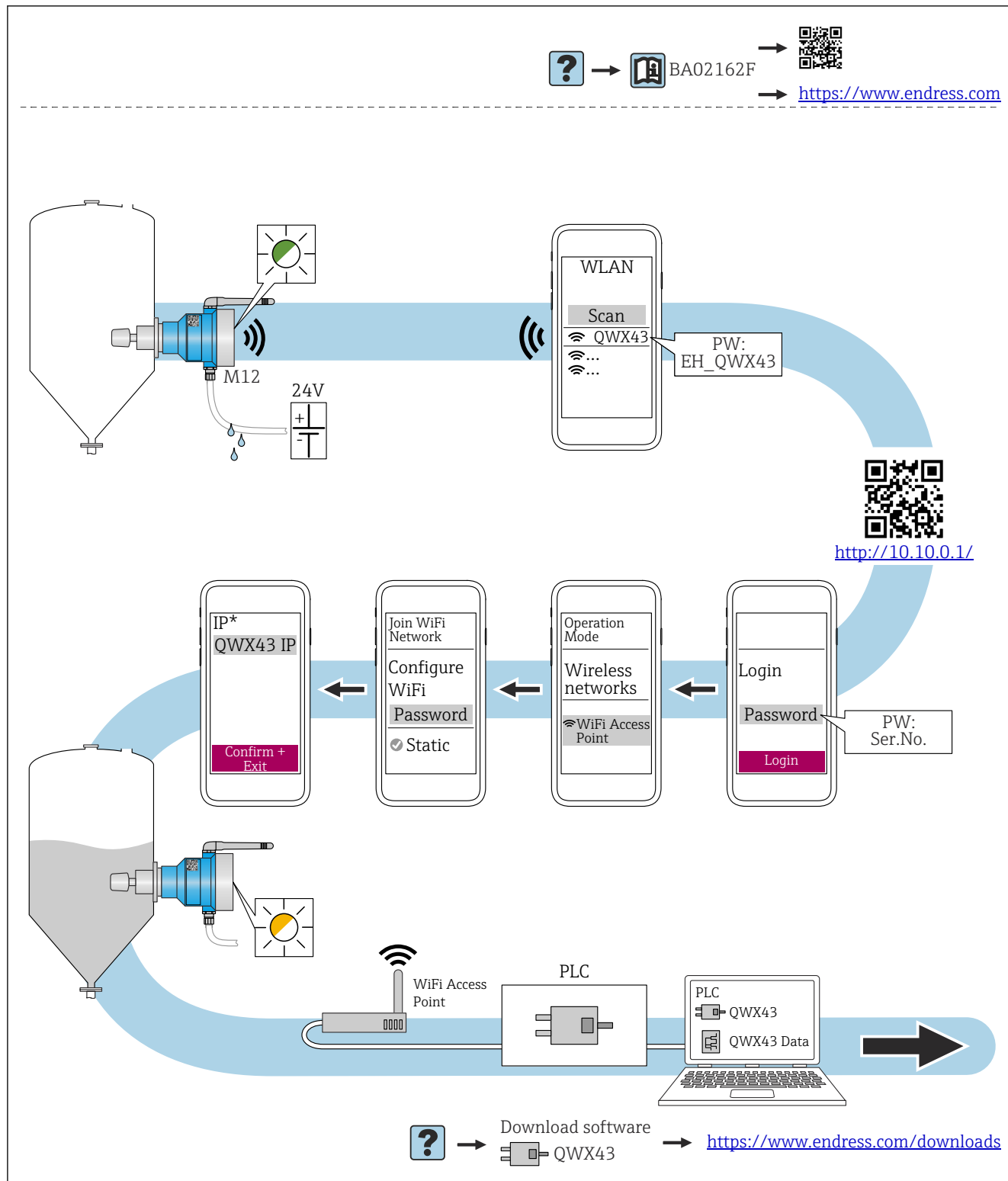

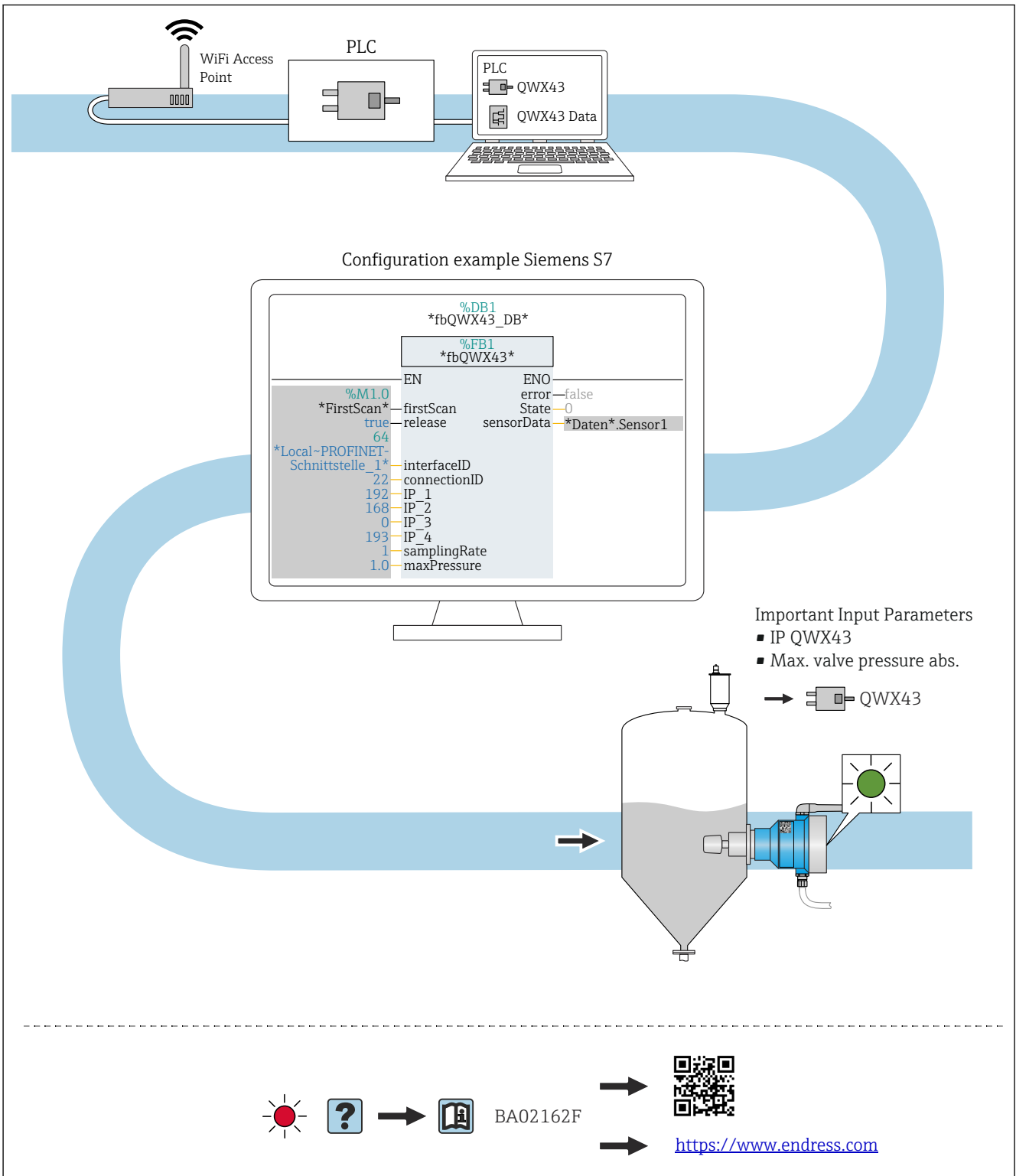

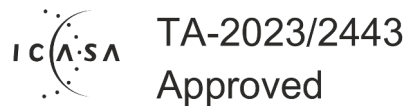
