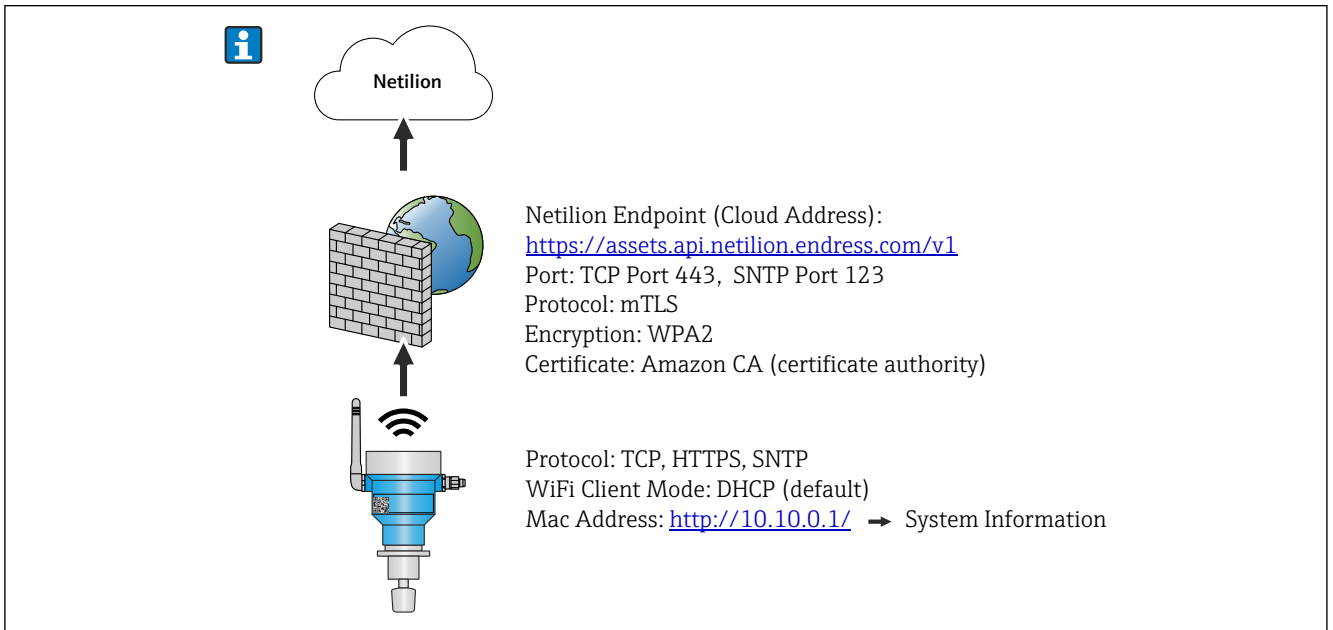

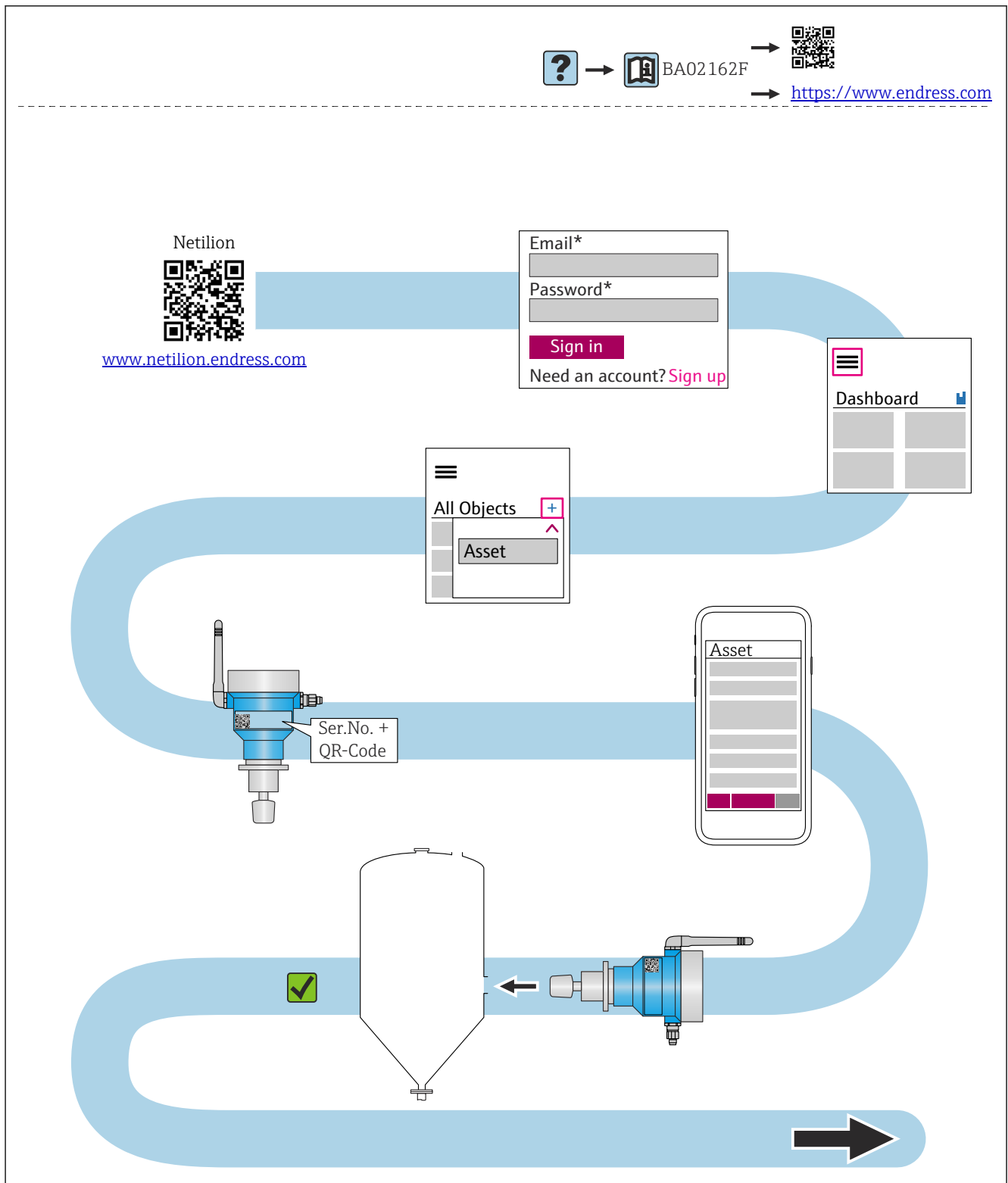

Hálózati konfiguráció

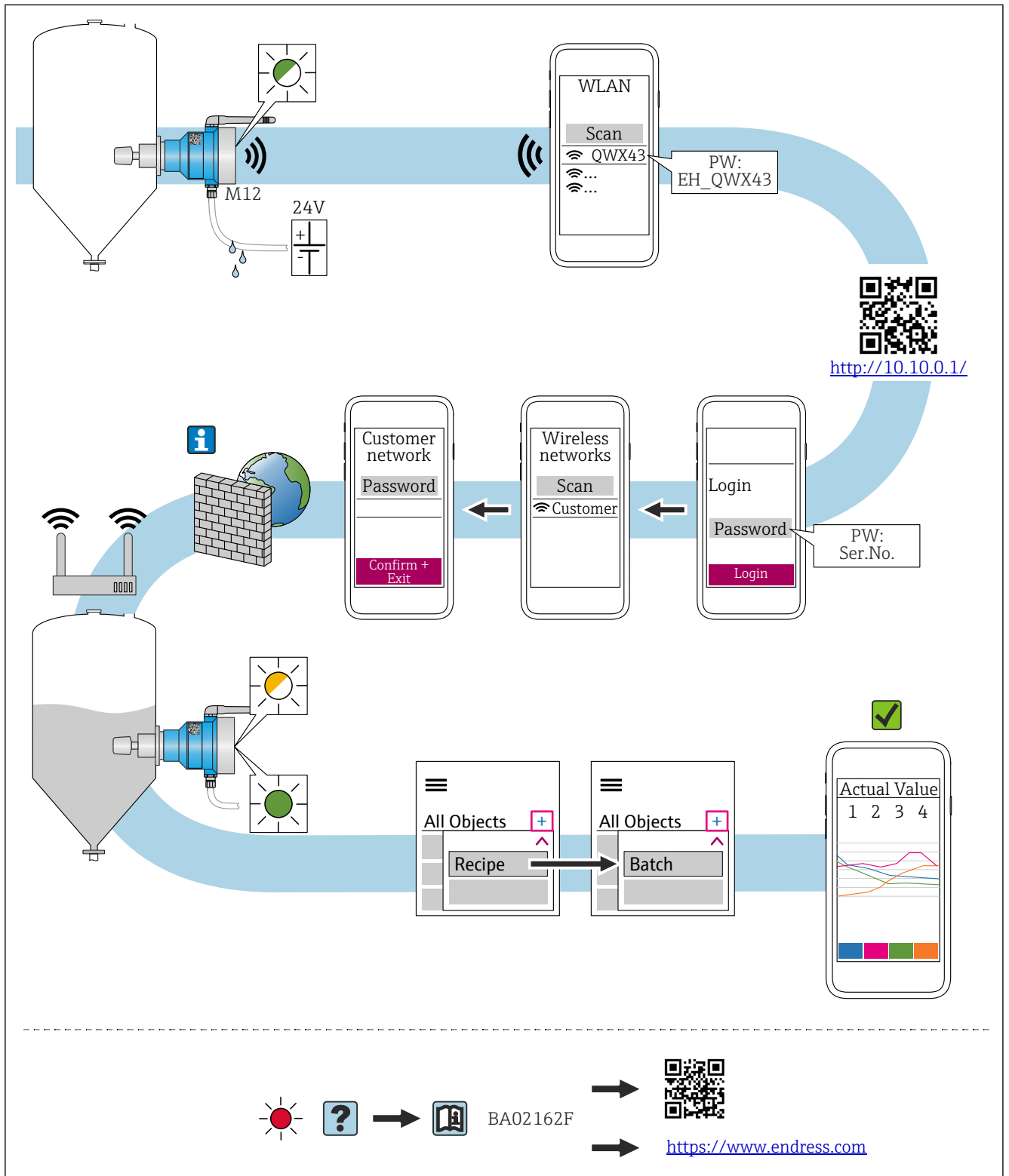

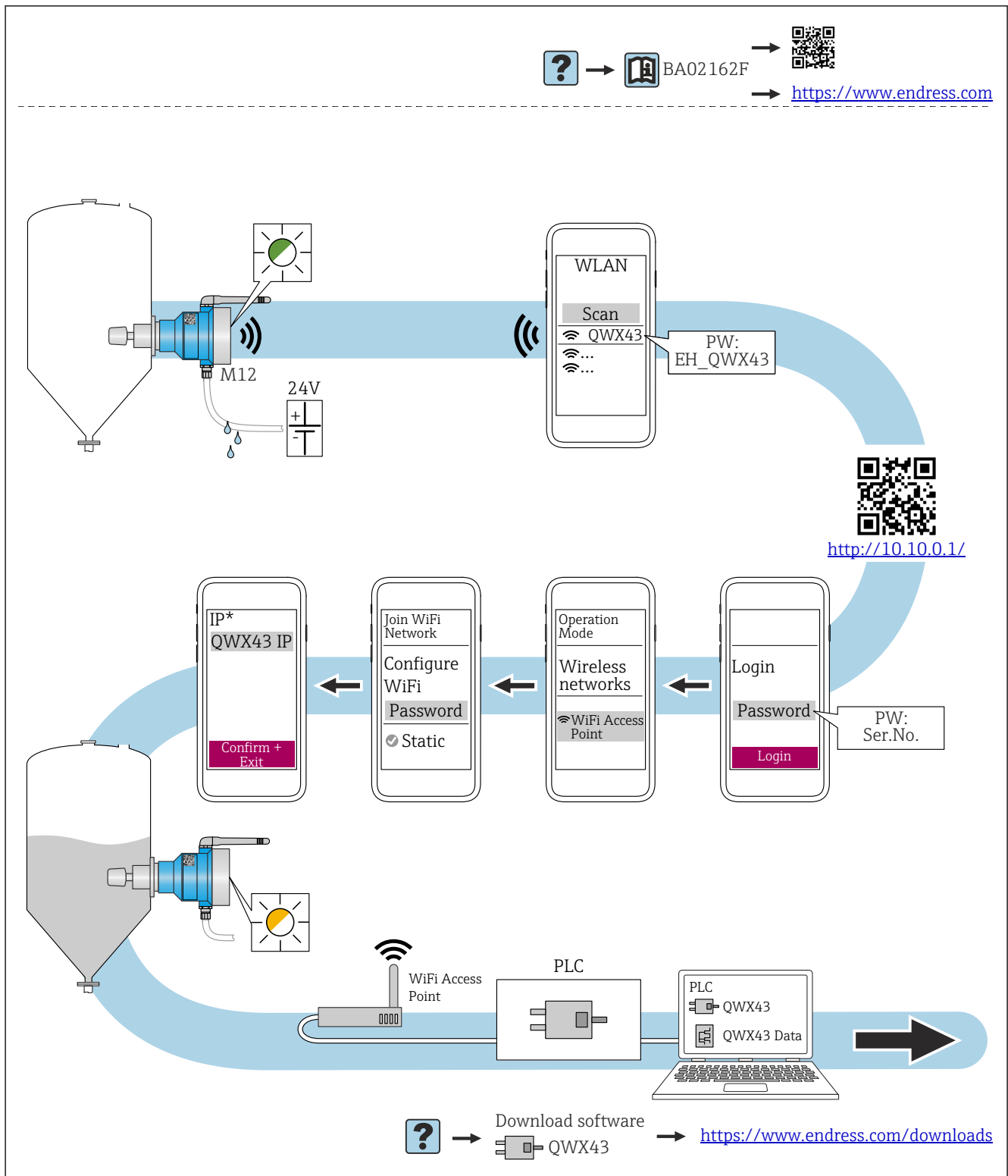

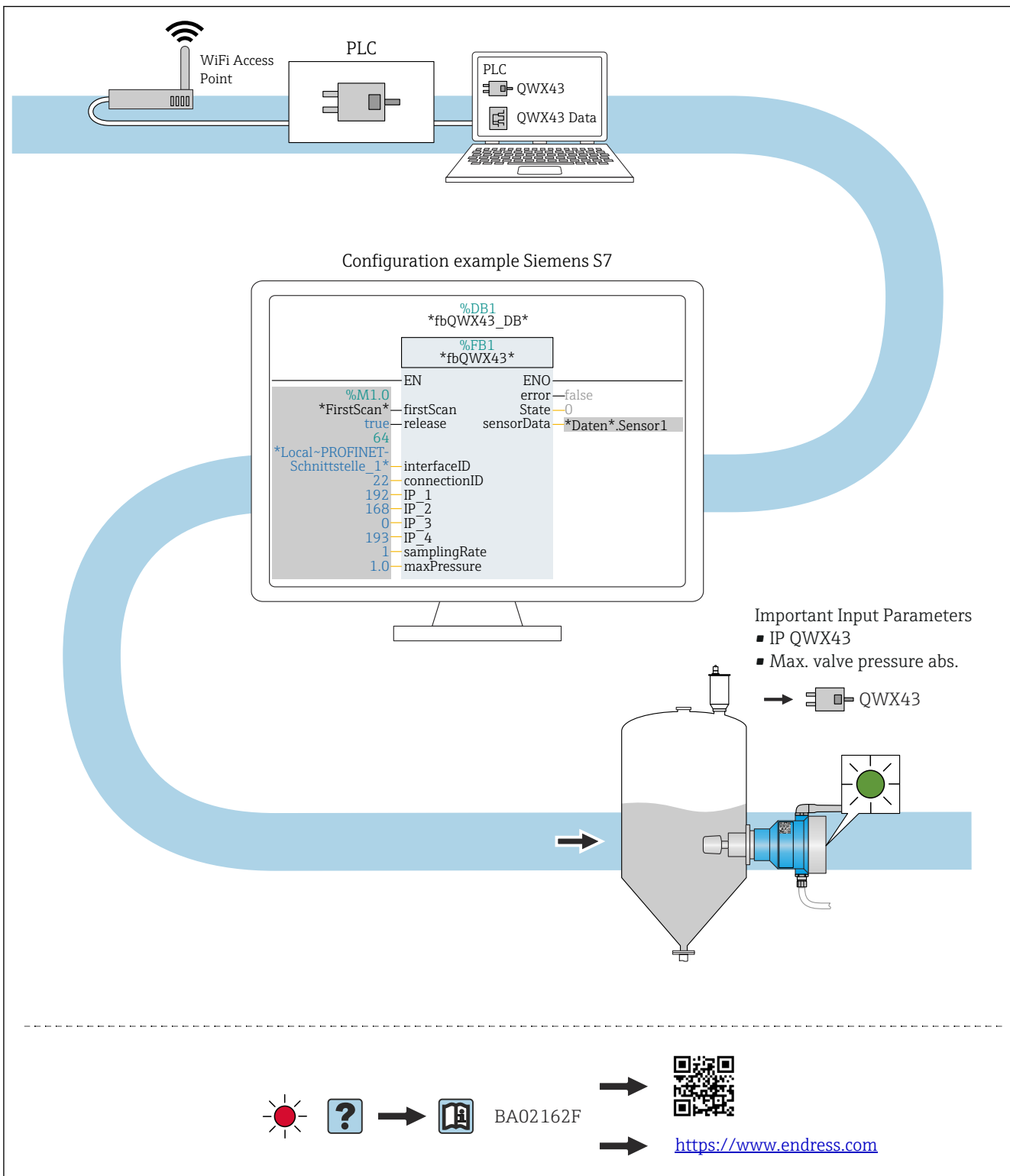
