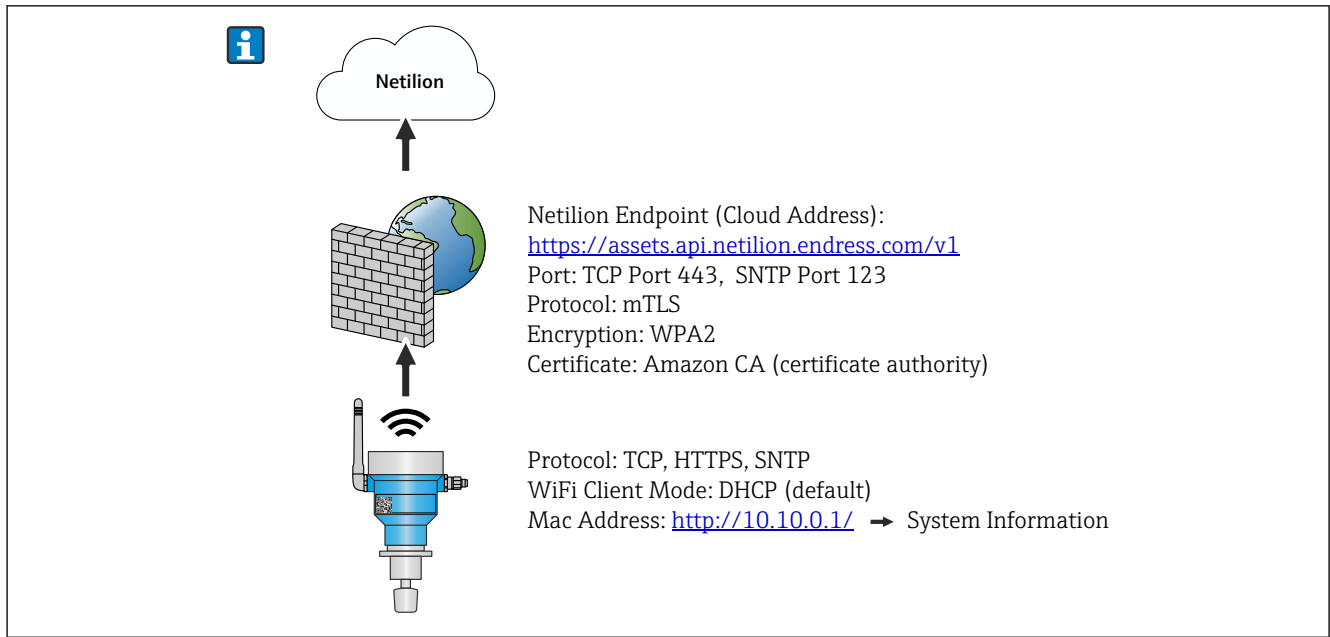

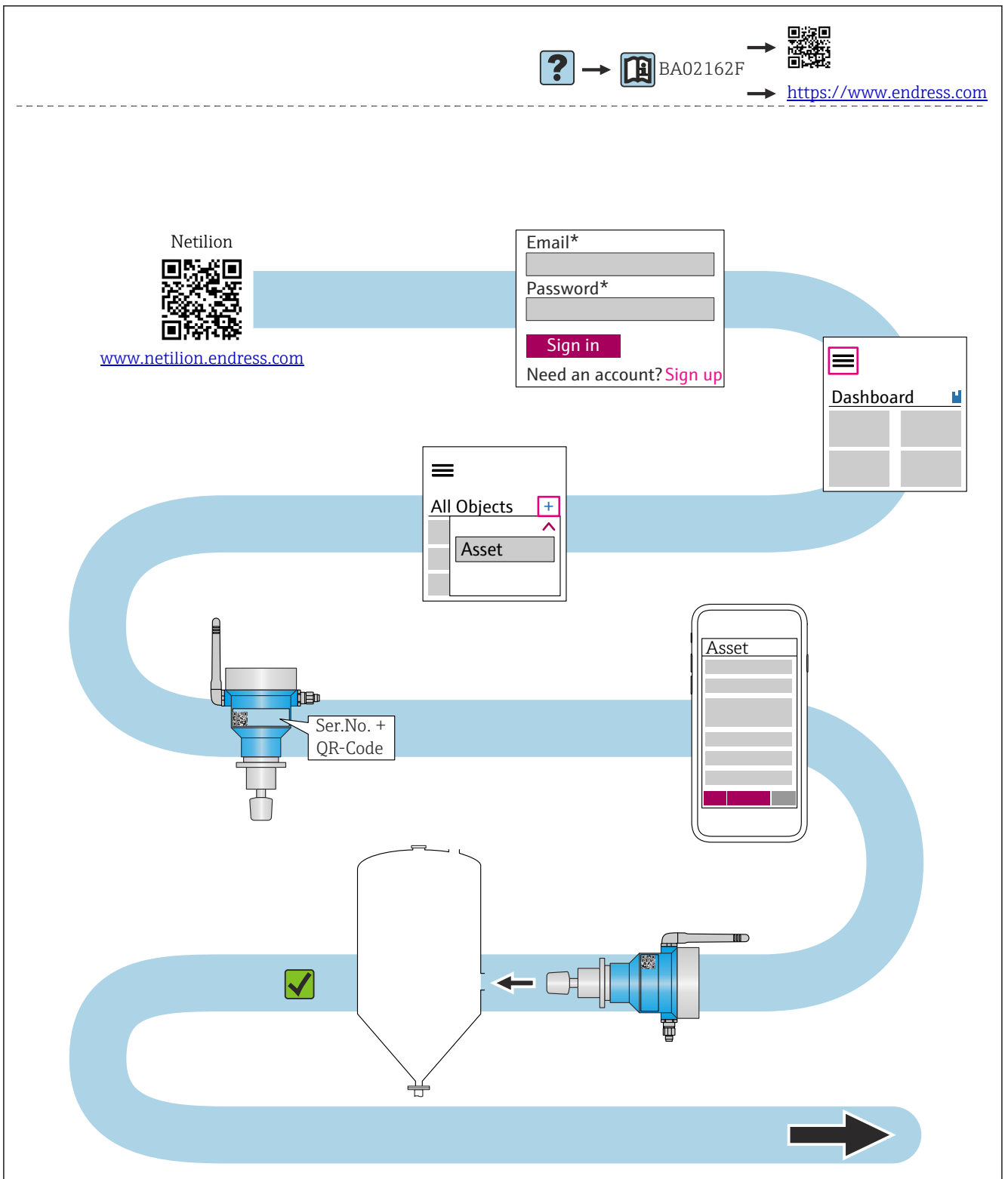

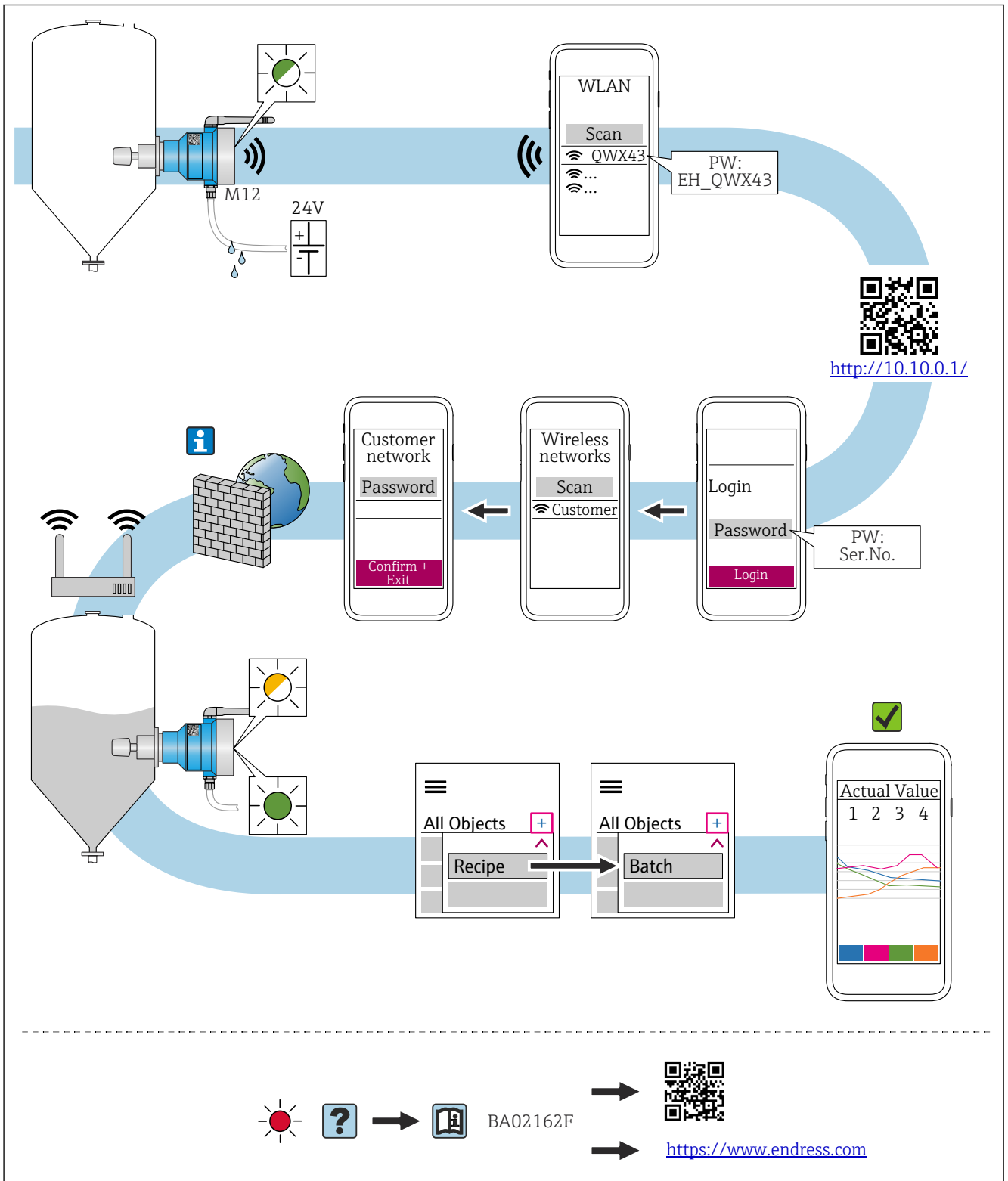
Network configuration



Conexión Netilion

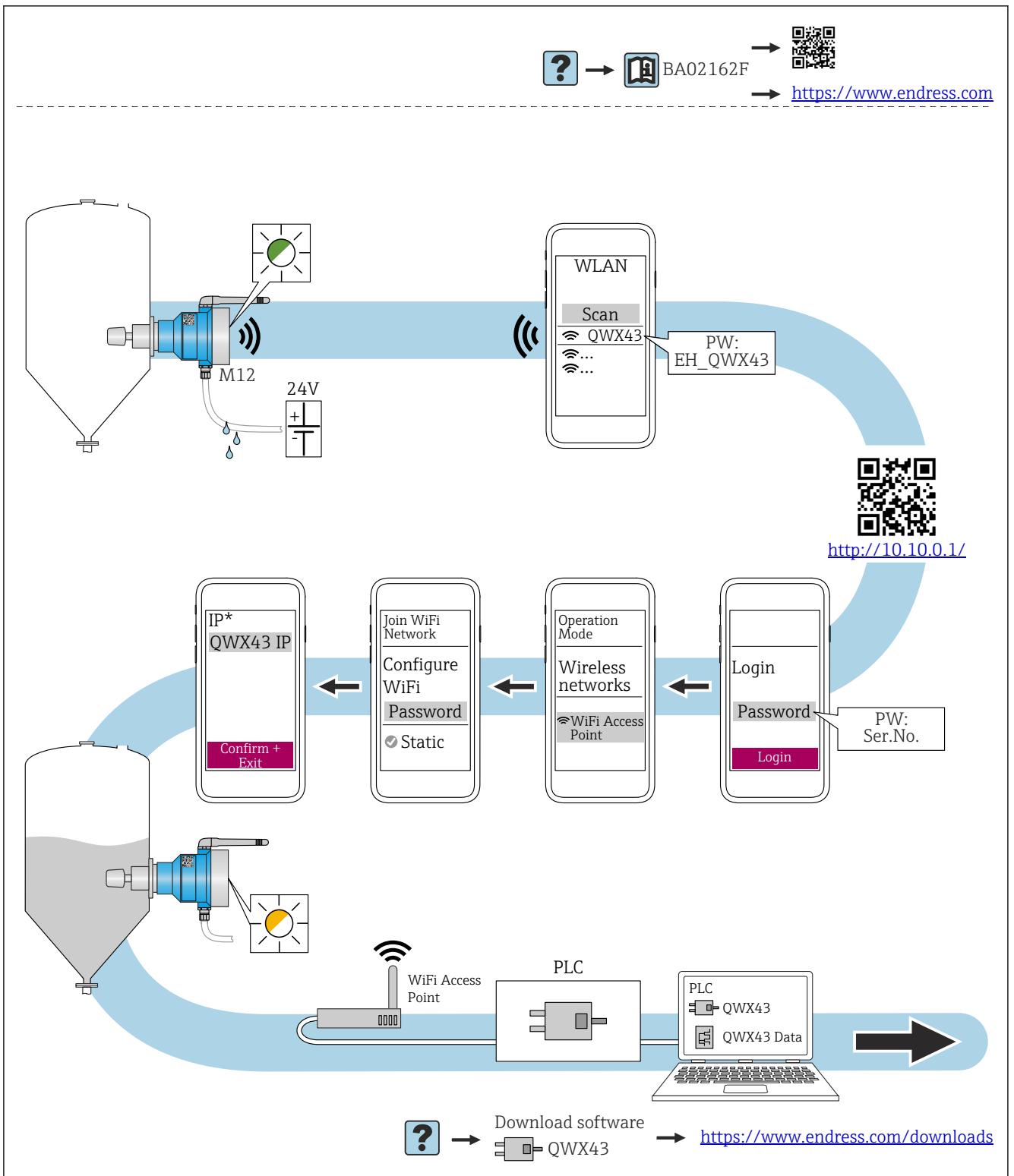

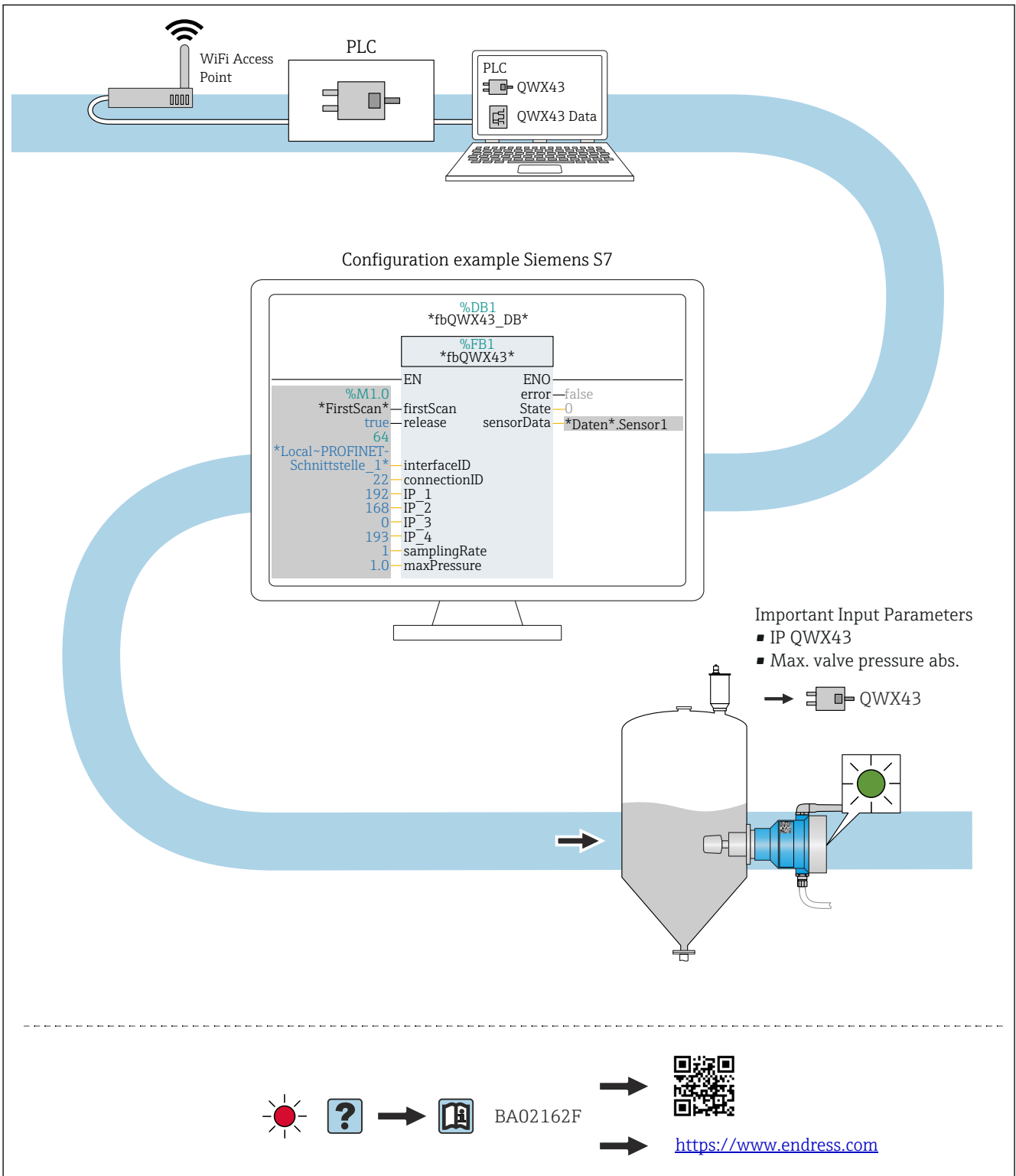

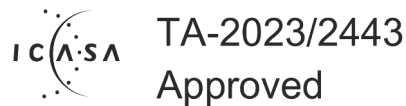
