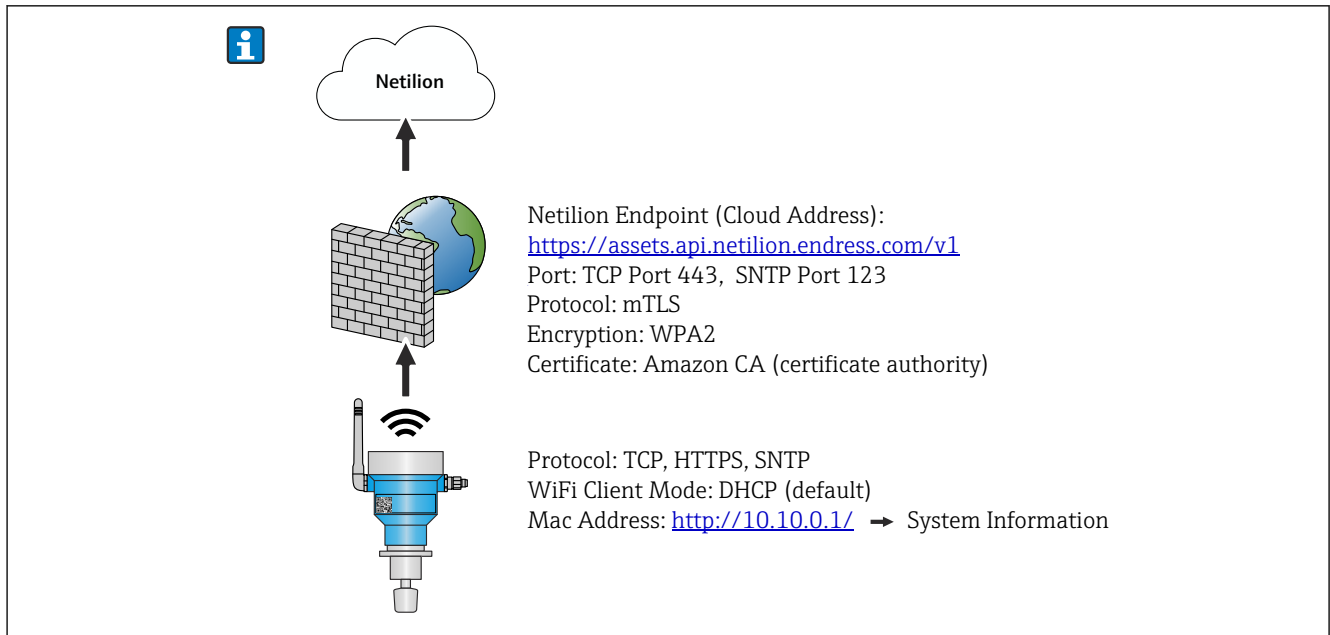

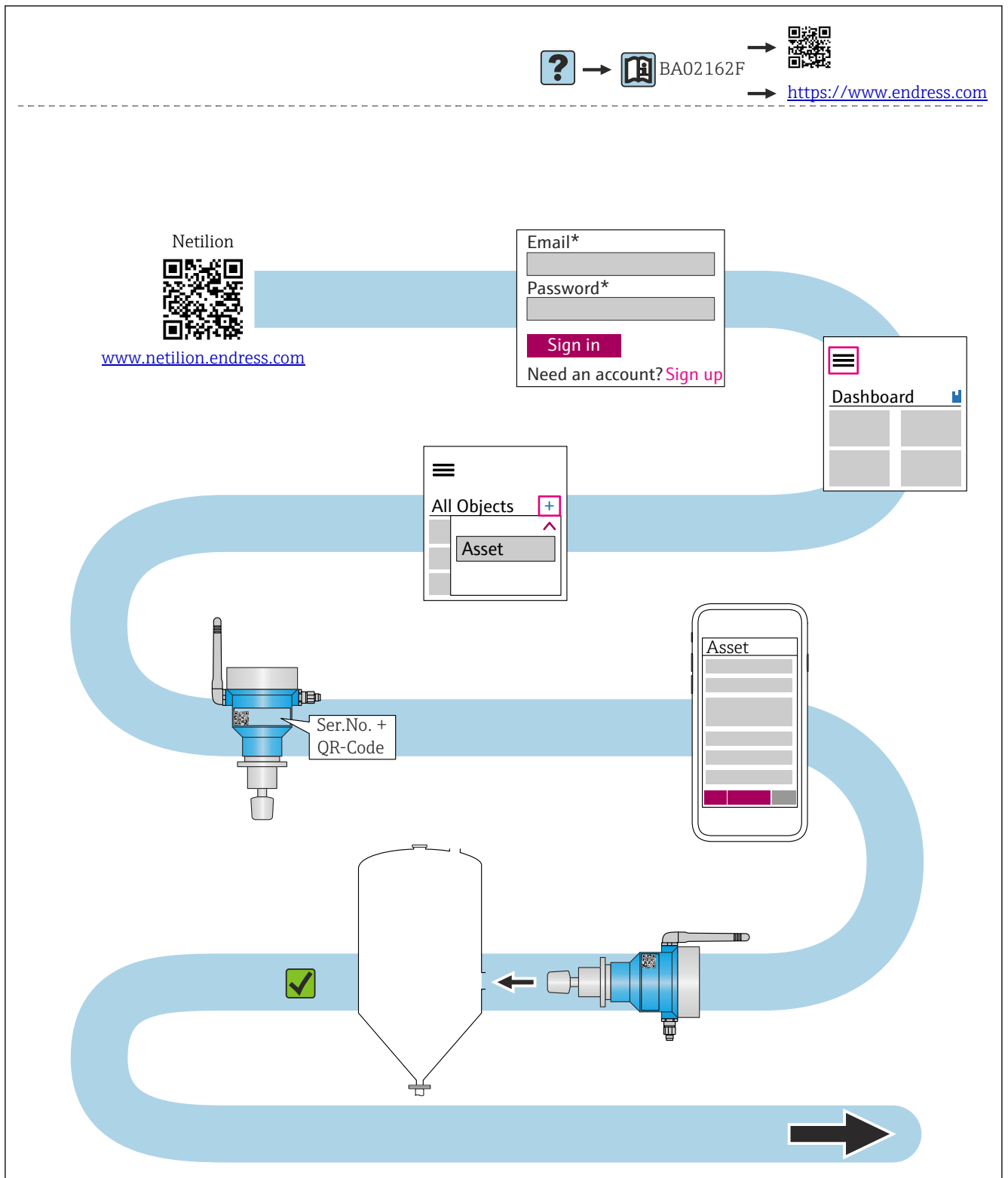

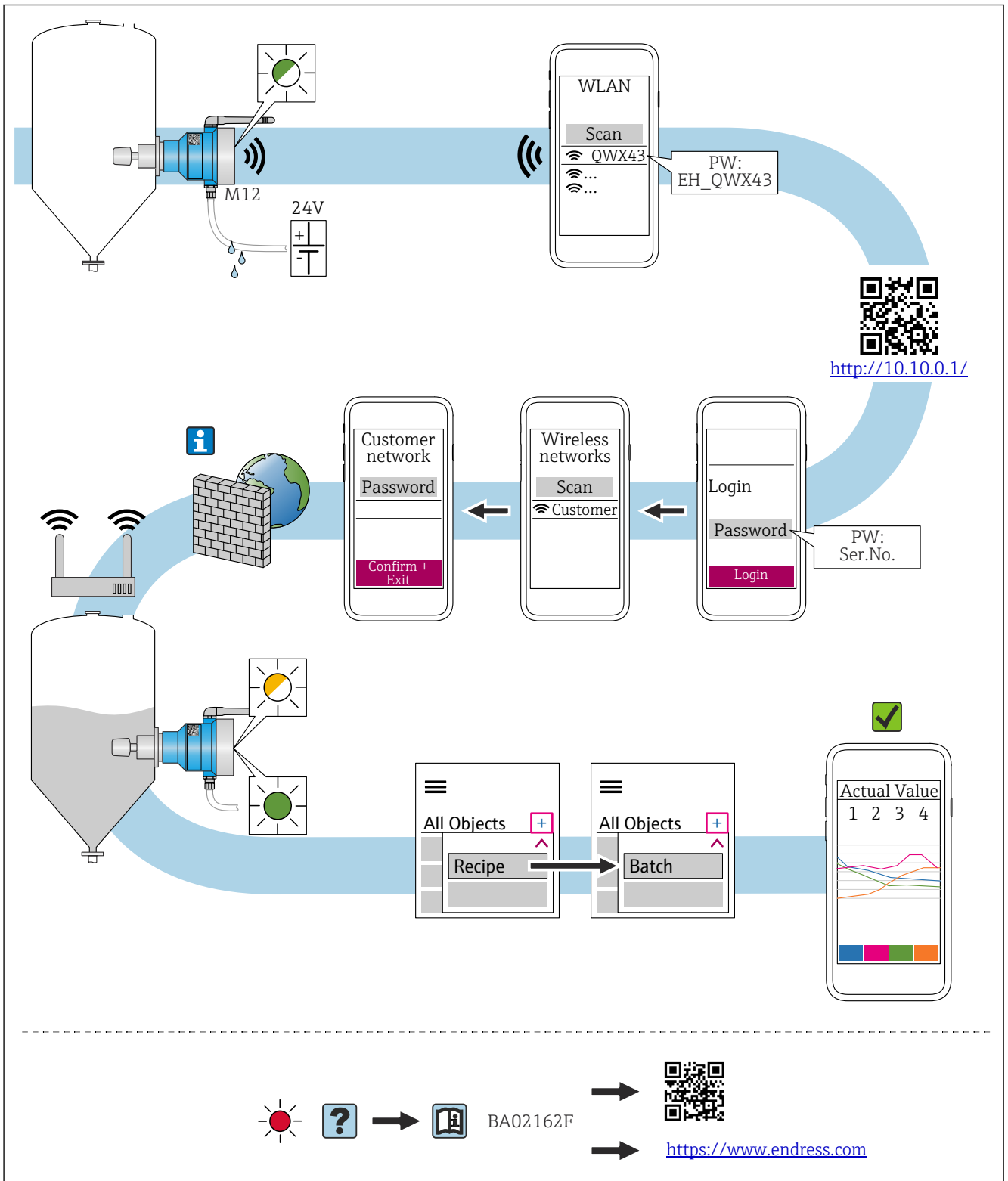
## Netwerkconfiguratie



# Netilion-verbinding

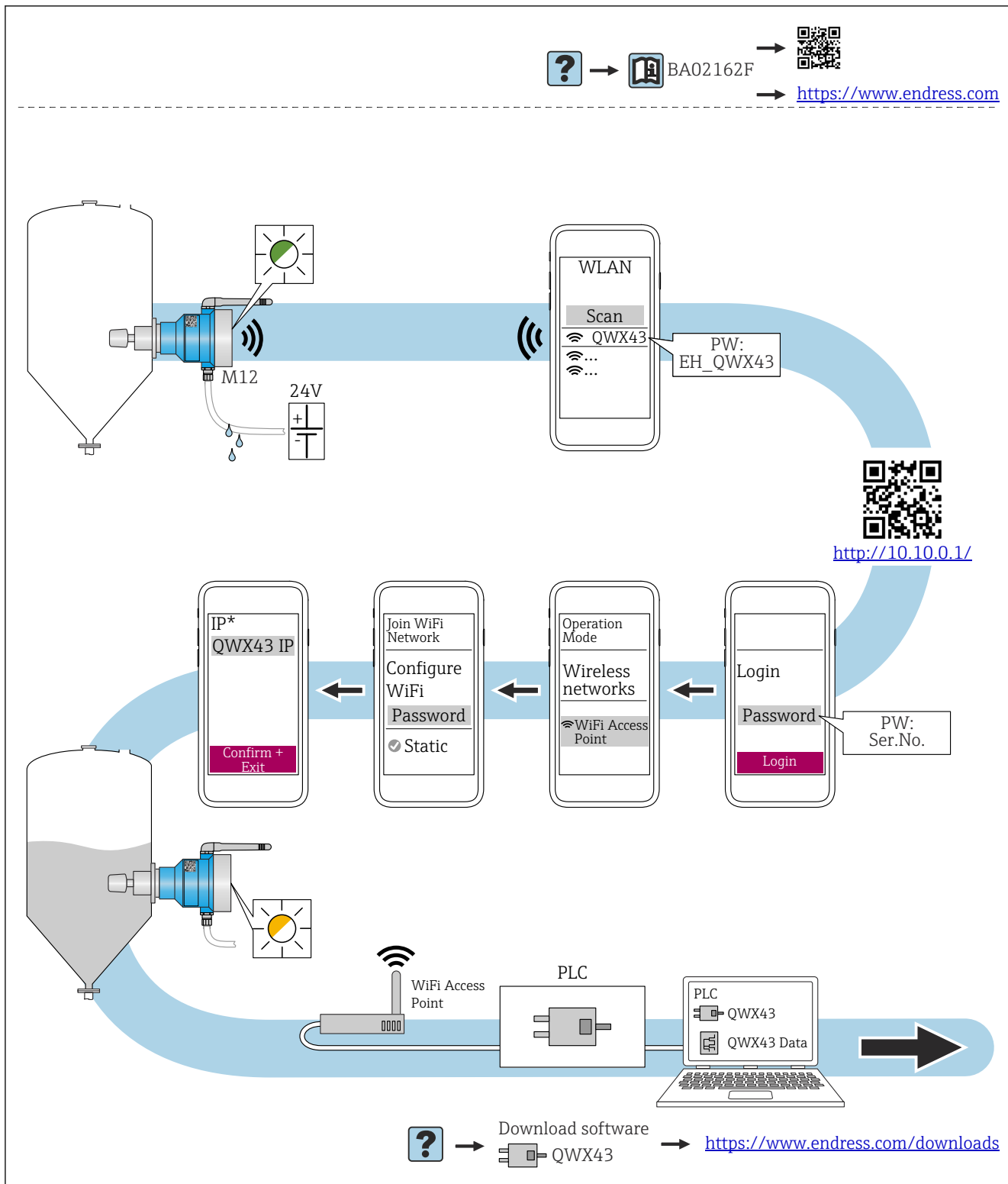

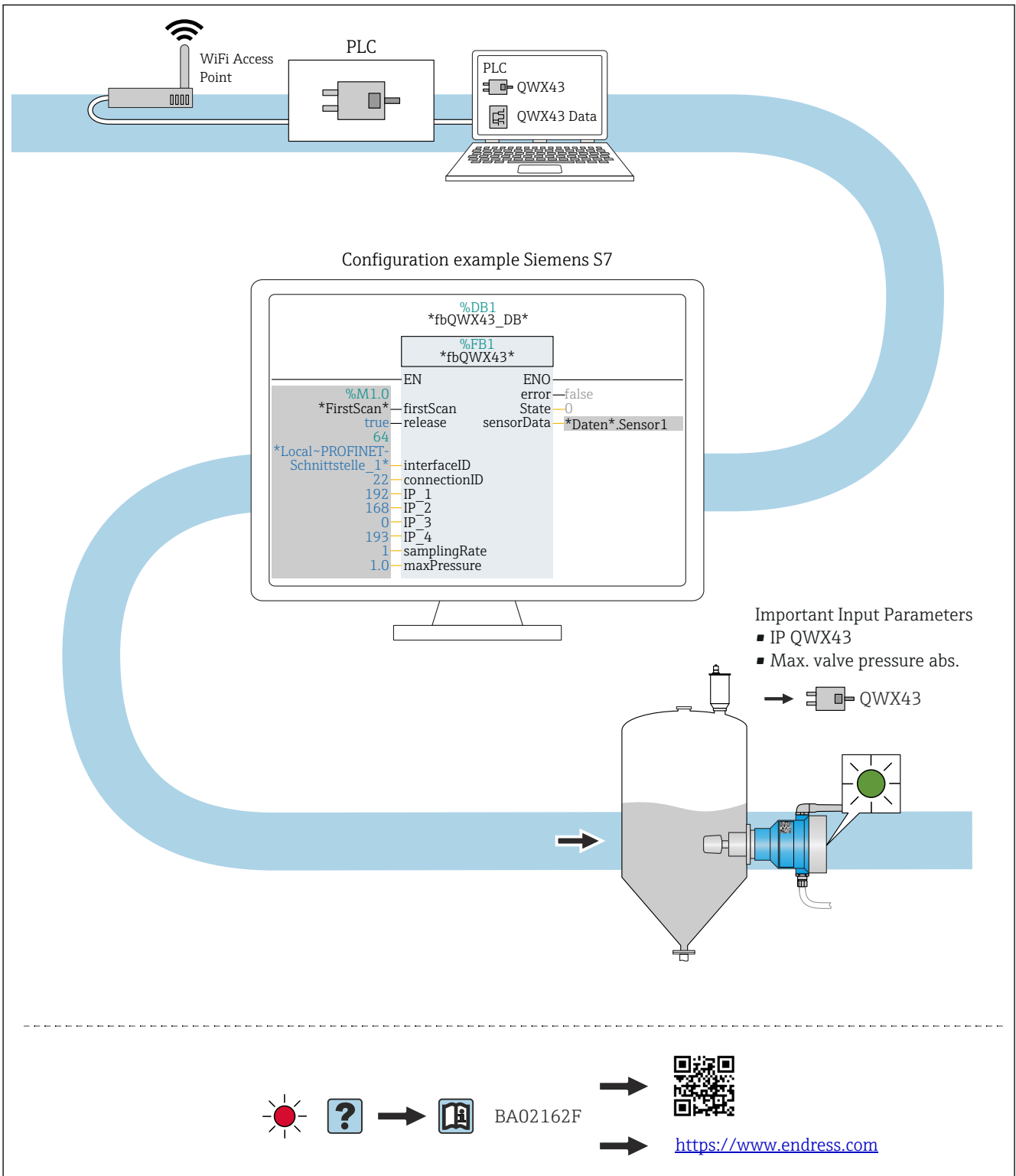

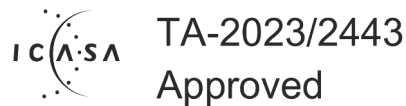
