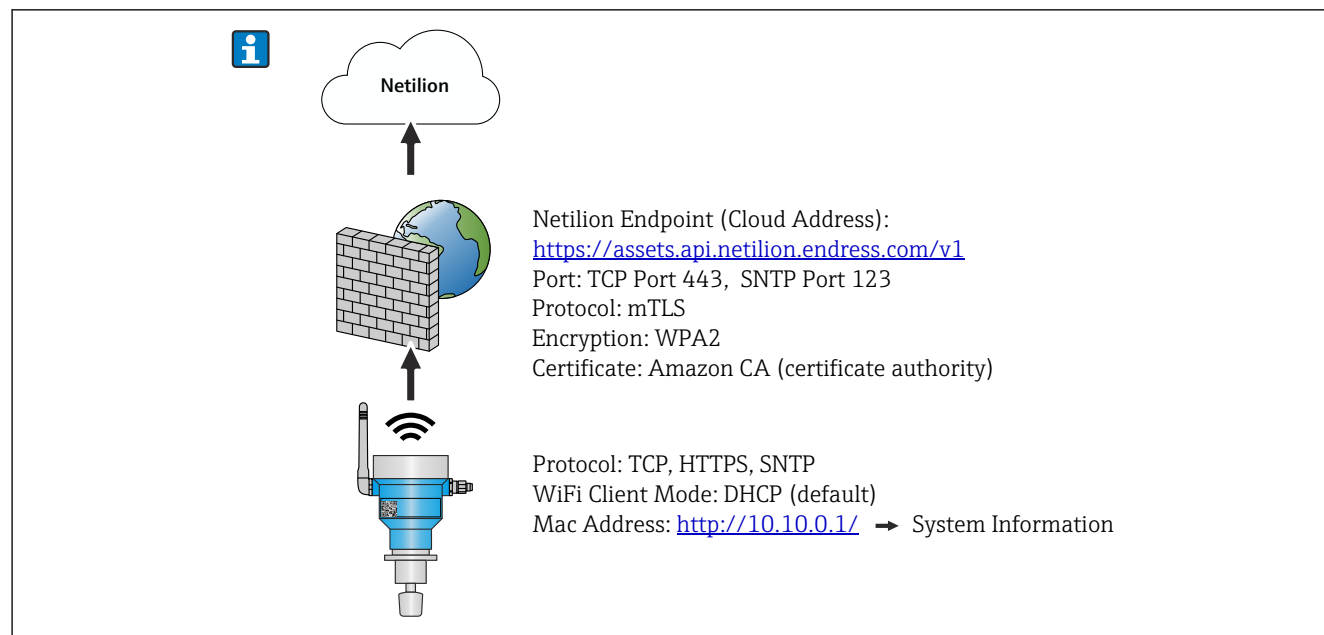

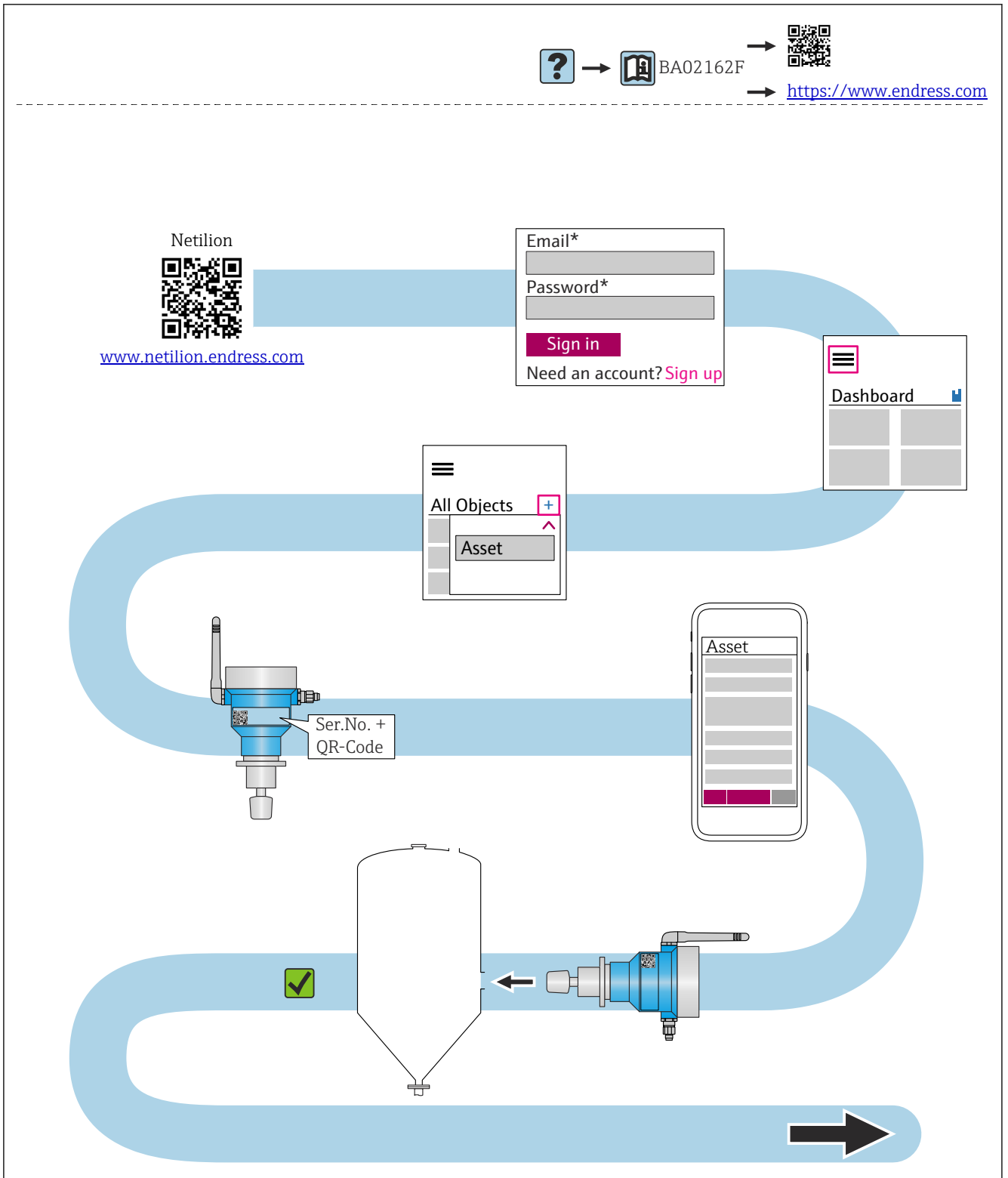

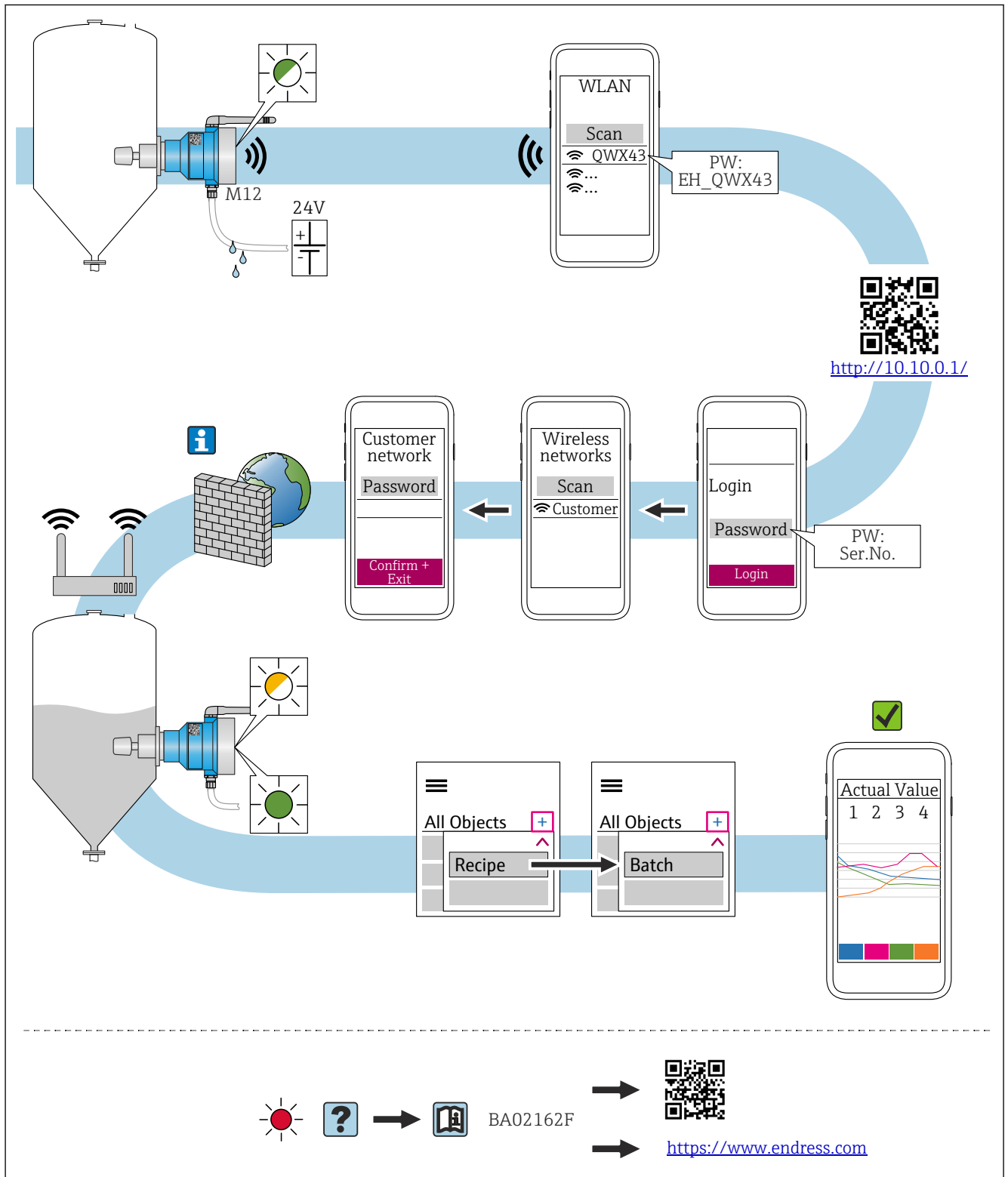
ネットワーク設定

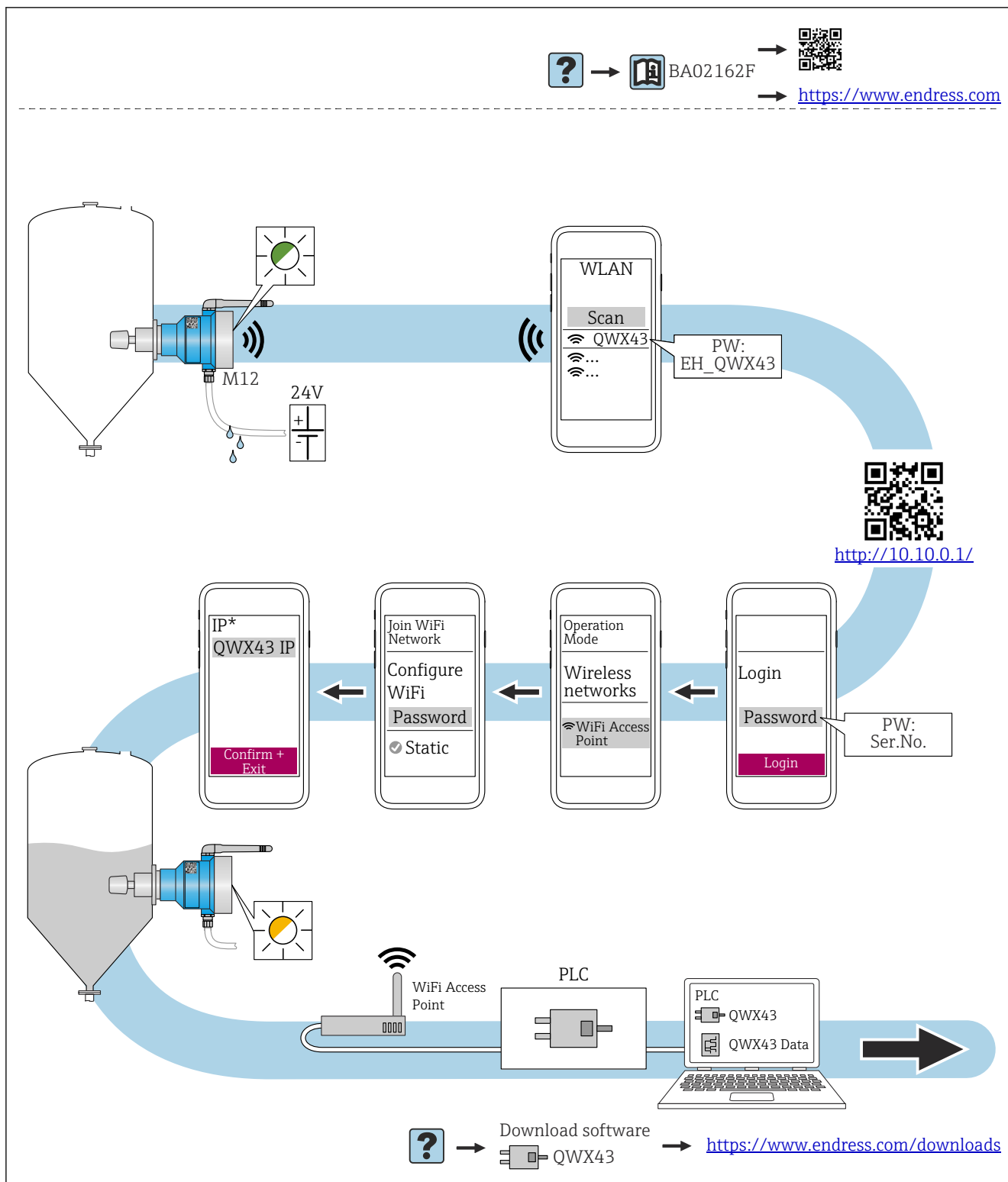
Netilion 接続

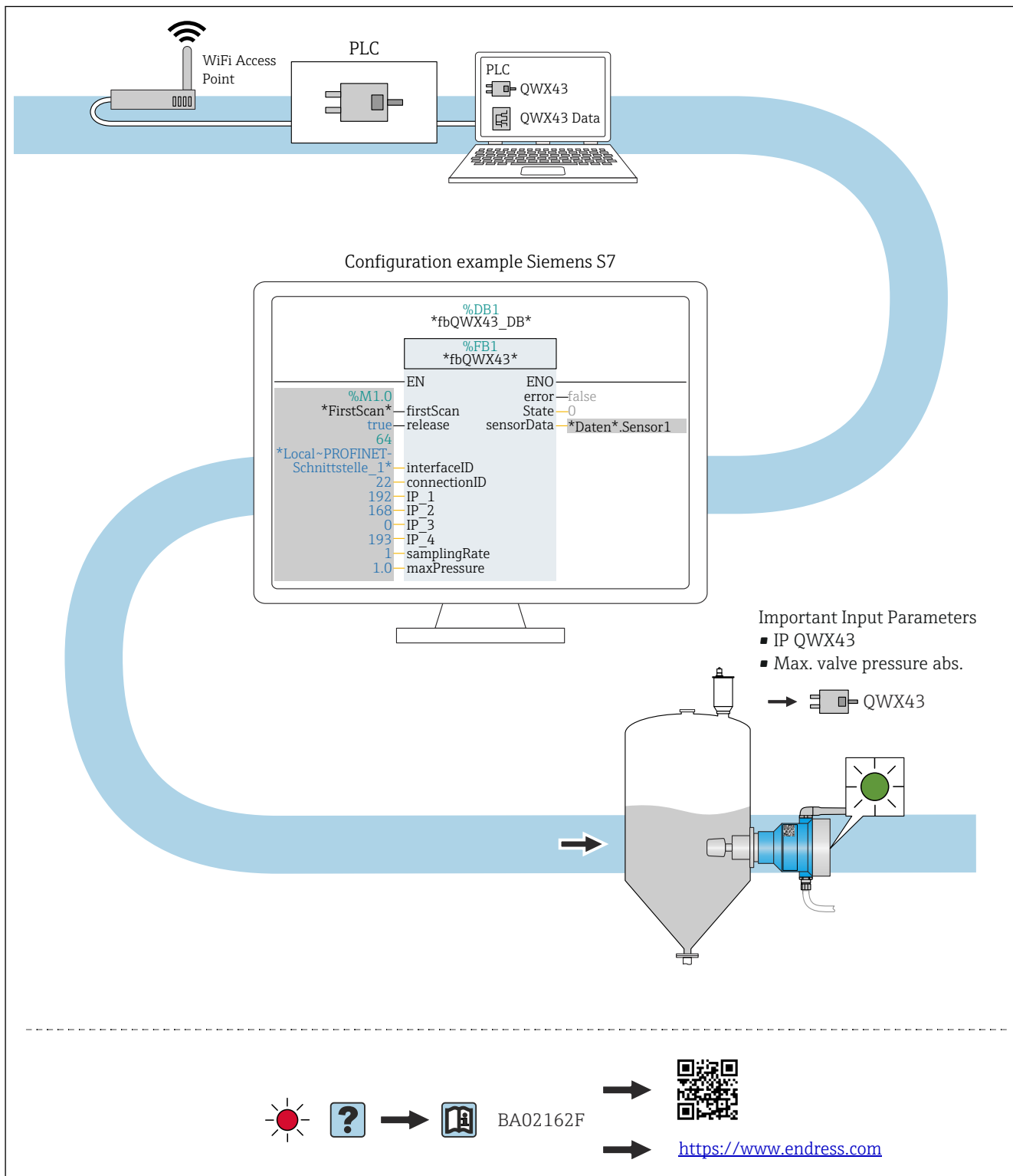
