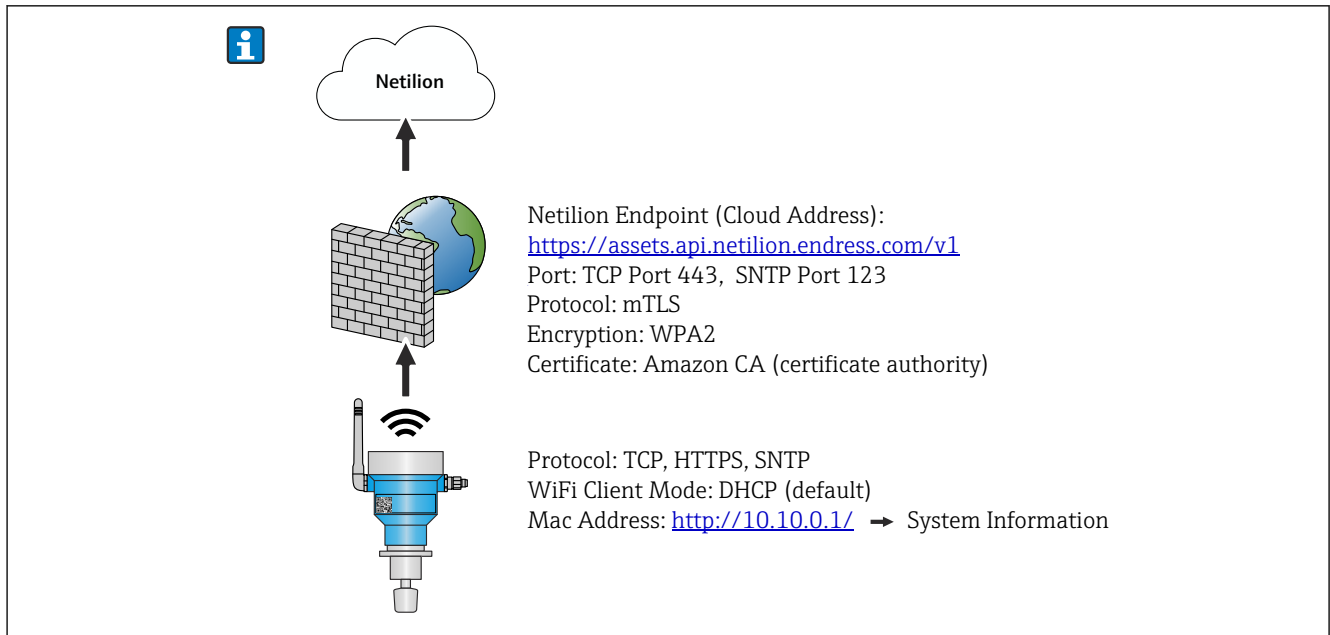

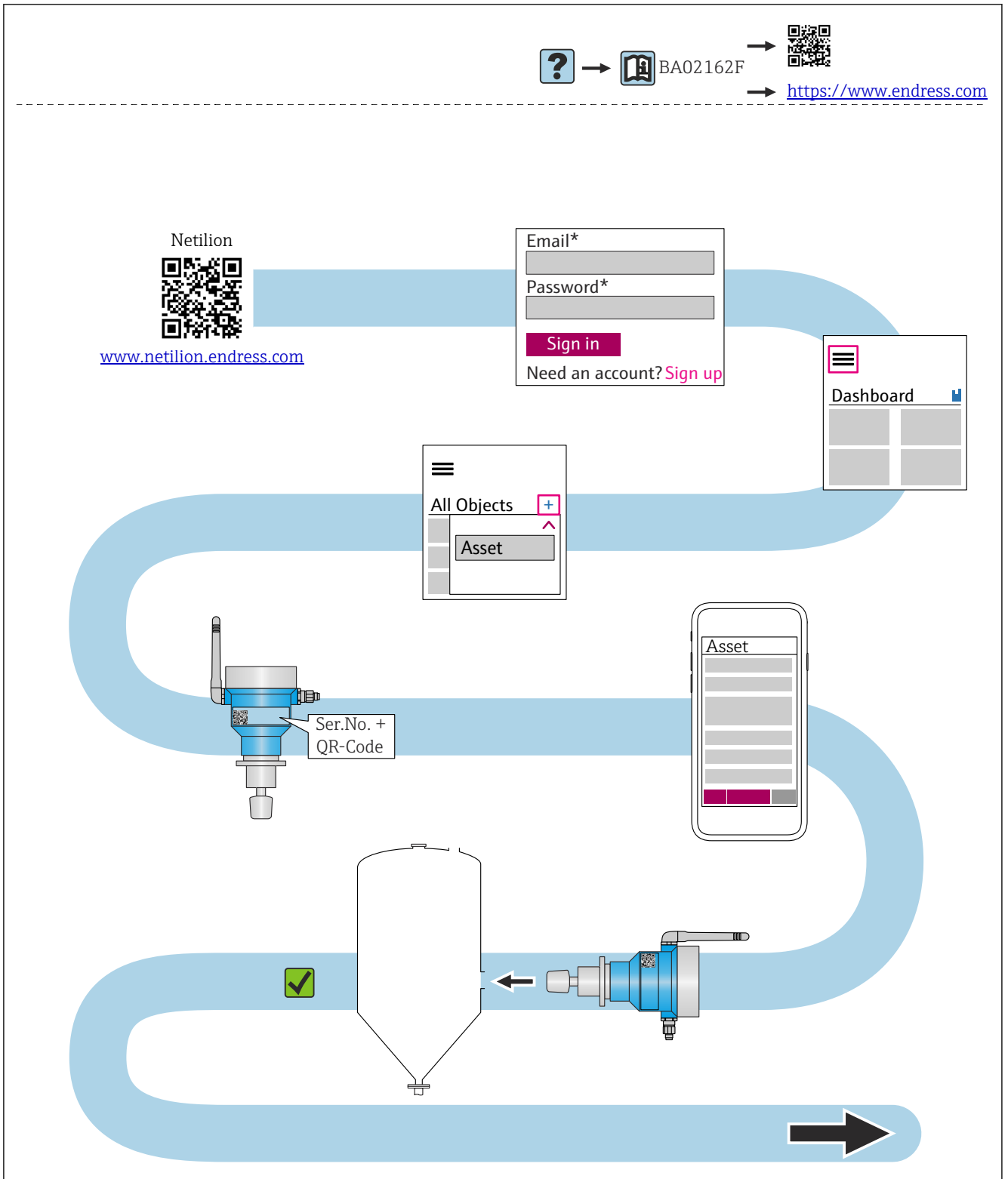

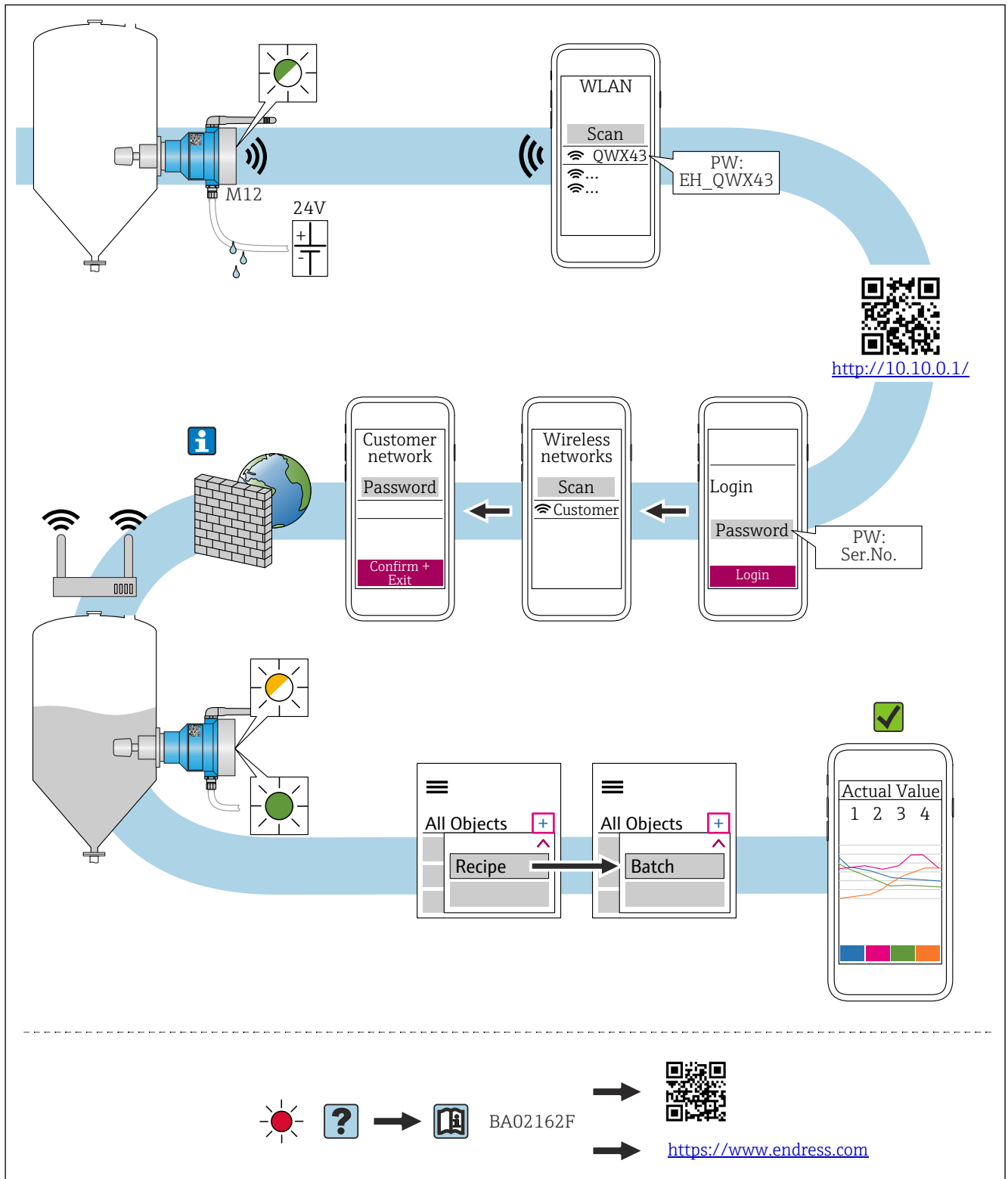
Configuração de rede



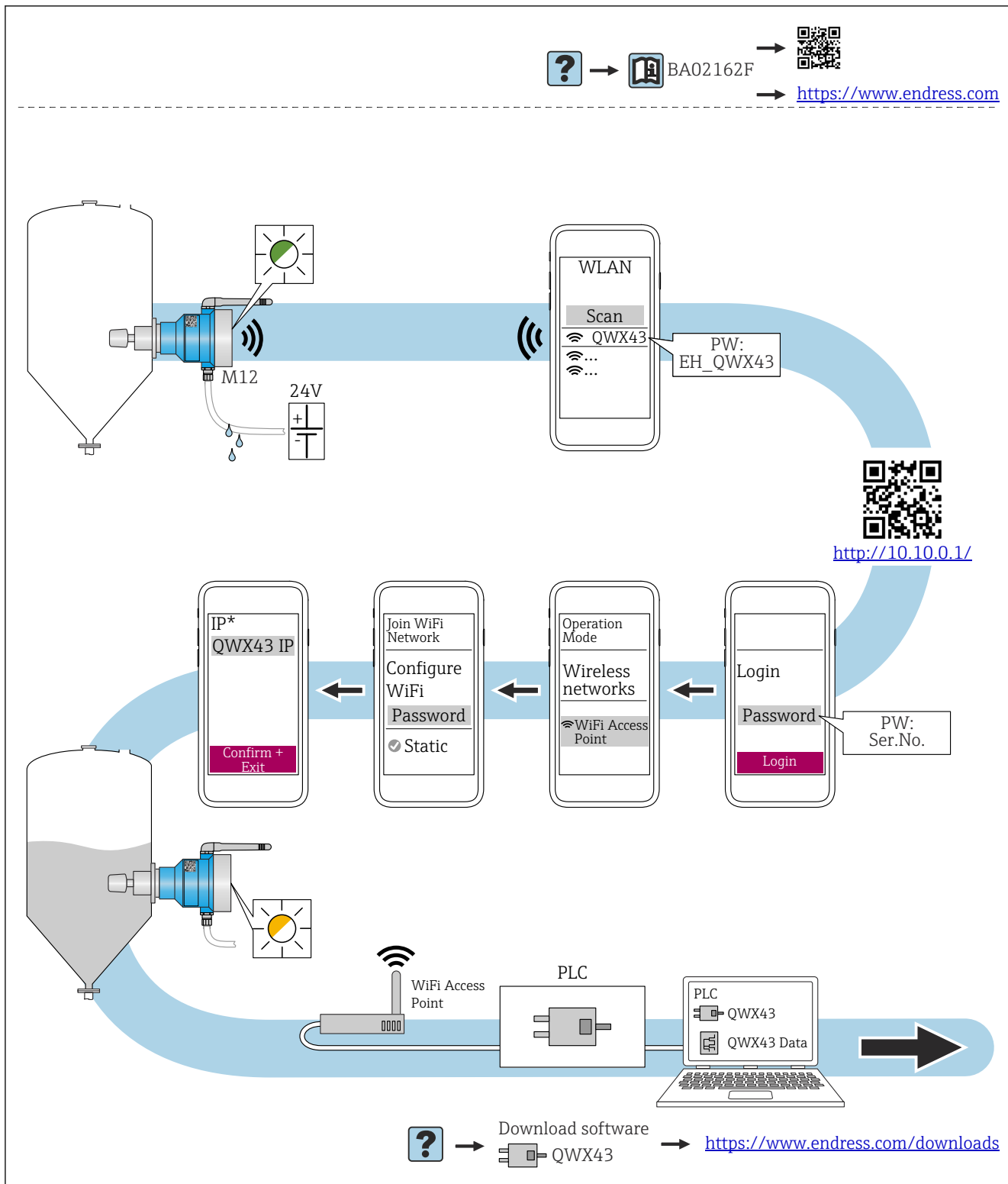
Conexão Netilion



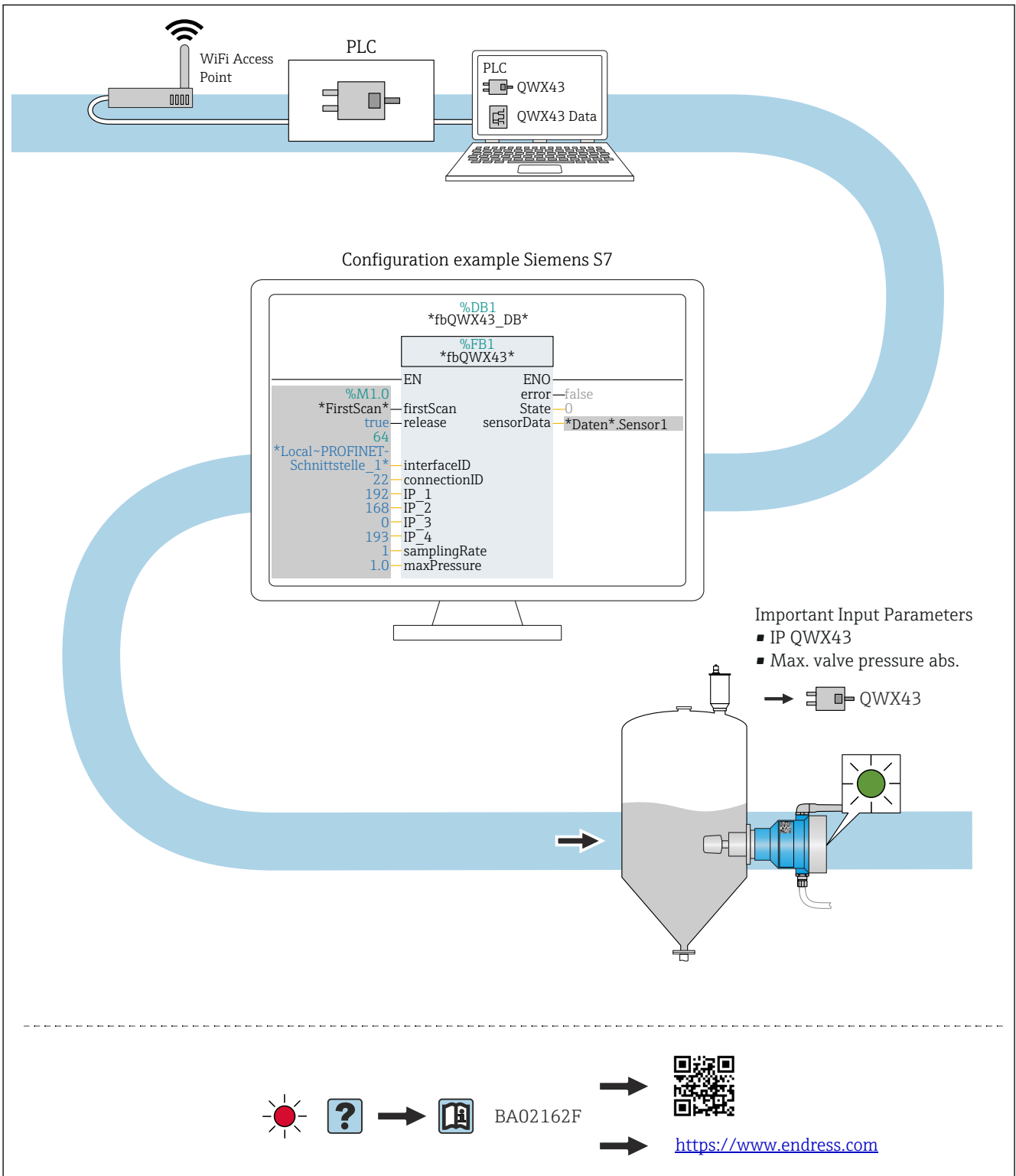

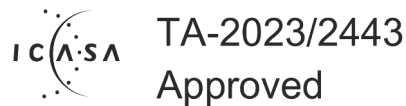
