
The retractable assembly CleanFit P CPA 477 has been designed specifically for pH measurement in the chemical industry, the paper industry (in backwater and low-density bleaching) and for effluent treatment stations or the foodstuffs industry. Without having to interrupt the process, the electrode can be

- separated from the process and moved to a rinse chamber pneumatically via a ball valve;
- rinsed with water or cleaning solution;
- kept moist during interruptions in operation;
- removed:
- sterilised; or
- calibrated.

The replaceable measuring insert in a pressure-resistant enclosure guarantees easy calibration and electrode replacement and prevents leakage in the event of electrode breakage.


The CleanFit P CPA 477 assembly is operated with an air pressure of 4 to 8 bar. The air must be filtered (40 µm) and free from water and oil. There is no continuous pressure demand. The air lines must have a minimum nominal diameter of 4 mm.




Note

If pressure increases to above 8 bar are possible (including short peak pressures), a pressure reducer must be installed.




Auxiliary energy connections for assembly with pneumatic ball drive



Overview over the connections to the CleanFit P assembly CPA 477 with force controlled drive








