 How can the previous software version number be identified? : The version number is to be read directly in application, headline of the portal window. For security reason it can be used the button ‚About‘ in the headline. Afterwards opens a window with the version information (version number and serial number)  
 Description of the modification in comparison with the predecessor version : SupplyCare Enterprise has now an OPC interface and can read the data and/or structures out of a standard OPC server. Beside the gateways SupplyCare Enterprise can also work with standard OPC servers such as ControlCare, PView, etc. in the application.

SupplyCare Enterprise supports the Web-communication OPC XML DA 1.0. A so-called OPC-Bridge is required for the retrieval of OPC DA 1.0, 2.0 or 3.0 connections via COM/DCOM. This bridge connects itself via COM/DCOM with the OPC-Server and provides an OPC-XML-Web-Service (SOAP-Technology). This OPC-Bridge is supplied together with the SupplyCare Enterprise-CD and separately licensed.
